CHARGING

Before using your Yinko BTE004, please charge it using the micro USB charging cable included in the package. The white LED breath when charging and keep lighting after finished.

Note: Most USB chargers are compatible with Yinko BTE004. For optimal AC charging, please use a 1.0A USB charger.

PAIRING

Power on-Press and hold the multifunctional button for 3-4 seconds. The white LED light will flash quickly. The earbuds will enter to paring mode. Enable your Bluetooth device such as cell phones, tablets or other Bluetooth media and make sure it is in searching mode. Select "BTE004" in the list shown on the Bluetooth device. The Bluetooth earbuds will reconnected automatically if your device has been paired.

Power ON/OFF

On: Long press multifunctional button for 2s
Off: Long press multifunctional button for 2s

PLAY / PAUSE

Press multifunctional button for play & pause

VOLUME UP

Press the + button for volume up.

VOLUME DOWN

Press the - button for volume up.

PREVIOUS TRACK

Press and hold the - button for previous track.

NEXT TRACK

Press and hold the + button for the next track.

ANSWER CALL

Press multifunctional button once while a call is incoming.

END CALL

Press multifunctional button again to end call.

REDIAL

Double press the multifunctional button to redial the last number.
