Tie each end of the strap to the headphone hanging wires behind the ears.</div> <div></div>	<div>Operations</div> <div>Power On/Off</div> <div>Power On: Press and hold the power button for 3 seconds until the LED flashes white and green. Prompt: power on pairing.</div> <div>Power Off: Press and hold the power button for 3 seconds until the LED flashes green three times. Prompt: power off .</div> <div>BT Connection</div> <div>Select "OPENEAR Air F3 " in BT menu to connect. Prompt: connected.</div> <div>Battery Level Notification</div> <div>Automatically announce the real-time battery level of the headphones after power on.</div> <div>Battery 100%-70%: Prompts: battery high.</div> <div>Battery 69%-40%: Prompts: battery medium.</div> <div>Battery 39%-10%: Prompts: battery low.</div>
<div>Switch Music/Communication Modes</div> <div>The headphones is built-in 2 sound modes. Double click the power button to switch. Prompt: music mode / communication mode.</div> <div>Mute On/Off</div> <div>Double click the MFB during a call to turn on/off mute function. Prompt: mute on / mute off.</div> <div>Answer/Hang Up/Reject A Call</div> <div>Answer/Hang Up A Call: Click the MFB once.</div> <div>Reject A Call: Double click the MFB.</div> <div>Play/Pause Music</div> <div>Click the MFB once.</div> <div>Previous/Next Track</div> <div>Previous Track: Press and hold the + button.</div> <div>Next Track: Press and hold the — button.</div> <div>Volume Up/Down</div> <div>Volume Up: Click the button + .</div> <div>Volume Down: Click the button — .</div> <div>When the volume reaches the maximum, Prompt: maximum volume.</div>	<div>Activate Voice Command</div> <div>Press and hold the MFB for 2 sec.</div> <div>Low Battery</div> <div>The green LED flashes three times every 3 minutes when the headset battery is lower than 20%. Prompt: low battery .</div> <div>Restore Factory Setting</div> <div>Press and hold "+" and "—" button at the same time under power-on status. Prompts: Restore to factory setting, power off.</div> <div>Charge</div> <div>Please use DC 5V adapter for charging. Green LED is on charging.
