## About the product

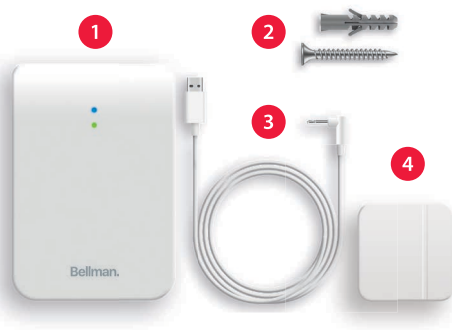
This Bridge Transceiver makes it possible to connect your Visit system to your mobile phone and the line of Bluetooth powered products from Bellman.

## What you'll need

A mobile phone with iOS 15 / Android 8 or later if you plan to connect it to your Visit system.

## Getting started

### 1. Prepare

Pull the battery tab to start the bridge.

The top indicator breathes in blue to show that it is ready for pairing.



### 2. Pair

- To pair the bridge with your mobile phone, follow the steps on p 5.
- To pair with a Bluetooth device from Bellman, follow the steps in the product's user manual. Then, hold down the bridge **top** test button to initiate pairing.



### 3. Position

To optimize coverage, select a central position in the house.

Connect the power adapter and mount it on the wall using the supplied screw and plug.



## Finishing up

### 4. Test the connection

To your Visit system

- 1 Press the **bottom** test button on the bridge. The bottom LED lights up in green to show that a signal is being transmitted.
- 2 The yellow Visit LED on your receiver lights up and it starts to sound, flash or vibrate depending on the type of receiver.

## Need help?

If the bridge fails to generate a notification on your receiver, you need to adjust the bridge's radio key to match your system's radio key. The radio switches are located under the front cover.

- 1 Remove the front lid on one of the transmitters to see your current radio key settings. They are marked with the symbol **RADIO** and a radio wave icon.
- 2 Remove the front lid on your bridge, set the radio key switches to the same position and put the lid back on. Test the connection by pressing the bottom test button on the bridge.

## Unpairing your bridge

If you want to use the bridge in another system, you need to unpair it from your current system.

- 1 Hold down both buttons for at least 6s. The top LED will start to blink rapidly in purple.
- 2 Release the buttons and hold down the top button for 3s to confirm. The top and bottom LED lights up.
- 3 Remove the power adapter and batteries to restart.

## Installing the app

### 1. Turn on Bluetooth®

Swipe down from the top of the screen and tap the Bluetooth icon to turn it on.



### 2. Install the app

Download the **Bellman Assistant** app from the App Store® or Google Play™ and follow the setup instructions.

## Safety and Handling

- Keep this device out of reach of children under 3 years.
- Note that notifications can be missed if batteries run out.
- This product uses Alkaline batteries as power backup. Do not expose the batteries to fire or to direct sunlight. Only use 1.5 V AA alkaline batteries.
- This device is designed for indoor use only. Do not expose the device to moisture.
- Protect the device from shocks during storage and transport.
- This equipment generates, uses and can radiate radio frequency energy and, if not installed and used in accordance with the user guide, may cause harmful interference to radio communication.
- Do not use or store this device near any heat sources such as flames, radiators, ovens or other devices that produce heat.
- Do not dismantle the device; there is a risk of electric shock. Tampering with or dismantling the device will void warranty.
