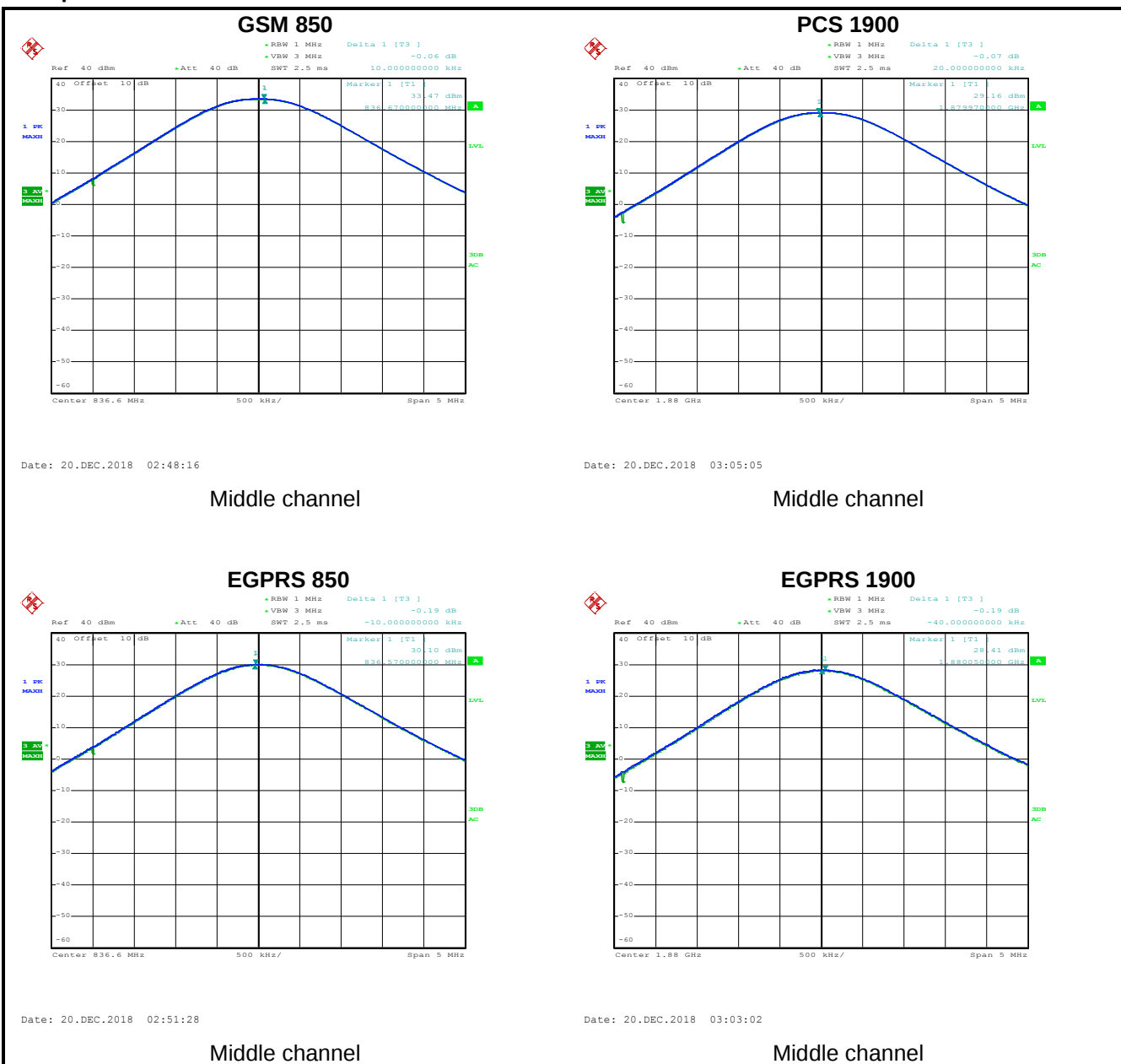

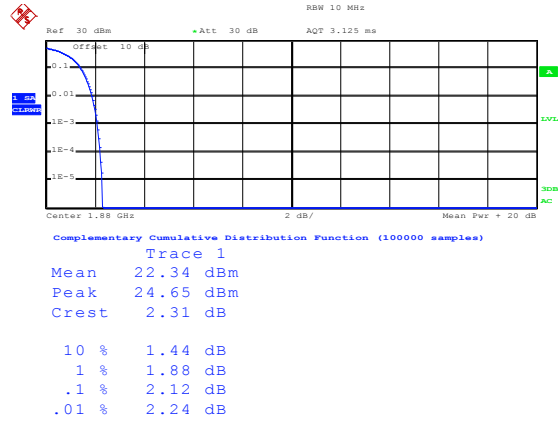

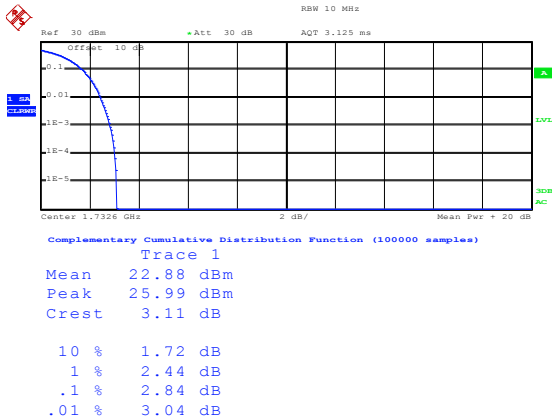
UMTS 1900 RMC

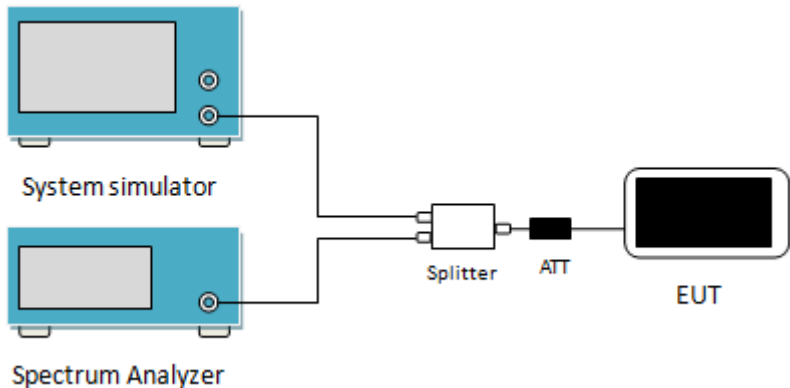

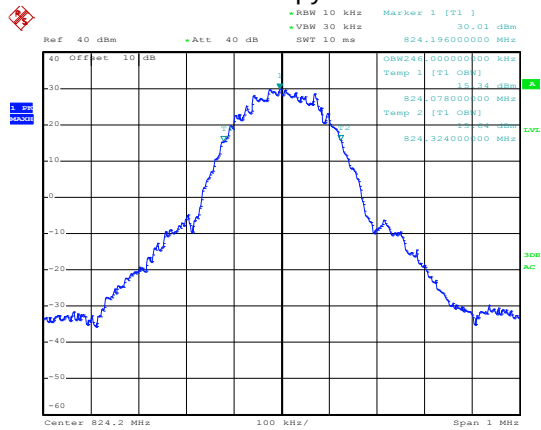

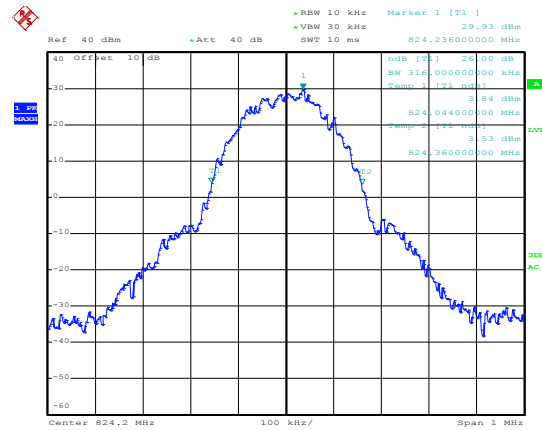

99% Occupancy bandwidth



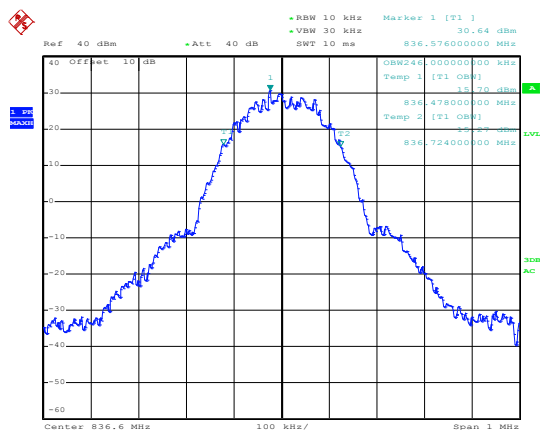
