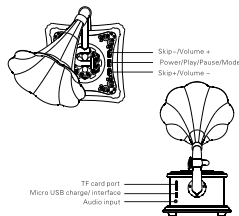

### Function and operation instructions



- ① Skip-/Volume +  
After starting the machine, short press to switch to Prev song, long press to increase volume, prompt "didi" sound, indicating that the volume has been set to the maximum.
- ② Power/Play/Pause/Mode  
Long press 2 seconds to start up, long press 2 seconds to shut down; After starting up, double-click to switch the playing mode. Switching order: BT - TF card - Aux mode, for this loop, single click to play/pause.
- ③ Skip+/Volume -  
After starting the machine, short press to switch to the next song, long press to reduce the volume, when the volume is lowest it will turn to silent state.
- ④ TF card port  
When the TF card is inserted, the system will play the music of TF card repeatedly, and when the TF card is removed, it will automatically default to Bluetooth mode.
- ⑤ Micro USB charge interface  
When under low power or without power, the best charging time is 3 hours.
- ⑥ Audio input  
3.5mm audio input port  
Indicator light:  
In the charging state, the red light will be on, and the red light will be off after fully charged. In the playing mode, the blue indicator light will be on all time, and the blue indicator light will be flashing in the Bluetooth state.



### Product operation guide



**Bluetooth connection**  
Take your phone and open Bluetooth mode, so the available Bluetooth device will be in the list in mobile, then find device number MJ-101 and click it, the device will be connected successfully when you hear the voice prompt "Bluetooth started".



**Audio connection**  
After the audio cable connects to the mobile playback device, the device will automatically enter the "AUX mode" and start playing music in the mobile device. When the audio cable is pulled out, the device will automatically switch back to Bluetooth mode.

3.5mm audio cable, which can be connected to mobile phone, computer, TV and other devices with AUX interface.



**TF card read**  
When the device is started up, insert the TF card, the device is transferred to the TF card mode. When hearing the voice prompt of "TF card", the corresponding playing format file in the card is played. In TF card mode, the system will play the music of the TF card repeatedly. After removing the TF card, the device will automatically switch back to Bluetooth mode.
