

使用说明:

1. 使用配备的数据线链接上适配器或者是电脑，无线充电器就可以开始工作了。
2. 只需将智能手机直接放在无线充电器上即可，无需使用手机自带的充电数据线。
3. 在使用无线充电器之前，请确认您的智能手机拥有无线充电功能。
4. 手机在无线充电器充电期间，可以随时拿走或者放下你的手机，非常便捷。

注意事项:

1. 无线充电器对所有家庭电器都不会产生干扰。

3. 正常使用的情况下不需要做任何维护。充电结束的时候无线充电器是自动断电，处于休眠状态。保持无线充电器表层远离灰尘和金属。
4. 如果无线充电器无法正常工作，或者其他干扰，或者其他不正常的情况发生，请将适配器移除或者将无线充上面的设备拿走。重新将数据线或者适配器插入无线充电器。



Wireless Charger
User Manual

Operation Instruction:

1. Using a cable to connect an adapter or computer, you can start to charge
2. Just put your smartphone on the device directly without cable
3. Confirm your smartphone is built-in or insert a wireless receiver before charging
4. You can take your phone away for calling or place it back for charging freely

Attention:

1. The wireless charger has no interference on all household appliances
2. Do not place any magnetic card like bank card or ID card near the product to prevent magnet failing to work
3. As usual, it does not need any maintenance. The power is in sleep mode automatically if the charge stops. Keep the surface clean from dust or metal.
4. If the wireless charger cannot work normally, or other interference, please move the interference device away. Replace the USB cable or adapter for use again.

Notes: This manual is also suitable for using at other wireless charger which is made by D8



Warranty:

1. One year warranty from the date of purchasing. We provide the free maintenance service during warranty. The premise is that the product is normally used.
