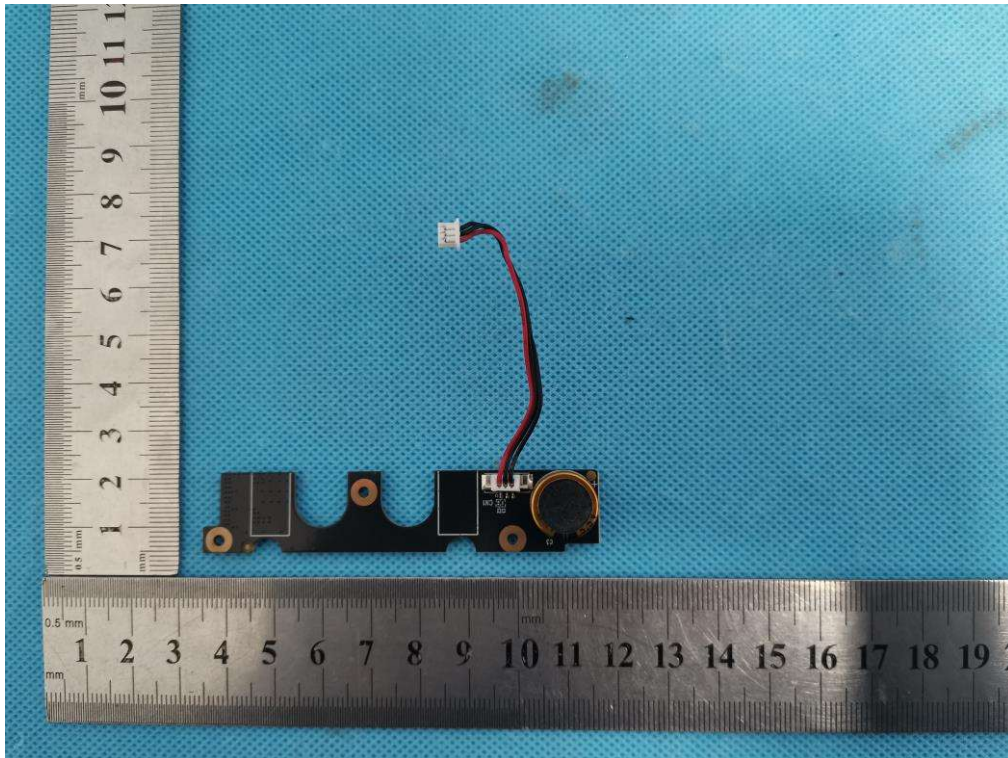

INTERNAL VIEW OF EUT (FIGURE 10)



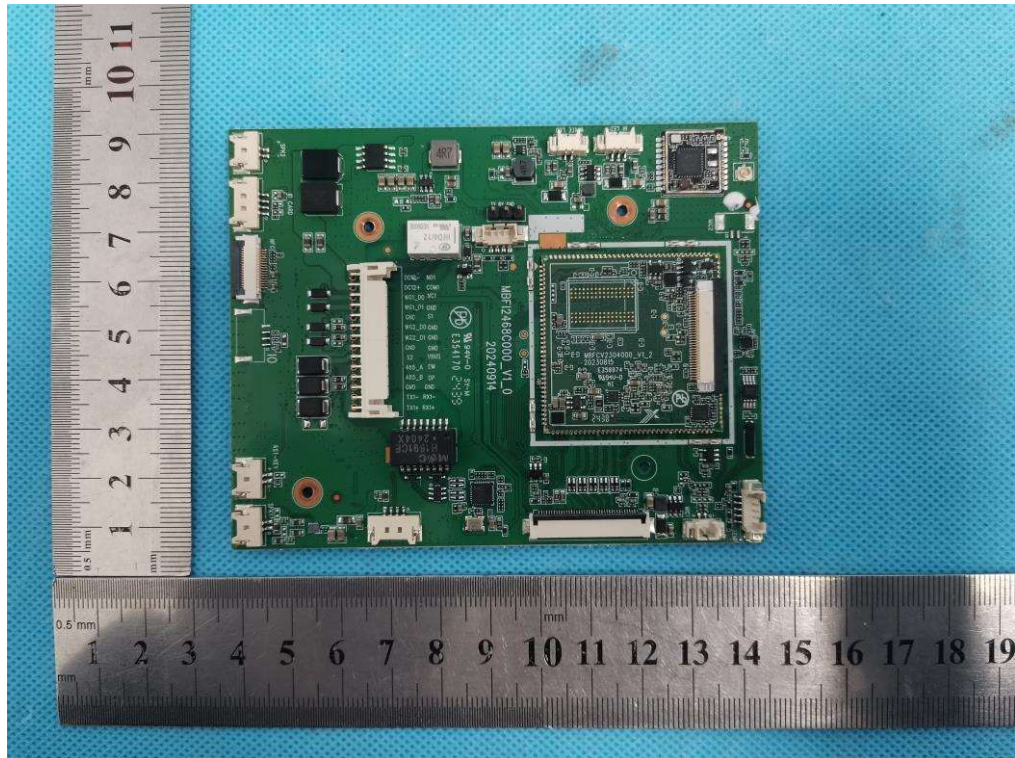
