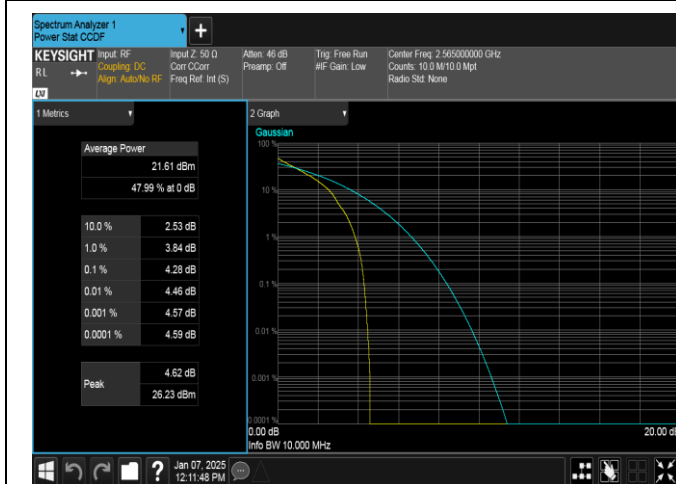
Band7-10MHz-QPSK-20800-50RB#0-PASS



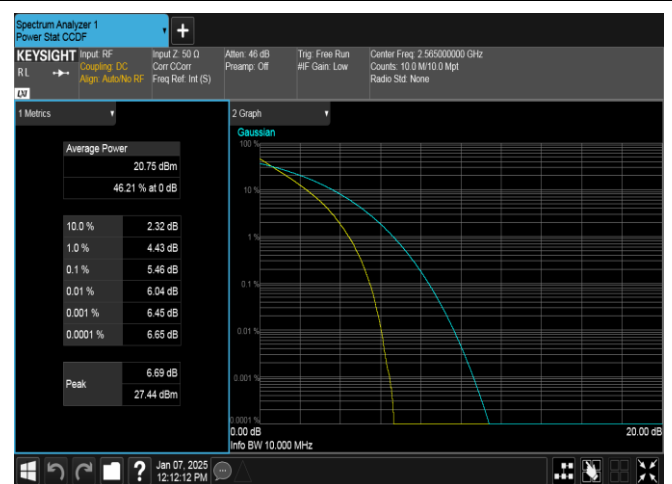
