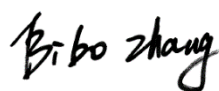

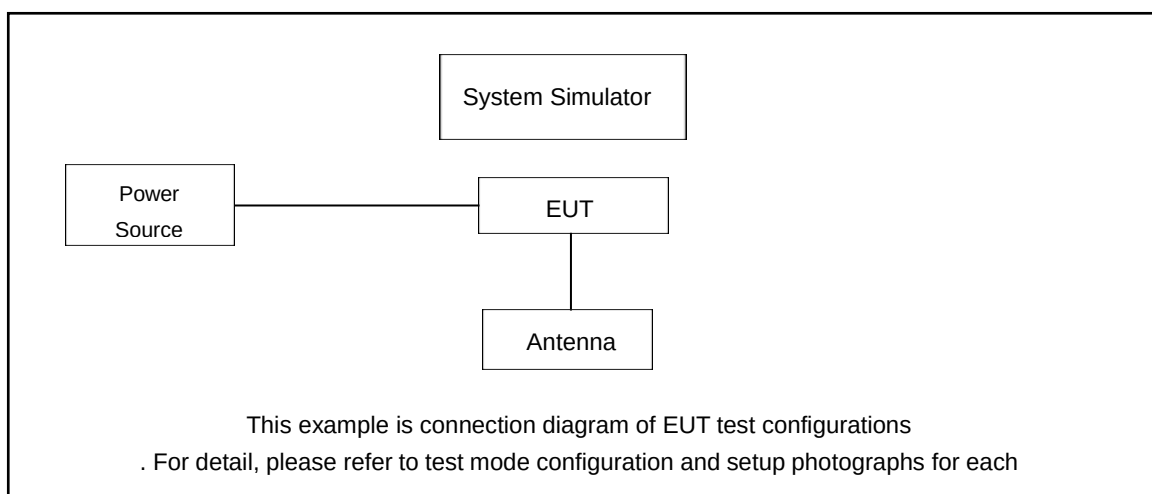

The device supports MPR to solve linearity issues (ACLR or SEM) due to the higher peak-to average ratios (PAR) of the HSUPA signal. This prevents saturating the full range of the TX DAC inside of device and provides a reduced power output to the RF transceiver chip according to the Cubic Metric (a function of the combinations of DPDCH, DPCCH, HS-DPCCH, E-DPDCH and E-DPCCH).

When E-DPDCH channels are present the beta gains on those channels are reduced firsts to try to get the power under the allowed limit. If the beta gains are lowered as far as possible, then a hard limiting is applied at the maximum allowed level.

The SW currently recalculates the cubic metric every time the beta gains on the E-DPDCH are reduced. The cubic metric will likely get lower each time this is done .However, there is no reported reduction of maximum output power in the HSUPA mode since the device also provides a compensate for the power back-off by increasing the gain of TX_AGC in the transceiver (PA) device.

The end effect is that the DUT output power is identical to the case where there is no MPR in the device.

In many cases, the RF output power limits for licensed digital transmission devices is specified in terms of effective radiated power (ERP) or equivalent isotropic radiated power (EIRP). Typically, ERP is specified when the operating frequency is less than or equal to 1 GHz and EIRP is specified when the operating frequency is greater than 1 GHz. Both are determined by adding the transmit antenna gain to the conducted RF output power with the primary difference between the two being that when determining the ERP, the transmit antenna gain is referenced to a dipole antenna (i.e., dBd) whereas when determining the EIRP, the transmit antenna gain is referenced to an isotropic antenna (dBi). The relevant equation for determining the ERP or EIRP from the conducted RF output power measured using the guidance provided above is:

$$ERP/EIRP = P_{Meas} + G_T - L_C$$

where: ERP/EIRP = effective or equivalent radiated power, respectively (expressed in the same units as P_{Meas} , typically dBW or dBm);

- P_{Meas} = measured transmitter output power or PSD, in dBm or dBW;

- L_C = signal attenuation in the connecting cable between the transmitter and antenna, in dB.

If the Fundamental frequency is below 1GHz, RF output power has been converted to EIRP.

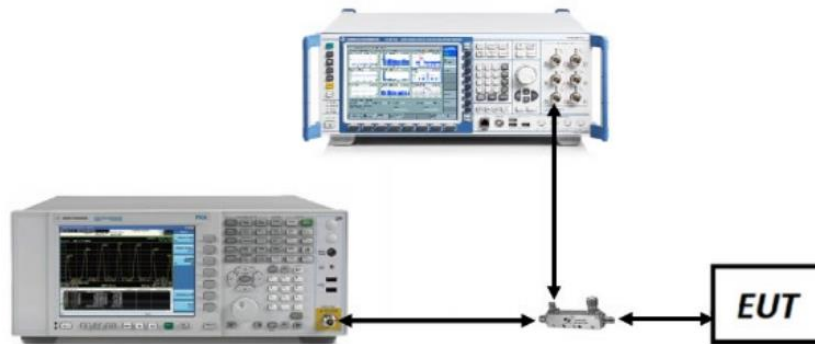

8. Peak-to-Average Ratio

8.1 Provisions Applicable

This is the test for the Peak-to-Average Ratio from the EUT.

Power Complementary Cumulative Distribution Function (CCDF) curves provide a means for characterizing the power peaks of a digitally modulated signal on a statistical basis. A CCDF curve depicts the probability of the peak signal amplitude exceeding the average power level. Most contemporary measurement instrumentation include the capability to produce CCDF curves for an input signal provided that the instrument's resolution bandwidth can be set wide enough to accommodate the entire input signal bandwidth. In measuring transmissions in this band using an average power technique, the peak-to-average ratio (PAR) of the transmission may not exceed 13 dB

8.2 Measurement Procedure

CCDF Procedure for PAPR:

1. Set resolution/measurement bandwidth $\geq$ signal's occupied bandwidth;
2. Set the number of counts to a value that stabilizes the measured CCDF curve;
3. Set the measurement interval as follows:

12. Radiated Spurious Emission

12.1. Provisions Applicable

(A) On any frequency outside a licensee's frequency block (e.g. A, D, B, etc.) within the USPCS spectrum, the power of any emission shall be attenuated below the transmitter power (P, in Watts) by at least $43+10\log(P)$ dB. The specification that emissions shall be attenuated below the transmitter power (P) by at least $43 + 10 \log (P)$ dB, translates in the relevant power range (1 to 0.001 W) to -13 dBm.

At 1 W the specified minimum attenuation becomes 43 dB and relative to a 30 dBm (1 W) carrier becomes a limit of -13 dBm. At 0.001 W (0 dBm) the minimum attenuation is 13 dB, which again yields a limit of -13 dBm. In this way a translation of the specification from relative to absolute terms is carried out.

(B) For specific criteria, please refer to the description in section 9.2 of the report for corresponding evaluation.

12.2. Measurement Procedure

1. The EUT was placed on the top of the turntable 0.8 or 1.5 meter above ground. The phase center of the receiving antenna mounted on the top of a height-variable antenna tower was placed 3 meters far away from the turntable.
2. Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
3. The height of the broadband receiving antenna was varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
4. For each suspected emissions, the antenna tower was scan (from 1 M to 4 M) and then the turntable was rotated (from 0 degree to 360 degrees) to find the maximum reading.
5. Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
6. For emissions above 1GHz, use 1MHz VBW and RBW for peak reading. Then 1MHz RBW and 10Hz VBW for average reading in spectrum analyzer. Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.
7. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds. As an alternative (provided the transmitter operates for longer than 0.1 seconds) or in cases where the

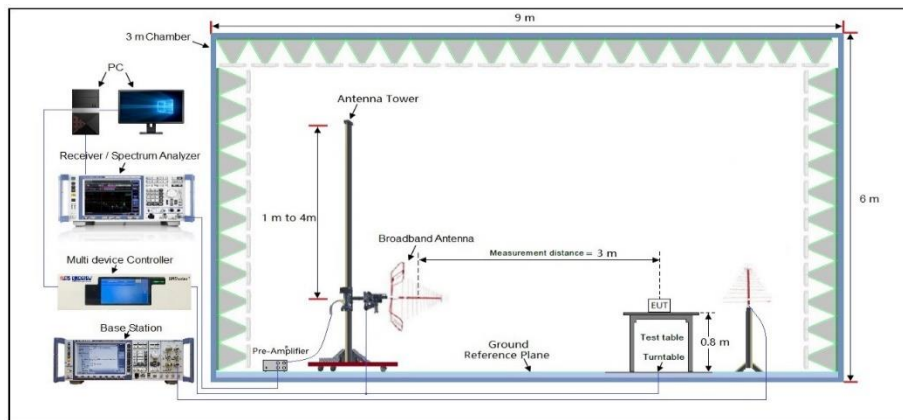

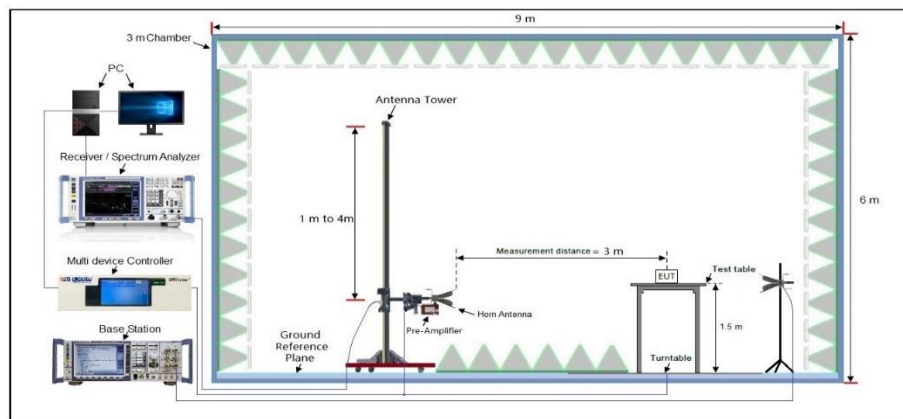

13. Frequency Stability / Variation of Ambient Temperature

13.1 Provisions Applicable

13.1.1 For Hand carried battery powered equipment

Frequency stability testing is performed in accordance with the guidelines of ANSI/TIA-603-E-2016. The frequency stability of the transmitter is measured by:

- a) Temperature: The temperature is varied from -30°C to +50°C in 10°C increments using an environmental chamber.
- b) Primary Supply Voltage: The primary supply voltage is varied from 85% to 115% of the nominal value for non hand-carried battery and AC powered equipment. For hand-carried, battery-powered equipment, primary supply voltage is reduced to the battery operating end point which shall be specified by the manufacturer.

For Part 22, the frequency stability of the transmitter shall be maintained within $\pm 0.00025\%$ (± 2.5 ppm) of the center frequency. For Part 24 and Part 27, the frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block.

13.1.2 For equipment powered by primary supply voltage

1. The carrier frequency of the transmitter is measured at room temperature (20°C to provide a
2. reference).
3. The equipment is turned on in a "standby" condition for fifteen minutes before applying power to
4. the transmitter. Measurement of the carrier frequency of the transmitter is made within one minute after applying power to the transmitter.
5. Frequency measurements are made at 10°C intervals ranging from -30°C to +50°C. A period of at
6. least one half-hour is provided to allow stabilization of the equipment at each temperature level.

13.2 Measurement Procedure

In order to measure the carrier frequency under the condition of AFC lock, it is necessary to make measurements with the EUT in a "call mode". This is accomplished with the use of R&S CMW500 DIGITAL RADIO COMMUNICATION TESTER.

1. Measure the carrier frequency at room temperature.
2. Subject the EUT to overnight soak at -30°C. 3. Repeat the above measurements at 10°C increments from -30°C to +50°C. Allow at least 1 1/2 hours at each temperature, unpowered, before making measurements.
4. Re-measure carrier frequency at room temperature with nominal voltage. Vary supply voltage from minimum voltage to maximum voltage, in 0.1Volt increments re-measuring carrier frequency at each

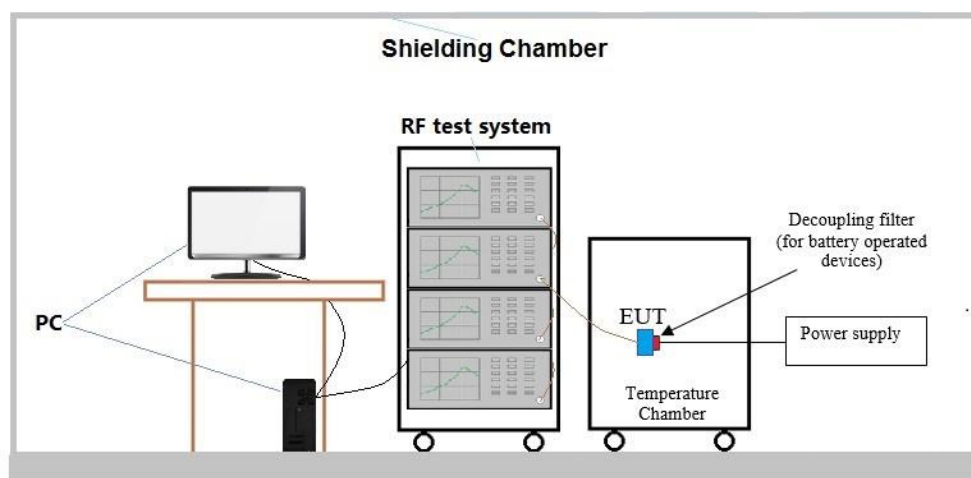

7. Repeat the above measurements at 10°C increments from +50°C to -30°C. Allow at least 1 1/2 hours at each temperature, unpowered, before making measurements.
8. At all temperature levels hold the temperature to +/- 0.5°C during the measurement procedure.
