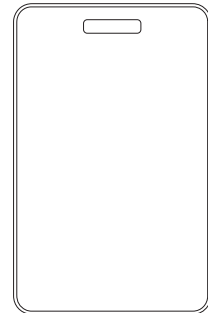

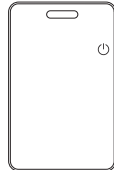

Key functions

2

1. By using the **Apple Find My app**, you can find your Rupt Trakard from your iPhone, iPad, iPod touch, or Mac. Simply open the **Apple Find My app**, click on the corresponding item, and you will see the location of the Tag item finder. Use the map guide to find it.

2. Even if it is left in a place far away from you, you can also enable the lost mode to lock the location of the item and use the map guide to find it since Apple device are widely used.

3. In addition, if your item finder leaves the range of your Apple device, you will receive an alarm notification. This can help you timely discover the lost items and avoid further losses.

Note:

1. Only for **Apple device** (such as iPhone).
2. Need turn on the iPhone **Bluetooth** function and **internet**.
3. need log into iCloud account, in "**Settings**" - "**Apple ID**" - enable "**Share My Location**" in the Apple Find My app.
4. The Find Items app on Apple Watch requires the latest version of **watchOS**.

Functions Description

3

1. Turn On:

Press once the button of Trakard, the device will beep "Di"
The red light will flash, then it will be turned on.

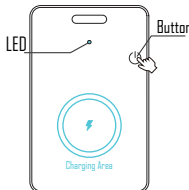
2. Turn Off:

Long press the button to hear di-- di di-- di di di after three prompts, release it (the red light flashes once for each prompt)

3. Factory Reset:

First, remove the item from Find My app then, after the Trakard is powered on, click button on Trakard 4 times.

On the 4th button click, hold until hear a long "Di"



Charging

Rupt Trakard supports wireless charging.
The light will turn green when it is charging.
The light will turn Blue when it is fully charged.

First time set up

1. Make sure phone Bluetooth and Share Your Location is turned on (cannot use bluetooth menu to connect).
2. Open the Find My app and Navigate to the "Items" section and click "Add Item" or the "+"
3. Select "Other Supported Item" or "Add Other Item"
4. TURN ON the Rupt Trakard: Press once the button (until the device chimes)
5. Rupt Trakard will appear. Click "Connect" and follow onscreen instructions.

Connect other device

The Rupt Trakard can only be connected to one device.
If you want to connect the item finder to other Apple devices, please remember to do the "**Remove Item**" operation on the Apple Find My app and reset the item finder.

Features

1. Find your Trakard from your iPhone, iPad, Mac or Apple Watch using the Find My app. Open the app, click on the item, and use the map to help guide you to your item.
2. You can set your Trakard to "Lost Mode" to make the device discoverable by others to help you recover your item.
3. Your Apple Device will receive a notification if your Trakard leaves its range.

Privacy Data Protection

1. Personal location information protection: The Apple Find My network uses advanced encryption to ensure that no one else, not even Apple or Shenzhen Winnershine Electronics Co., Ltd., can view the location of your Rupt Trakard.

2. Prevent Anonymous Tracking: How to prevent the device from being maliciously tracked? When someone else's item finder is mixed into your belongings and tracked for a period, you will be prompted in the following two ways. If you have iPhone, iPad and other Apple device, you will get reminders on Apple device, this function is supported on iOS 14.5 or iPadOS 14.5 and later versions of Apple devices. If you do not have Apple devices, when someone else's item finder is mixed into your belongings and tracked over a period, when it moves, it will emit a beep to remind you. If it happens that your friend is wearing a item finder, or there are many people on this device in the public transportation you take, don't worry, because if the item finder does not leave its owner's side, it will not trigger such a warning reminder.
