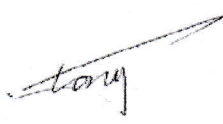

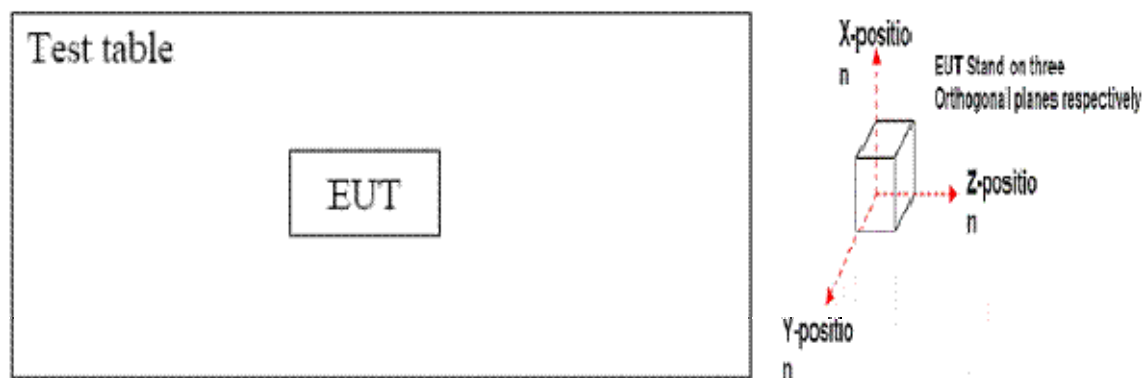
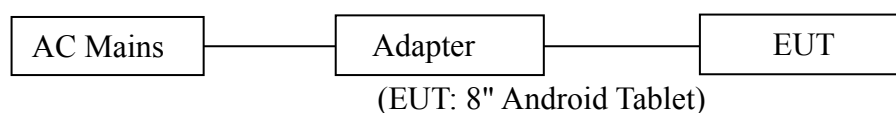

2.5. Block Diagram

For radiated emissions test: EUT was placed on a turn table, which is 0.8 (or 1.5) meter high above ground. EUT was be set into TX test mode by software before test.



Note: We test X-axis, Y-axis, and Z-axis,. The Y-axis is the worst mode, so only the worst mode test data was included in the report.

3.1. Test mode

A special test software was used to control EUT work in Continuous TX mode(100% duty cycle), and select test channel, wireless mode and data rate.

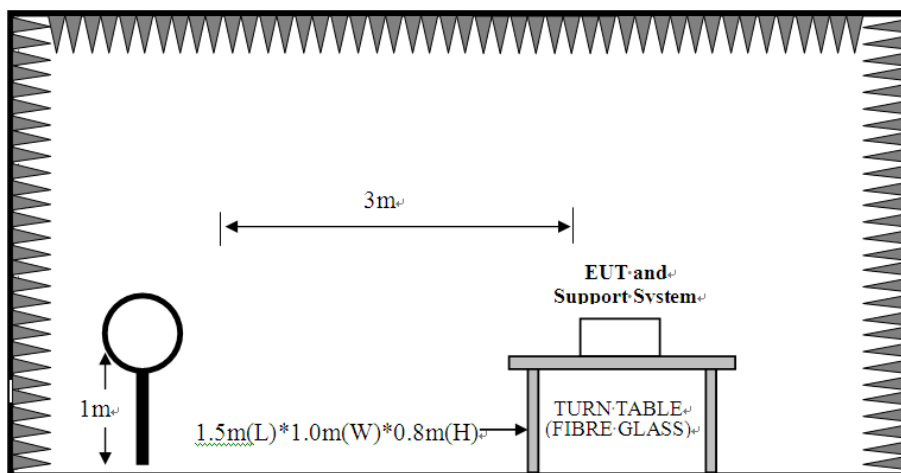

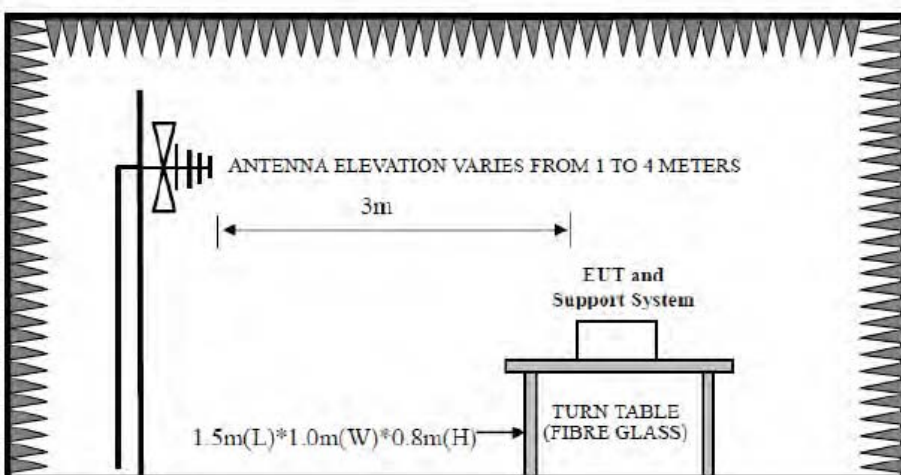

4.2. Block Diagram of Test setup

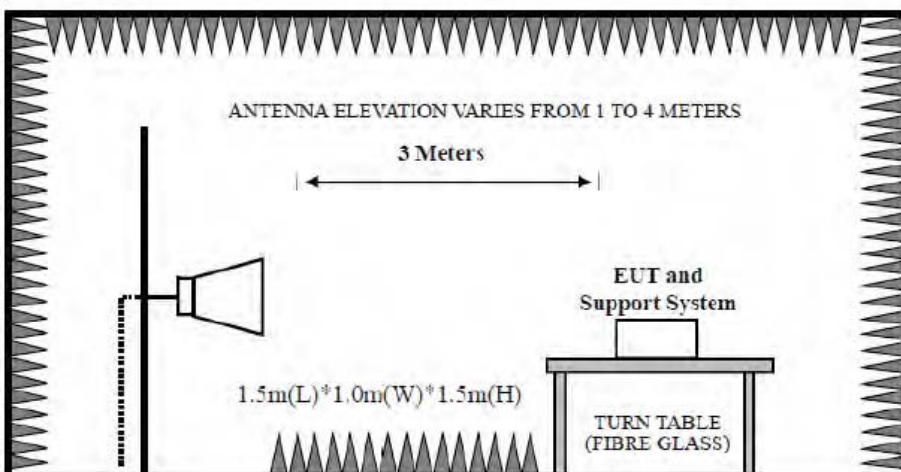
9kHz~30MHz

4.3. Test Procedure

EUT was placed on a turn table, which is 0.8 meter high above ground for 9kHz~1000MHz test, and which is 1.5 meter high above ground for above 1GHz test. The turn table can rotate 360 degrees to determine the position of the maximum emission level. Power on the EUT and let it working in test mode, then test it. EUT is set 3 meters away from the receiving antenna, which is mounted on a antenna tower. The antenna can be moved up and down between 1 meter and 4 meters to find out the maximum emission level. Both horizontal and vertical polarization of the antenna are set on test.

The test frequency analyzer system was set to Peak Detect (300Hz RBW in 9kHz to 150kHz and 10kHz RBW in 150kHz to 30MHz) Function and Specified Bandwidth with Maximum Hold Mode.

The bandwidth of the EMI test receiver (R&S ESVS10) is set at 120kHz for frequency range from 30MHz to 1000 MHz.

The bandwidth of the Spectrum's VBW is set at 1MHz and RBW is set at 1MHz for peak emissions measurement above 1GHz and 1MHz RBW, 10Hz VBW for average emissions measure above 1GHz PEAK detector, 1MHz/1MHz for PAEK measurement, PEAK detector, 1MHz/10Hz for Average measurement

The frequency range from 30MHz to 10th harmonic (25GHz) are checked.

4.4. Test Result

PASS.

All the emissions from 30MHz to 25 GHz were comply with 15.209 limits.

Note: 1、For emissions above 1GHz, if peak level comply with average limit, then the average level is deemed to comply with average limit.

2、The frequency 2402MHz 、2440MHz and 2480 MHz is fundamental frequency which no limit, the limit on plots is automatically generated by the software, it's not fundamental limit, we can't remove it.

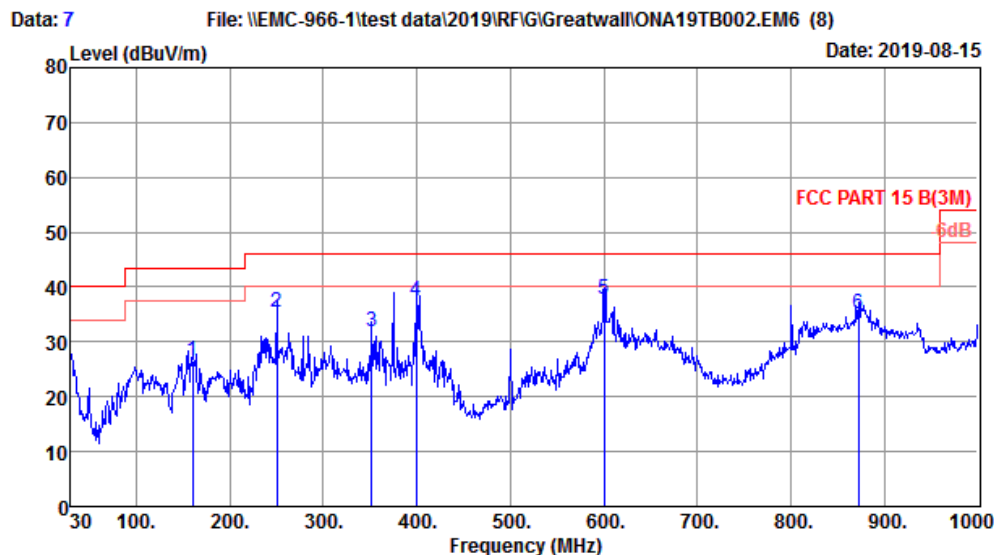

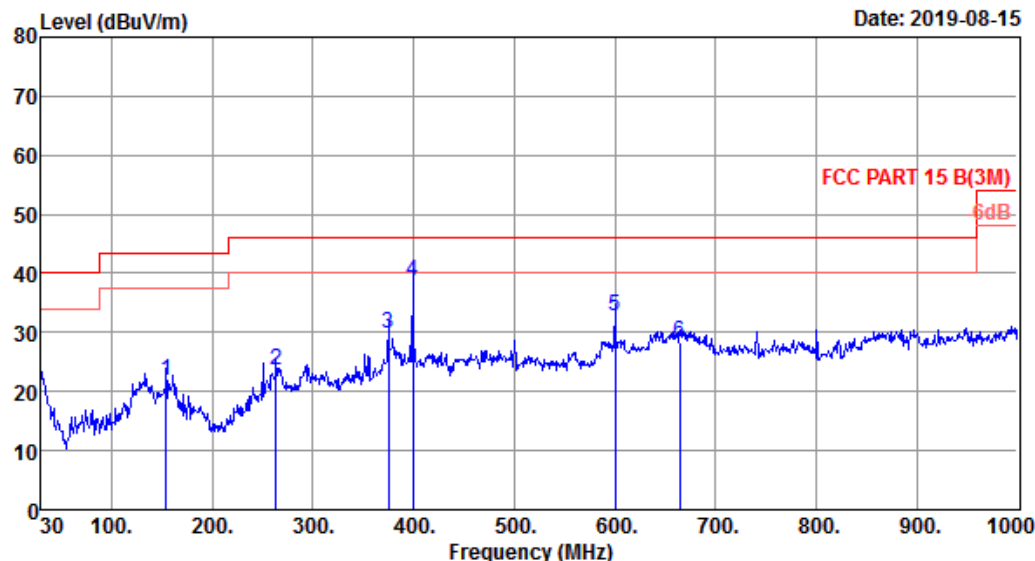

5 ANTENNA REQUIREMENTS

5.1 Limit

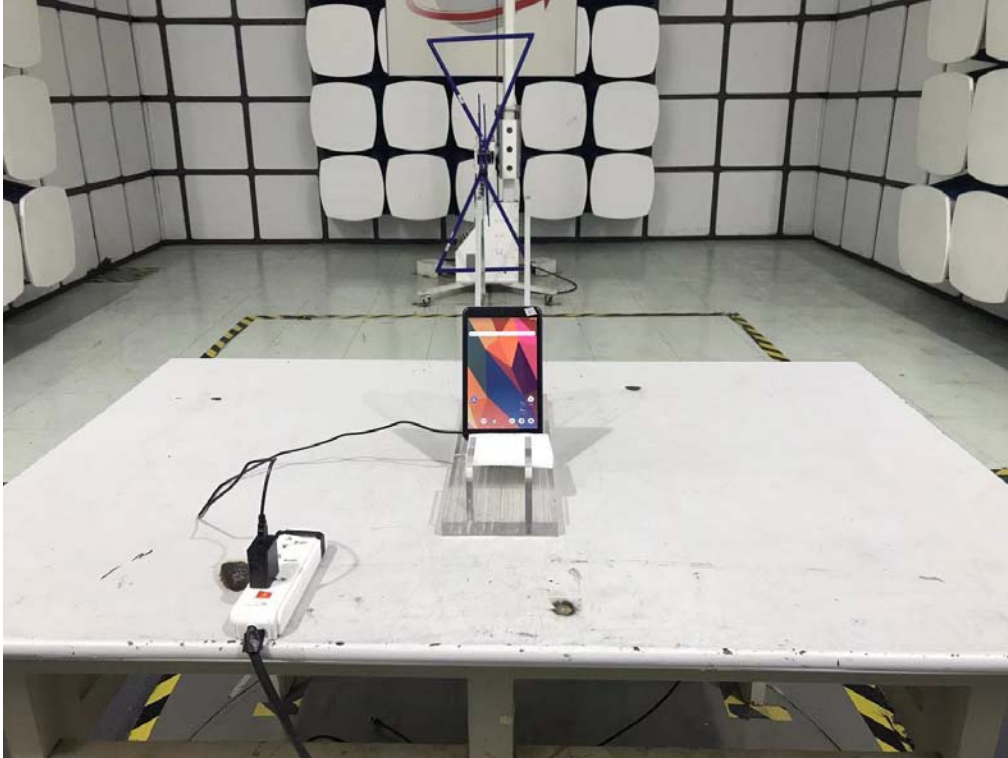
For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

5.2 Result

The antennas used for this product are Internal antenna and that no antenna other than that furnished by the responsible party shall be used with the device, the maximum peak gain of the transmit antenna is only 1.27 dBi.

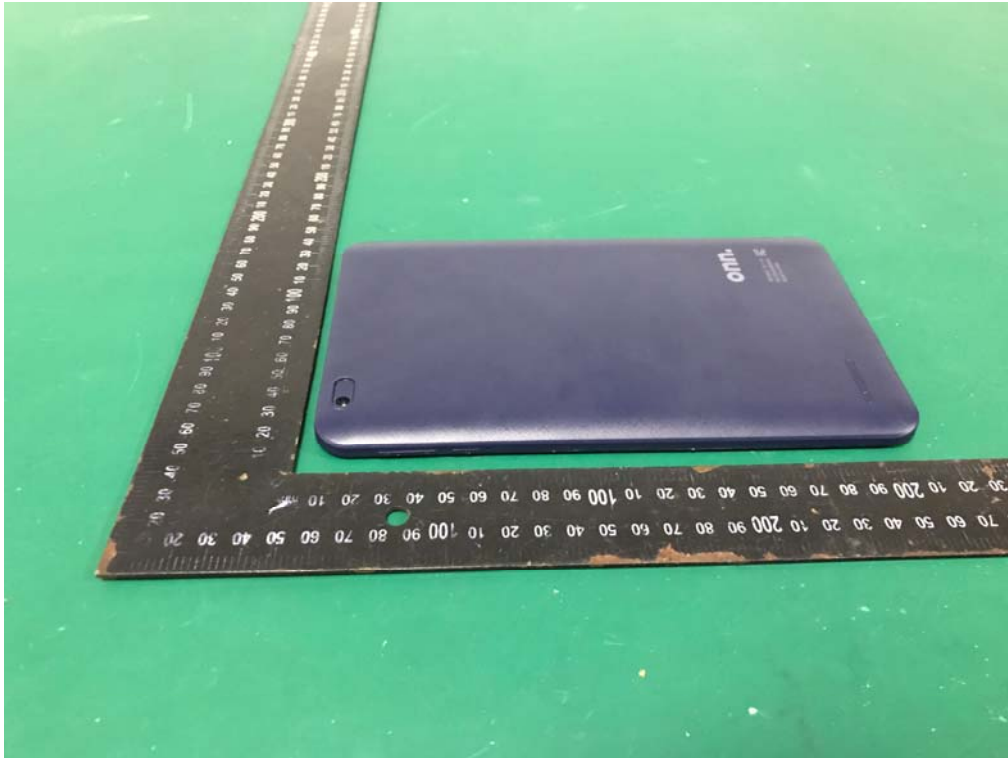
