



5.2 MPE Calculation

For FCC:

According to the formula $S=P/4\pi R^2$, we can calculate S which is MPE.

Note:

- 1) P (mW)
- 2) R = distance to the center of radiation of antenna (in meter) = 20cm
- 3) MPE limit = 1mW/cm²

For 13.56MHz: $73.16\text{dBuV/m}@3\text{m} = 73.16 + 40*\log(3/0.2) = 120.20\text{ dBuV/m}@20\text{cm} = 1.02\text{V/m} < 60.77\text{V/m}$.

The BLE and 13.56MHz function can simultaneous transmitting. But the maximum rate of MPE is $0.00372/1.0 + 1.02/60.77 = 0.0205 < 1.0$. according to the KDB447498 section 7.2 determine the device is exclusion from SAR test.
