#### 5.2 MPE Calculation

According to the formula  $S = \frac{PG}{4R^2\pi}$  , we can calculate S which is MPE.

Note:

- 1) P (Watts)
- 2) G (Antenna gain in numeric)
- 3) R = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm<sup>2</sup>

#### For FCC:

The best case gain of the antenna is 2dBi. 2dB logarithmic terms convert to numeric result is nearly 1.58

The Max Conducted Peak Output Power is 40.46mW;

$$S = \frac{PG}{4R^2\pi} = \frac{40.46 \times 1.58}{4 \times 400 \times 3.14} = 0.013 \text{ mW/cm}^2 < 1 \text{mW/cm}^2$$

#### For MIMO:

The best case gain of the antenna is 5.01dBi. 5.01dB logarithmic terms convert to numeric result is nearly 3.17

The Max Conducted Peak Output Power is 48.19mW;

$$S = \frac{PG}{4R^2\pi} = \frac{48.19 \times 3.17}{4 \times 400 \times 3.14} = 0.03 \text{ mW/cm}^2$$

So the device is exclusion from SAR test.
