## 1 Friis transmission formula: $P_d = \frac{P_{out} \cdot G}{4 \cdot \pi \cdot R^2}$

Where

$P_d$  = Power density in  $mW/cm^2$

$P_{out}$  = output power to antenna in mW

$G$  = Numeric gain of the antenna relative to isotropic antenna

$\pi = 3.1416$

$R$  = distance between observation point and center of the radiator in cm

$P_d$  the limit of MPE,  $1mW/cm^2$ . If we know the maximum gain of the antenna and total power input to the antenna, through the calculation, we will know the distance where the MPE limit is reached.
