### 5.1. Antenna requirement

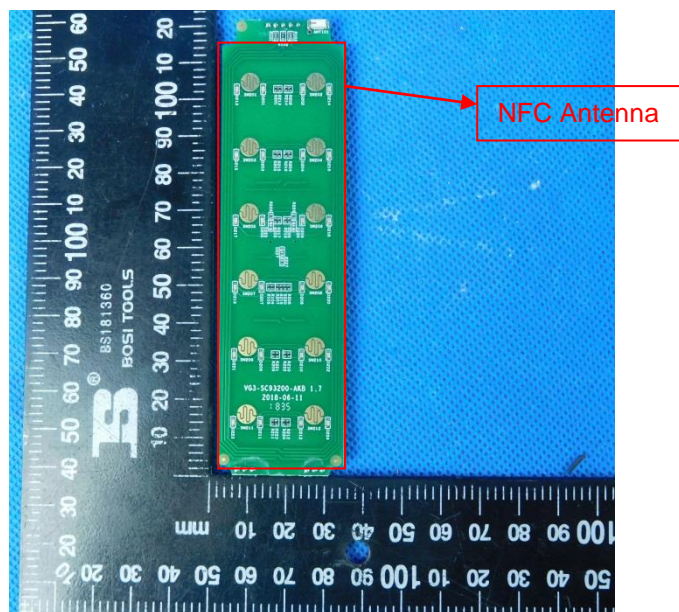

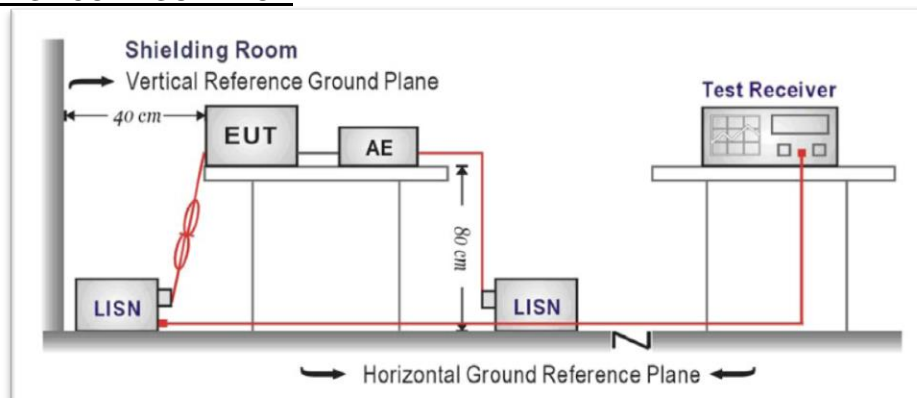

### TEST PROCEDURE

1. The EUT was setup according to ANSI C63.10:2013
2. The EUT was placed on a plat form of nominal size, 1 m by 1.5 m, raised 10 cm above the conducting ground plane. The vertical conducting plane was located 40 cm to the rear of the EUT. All other surfaces of EUT were at least 10 cm from any other grounded conducting surface.
3. The EUT and simulators are connected to the main power through a line impedance stabilization network (LISN). The LISN provides a 50ohm / 50uH coupling impedance for the measuring equipment.
4. The peripheral devices are also connected to the main power through a LISN. (Please refer to the block diagram of the test setup and photographs)
5. Each current-carrying conductor of the EUT power cord, except the ground (safety) conductor, was individually connected through a LISN to the input power source.
6. The excess length of the power cord between the EUT and the LISN receptacle were folded back and forth at the center of the lead to form a bundle not exceeding 40 cm in length.
7. Conducted emissions were investigated over the frequency range from 0.15MHz to 30MHz using a receiver bandwidth of 9 kHz.
8. During the above scans, the emissions were maximized by cable manipulation.

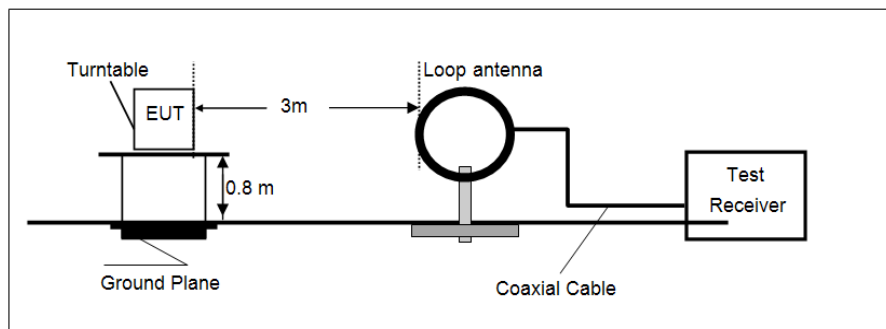

#### **TEST PROCEDURE**

1. The EUT was setup and tested according to ANSI C63.10:2013 requirements.
2. The EUT is placed on a turn table which is 0.8 meter above ground. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
3. The EUT was positioned such that the distance from antenna to the EUT was 3 meters.
4. The antenna is scanned from 1 meter to 4 meters to find out the maximum emission level. This is repeated for both horizontal and vertical polarization of the antenna. In order to find the maximum emission, all of the interface cables were manipulated according to ANSI C63.10:2013 on radiated measurement.

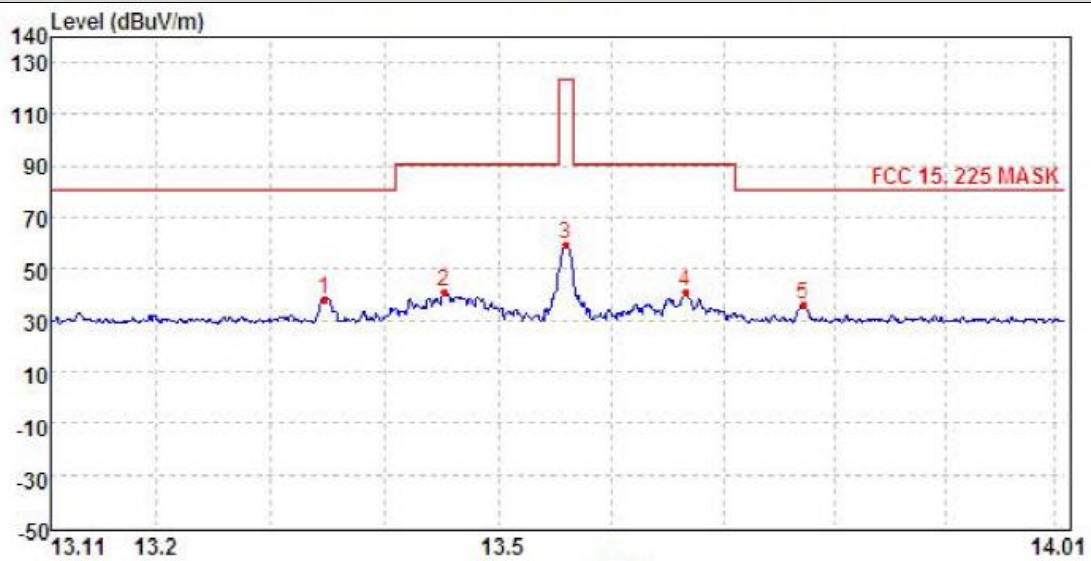

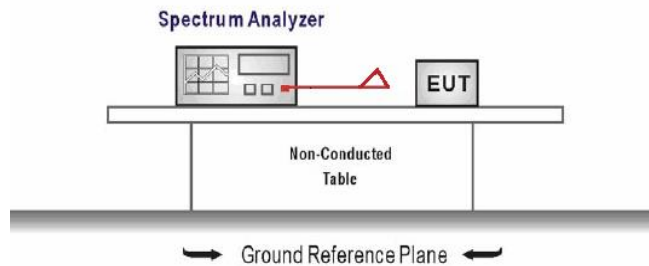

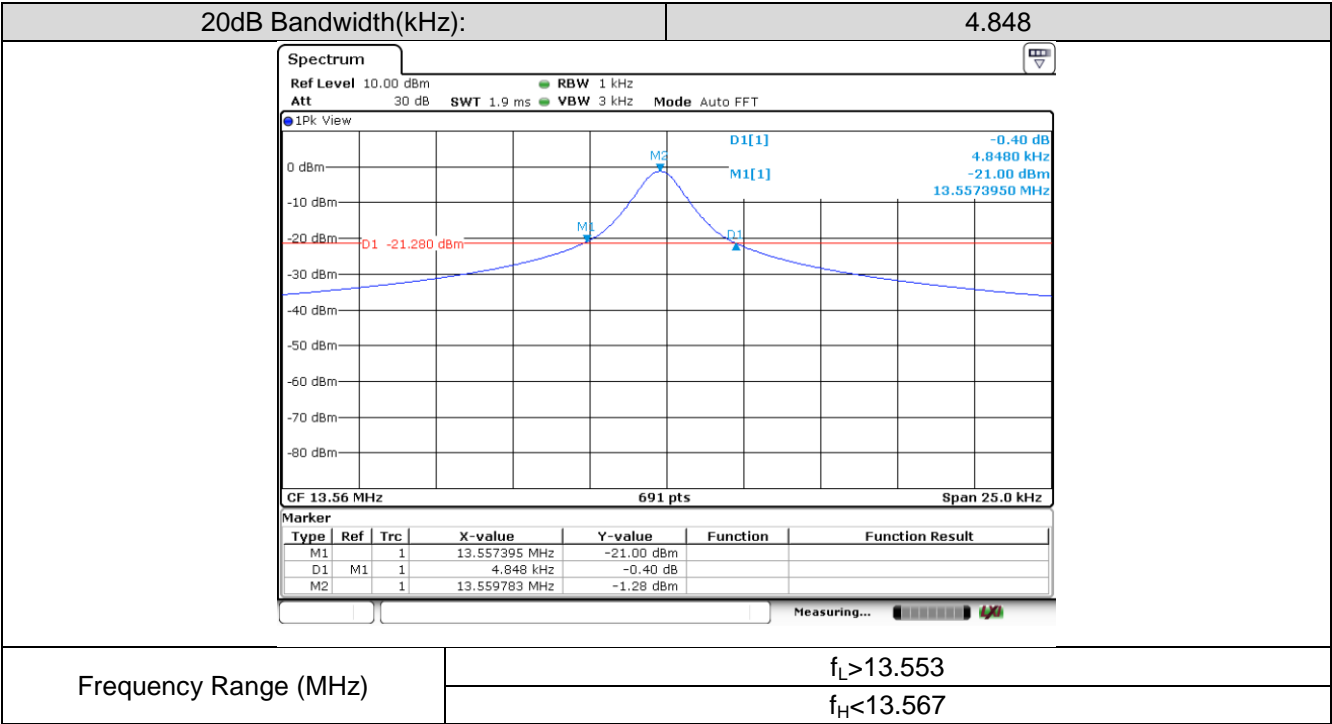

2. Set to the maximum power setting and enable the EUT transmit continuously
3. Use the following spectrum analyzer settings:  
Span = approximately 2 to 3 times the 20 dB bandwidth, centered on a hopping channel  
RBW  $\geq$  1% of the 20 dB bandwidth, VBW  $\geq$  RBW  
Sweep = auto, Detector function = peak, Trace = max hold

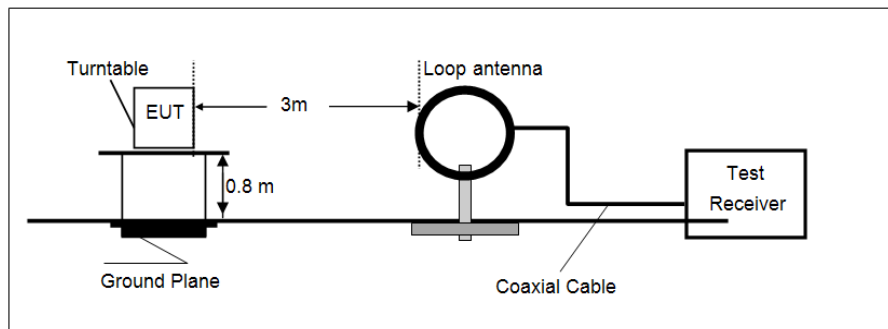

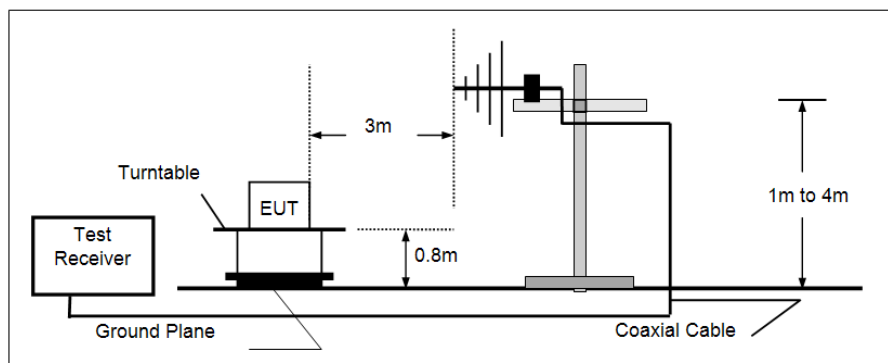

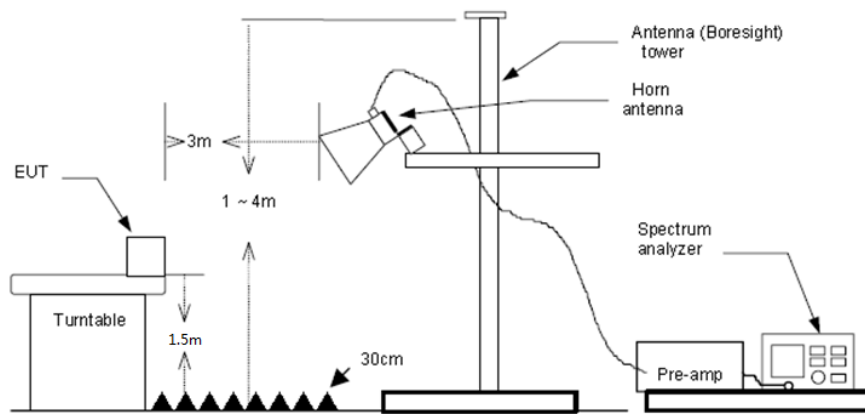

## **TEST PROCEDURE**

1. The EUT was setup and tested according to ANSI C63.10:2013 requirements.
2. The EUT is placed on a turn table which is 0.8 meter above ground for below 1 GHz, and 1.5 m for above 1 GHz. The turn table is rotated 360 degrees to determine the position of the maximum emission level.
3. The EUT was set 3 meters from the receiving antenna, which was mounted on the top of a variable height antenna tower.
4. For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level to comply with the guidelines.
5. Set to the maximum power setting and enable the EUT transmit continuously.
6. Use the following spectrum analyzer settings
  - (1) Span shall wide enough to fully capture the emission being measured;
  - (2) Below 30MHz:  
RBW=10 kHz, VBW=30 kHz, Sweep=auto, Detector function=peak, Trace=max hold;
  - (3) 30MHz to 1 GHz:  
RBW=120 kHz, VBW=300 kHz, Sweep=auto, Detector function=peak, Trace=max hold;  
If the emission level of the EUT measured by the peak detector is 3 dB lower than the applicable limit, the peak emission level will be reported. Otherwise, the emission measurement will be repeated using the quasi-peak detector and reported.
  - (4) From 1 GHz to 10<sup>th</sup> harmonic:  
RBW=1MHz, VBW=3MHz Peak detector for Peak value.  
RBW=1MHz, VBW=3MHz RMS detector for Average value.

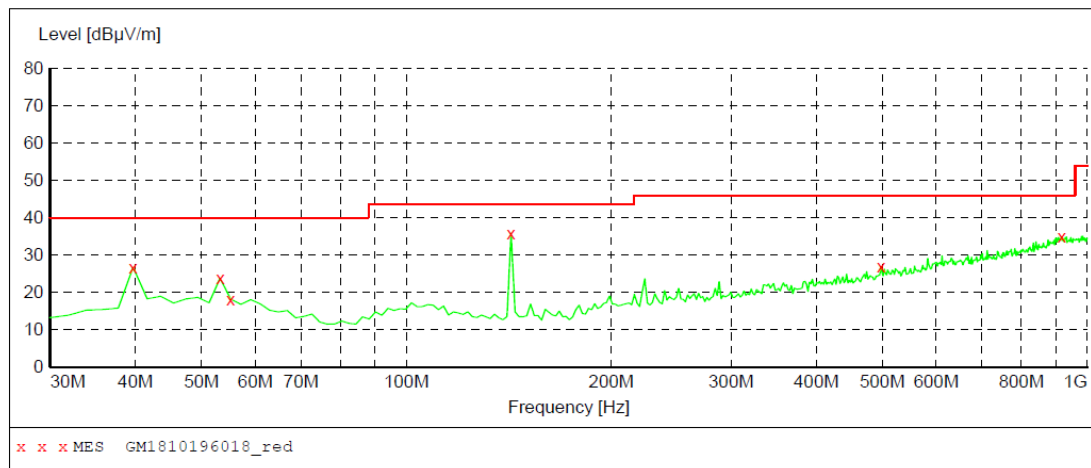

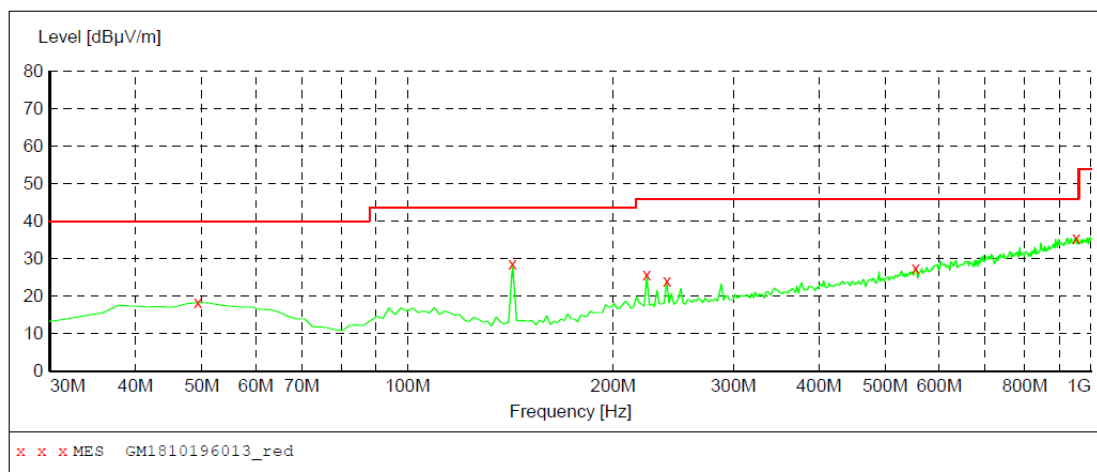

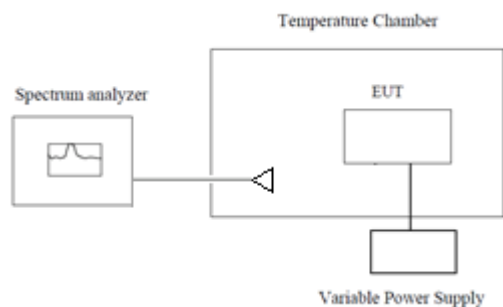

## 5.6. Frequency Stability

### LIMIT

The frequency tolerance of the carrier signal shall be maintained within  $\pm 0.01\%$  of the operating frequency over a temperature variation of  $-20$  degrees to  $+50$  degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees C. For battery operated equipment, the equipment tests shall be performed using a new battery.

### TEST PROCEDURE

1. The equipment under test was connected to an external power supply.
2. RF output was connected to a frequency counter or spectrum analyzer via feed through attenuators.
3. The EUT was placed inside the temperature chamber.
4. Set the spectrum analyzer RBW low enough to obtain the desired frequency resolution and measure EUT 25°C operating frequency as reference frequency.
5. Turn EUT off and set the chamber temperature to  $-20^{\circ}\text{C}$ . After the temperature stabilized for approximately 30 minutes recorded the frequency.
6. Repeat step measure with  $10^{\circ}\text{C}$  increased per stage until the highest temperature of  $+50^{\circ}\text{C}$  reached.

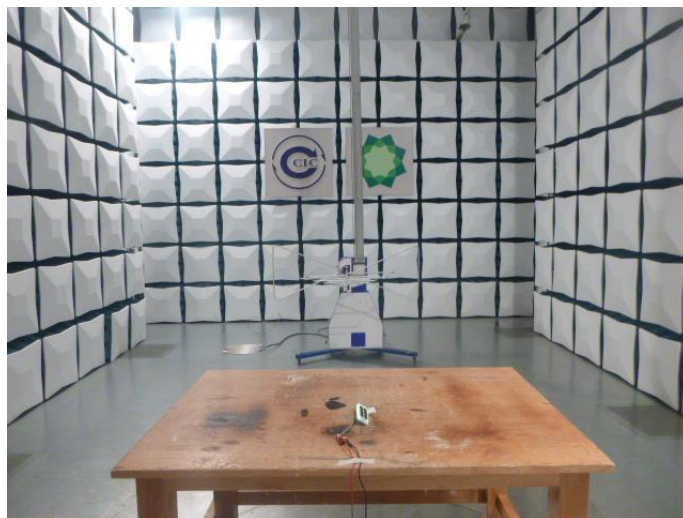
