6.3 Test Requirement

FCC Part 96.47

- a). End User Devices may operate only if they can positively receive and decode an authorization signal transmitted by a CBSD, including the frequencies and power limits for their operation.
- b). An End User Device must discontinue operations, change frequencies, or change its operational power level within 10 seconds of receiving instructions from its associated CBSD.

6.4 Test Procedure

Following procedure can be done by applying WINNF-TS-0122-V1.0.1 CBRS CBSD Test Specification, use the certified Baicell CBSD (FCC ID: 2AG32MBS110596) as companion device to show compliance with Part 96.47 requirement for End User Device (EUD):

1. Setup with frequency 3590-3610MHz and power level 13dBm/MHz;
2. Enable CBSD service ;
3. Check EUD Tx Frequency and power;
4. Disable AP service ;
5. Check EUD stops transmission within 10seconds;
6. Setup with 3650-3670MHz & power level 7dBm/MHz;
7. Enable CBSD service;
8. Check EUD Tx Frequency and power;
9. Disable CBSD service;
10. Check EUD stops transmission within 10seconds.

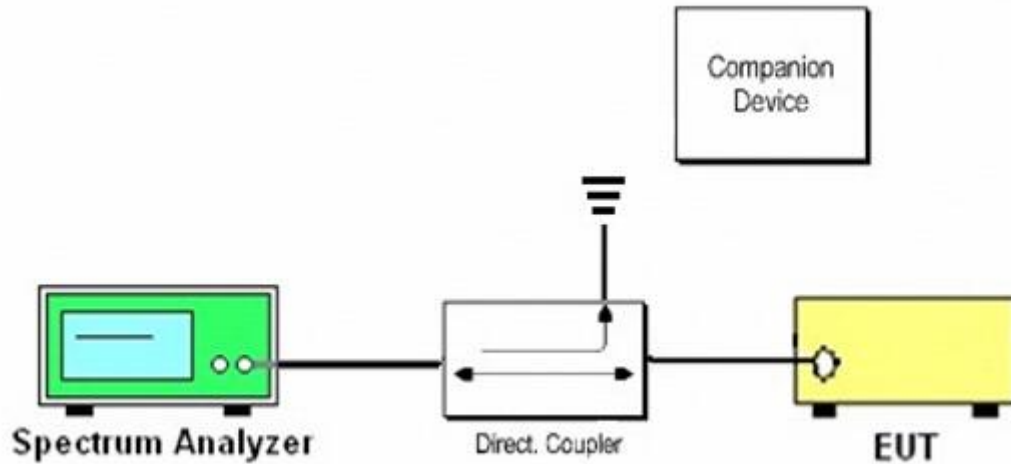

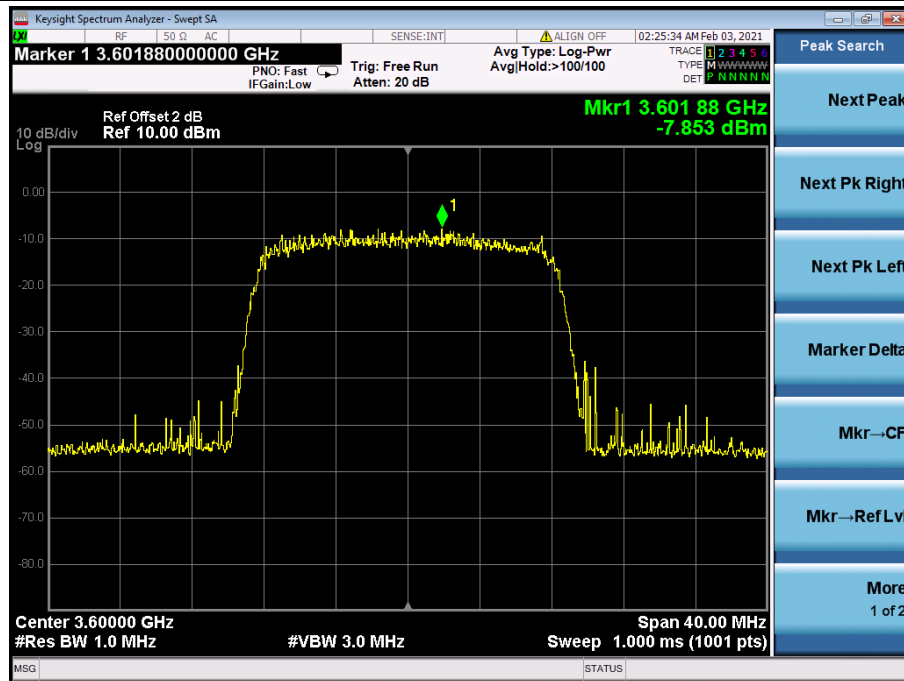

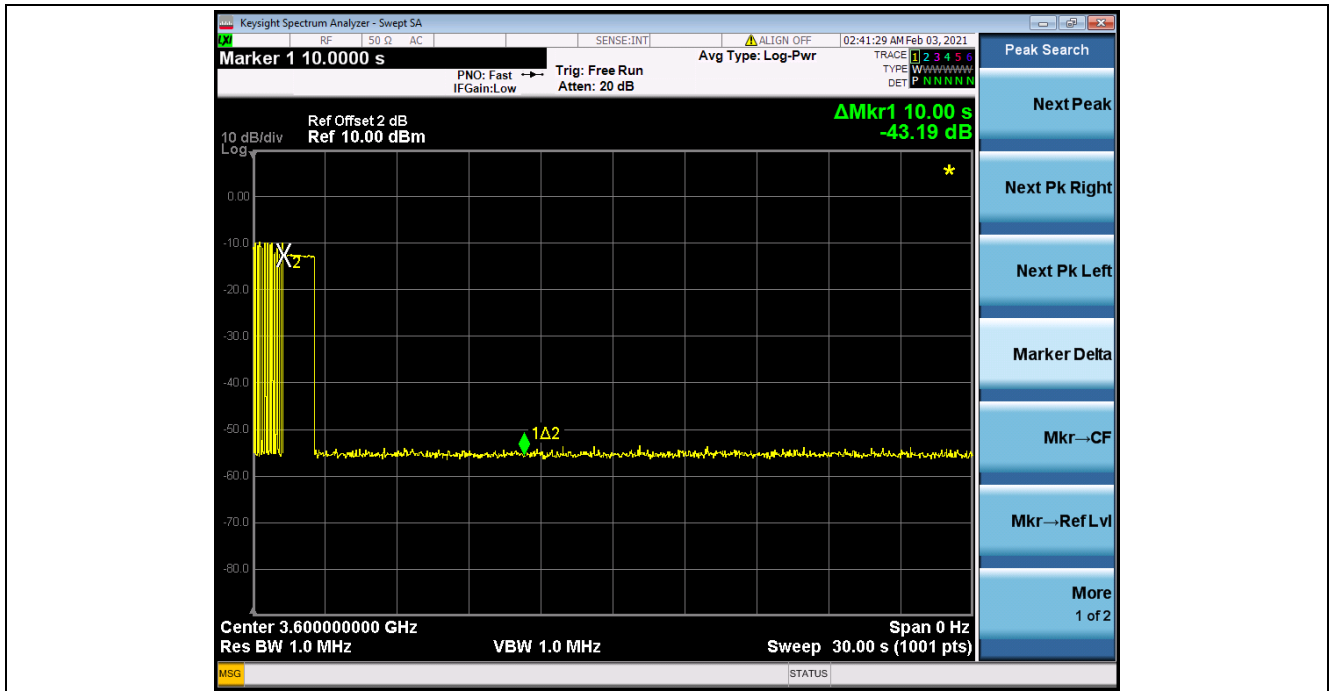

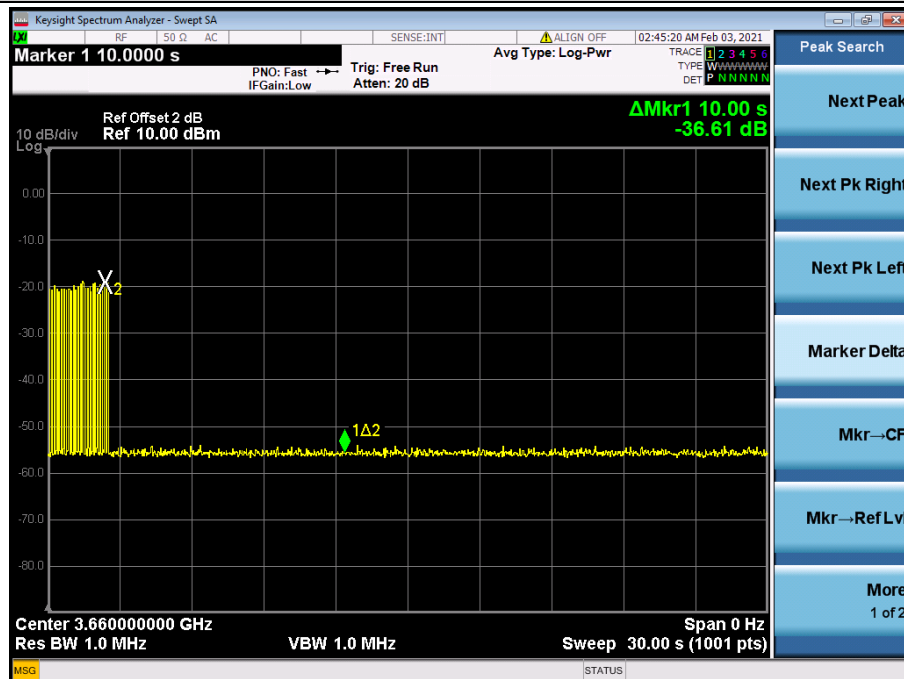


[Step 6] Setup with frequency 3650-3670MHz and power level 7dBm/MHz
