

Appendix D

Per standard guidance, dipoles longer calibration intervals of up to three years may be considered when it is demonstrated that the SAR target, impedance and return loss of a dipole have remained stable according to the following requirements:

- a. When the measured SAR deviates from the calibrated SAR value by less than 10%.
- b. When the most recent return loss result, measured at least annually, deviates by less than 20% from the previous measurement.
- c. When the most recent measurement of the impedance, measured at least annually, deviates by less than 5Ω from the previous measurement.




