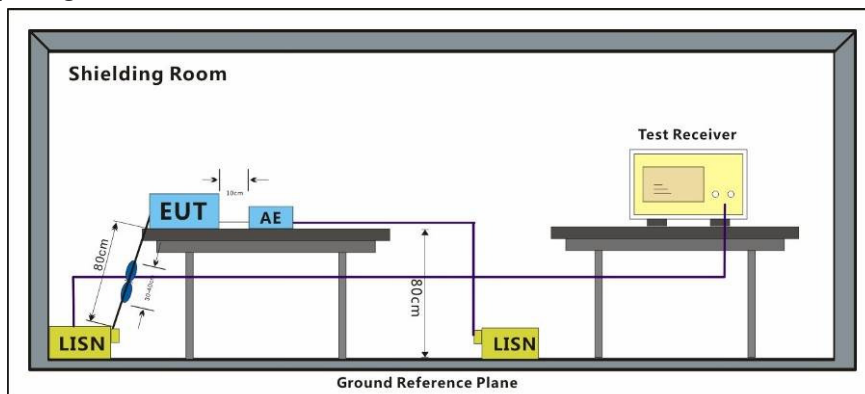

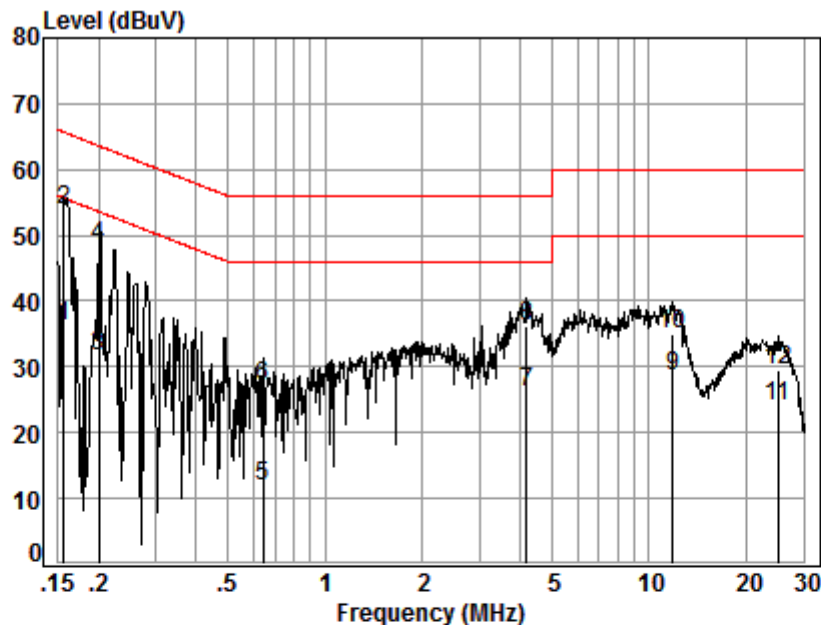

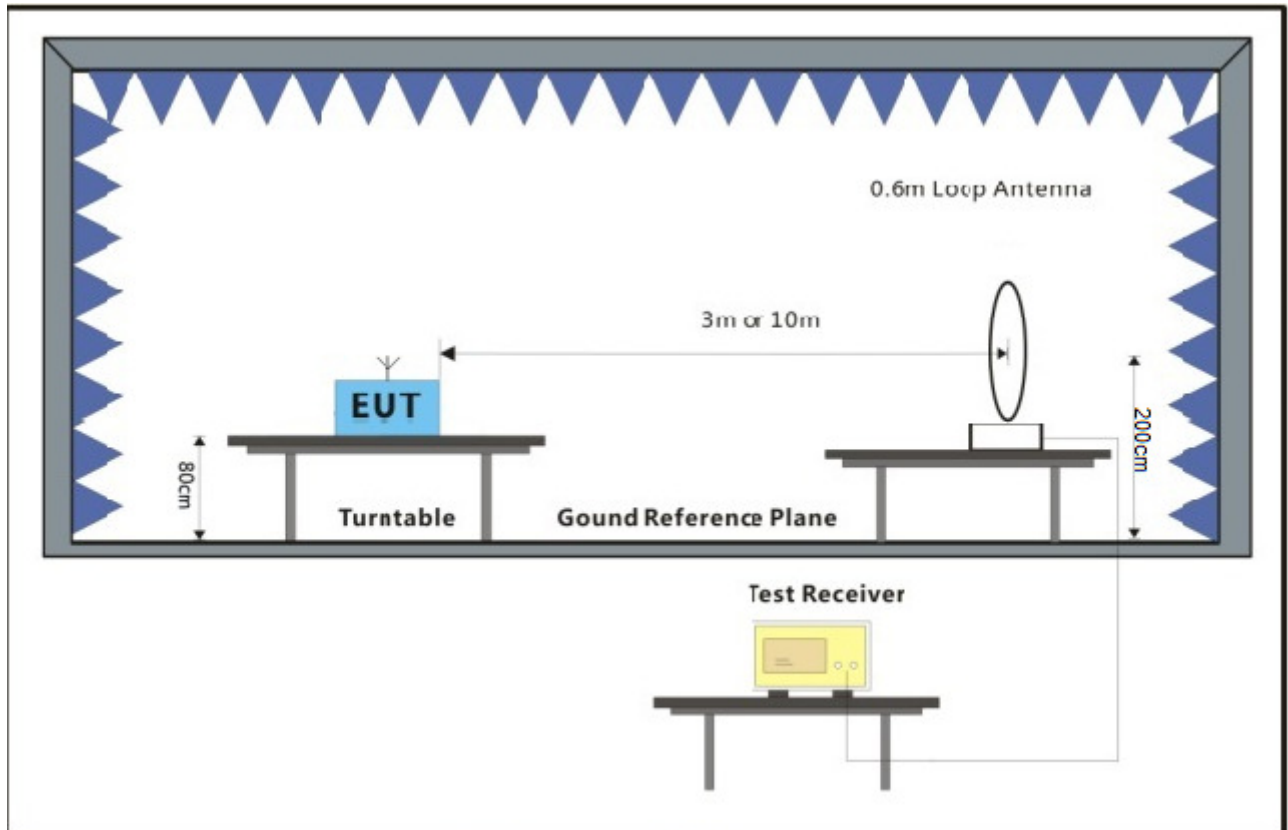

6.2.2 Test Setup Diagram

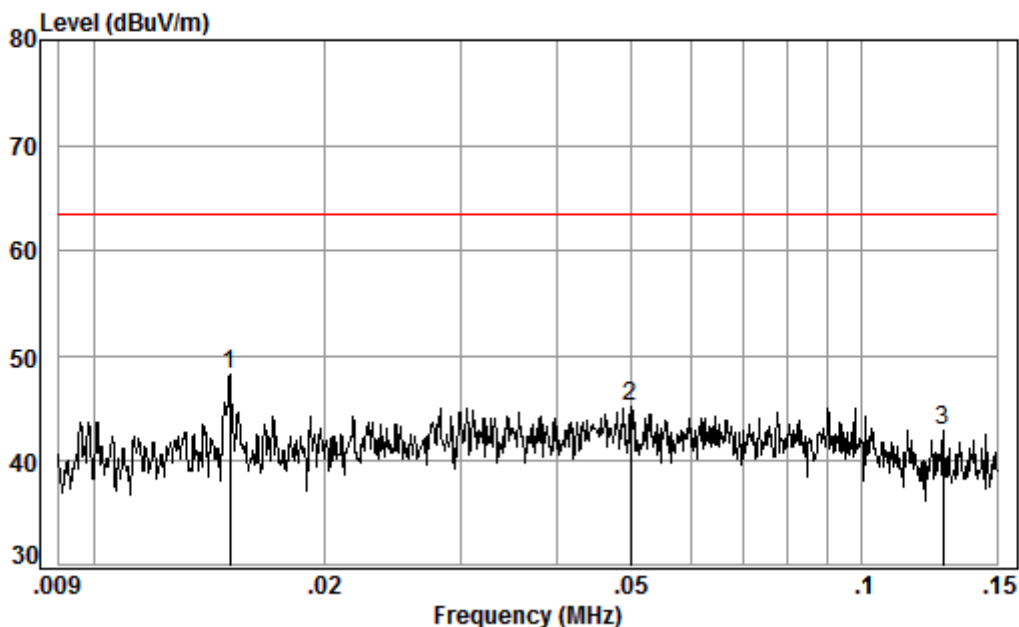

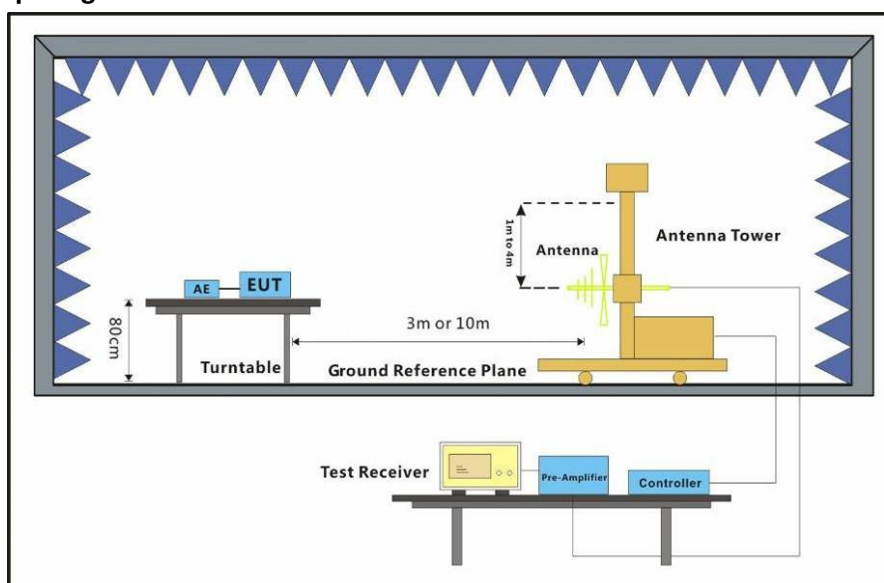

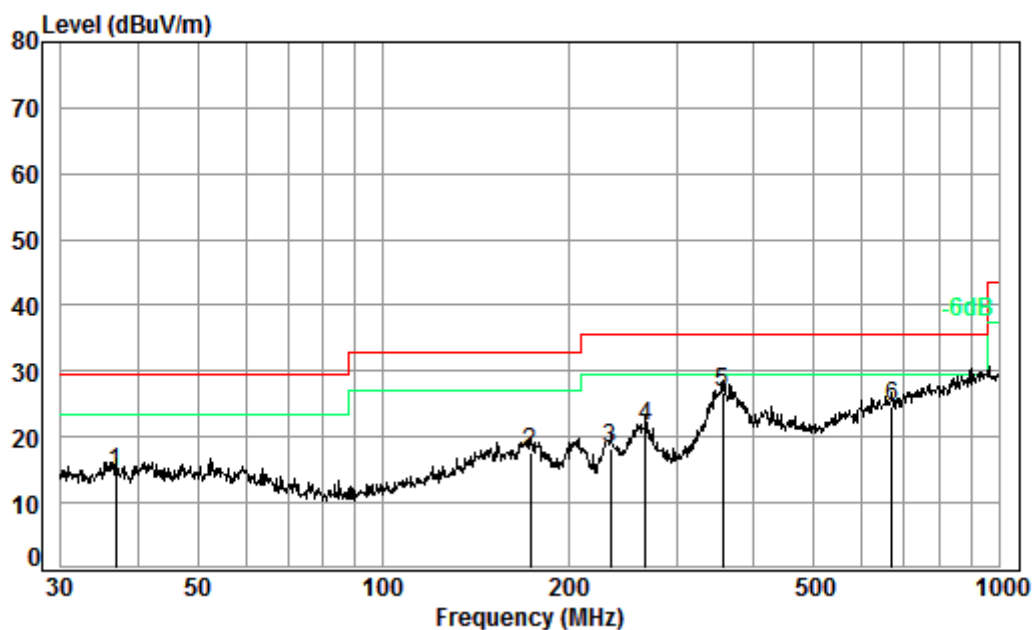


6.3.3 Measurement Data

Mode:b; Polarization:Horizontal



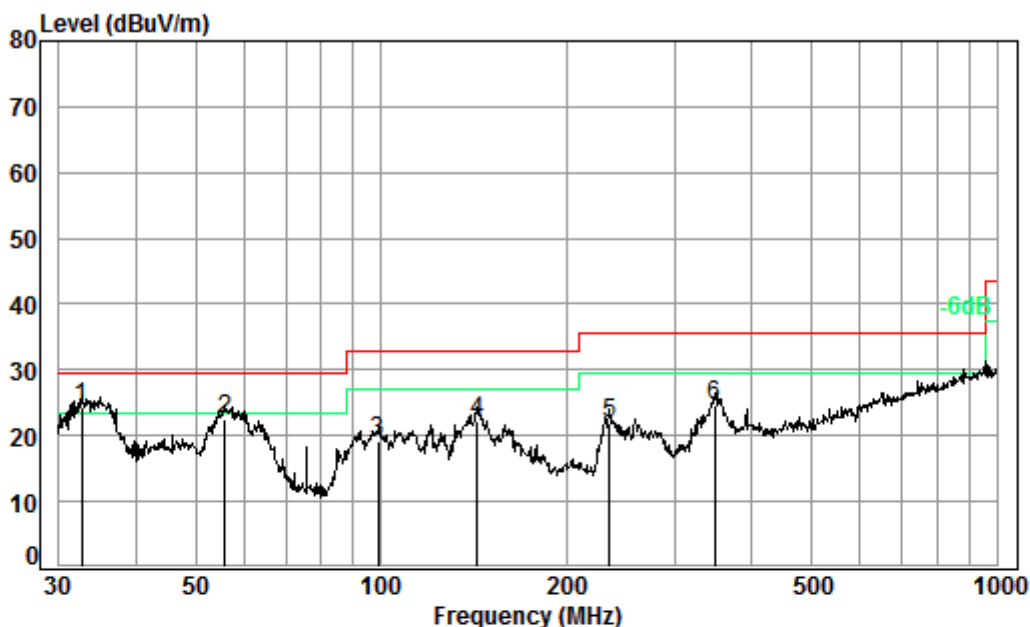
