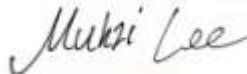

4 DESCRIPTION OF TEST MODES

During the testing, the EUT was controlled via Rhode & Schwarz Digital Radio Communication Tester(CMU 200) to ensure max power transmission and proper modulation. Three channels (The low channel, the middle channel and the high channel) were chosen for testing on, GSM/GPRS/EGPRS 850, GSM/GPRS/EGPRS 1900, HSDPA band II, HSUPA band II, HSDPA band V, HSUPA band V frequency band.

Note: GSM/GPRS/EGPRS 850, GSM/GPRS/EGPRS 1900, HSDPA band II, HSUPA band II, HSDPA band V, HSUPA band V, modes have been tested during the test. the worst condition be recorded in the test report if no other modes test data.

Antenna port conducted and radiated test items were performed according to KDB 971168 D01 Power Meas. License Digital Systems v03 with maximum output power.

Radiated measurements were performed with rotating EUT in different three orthogonal test planes to find the maximum emission.

Radiated emissions were investigated as following frequency range:

- 30 MHz to 10th harmonic for GSM850/UMTS FDD Band V
- 30 MHz to 10th harmonic for GSM1900/UMTS FDD Band II

All modes and data rates and positions were investigated.

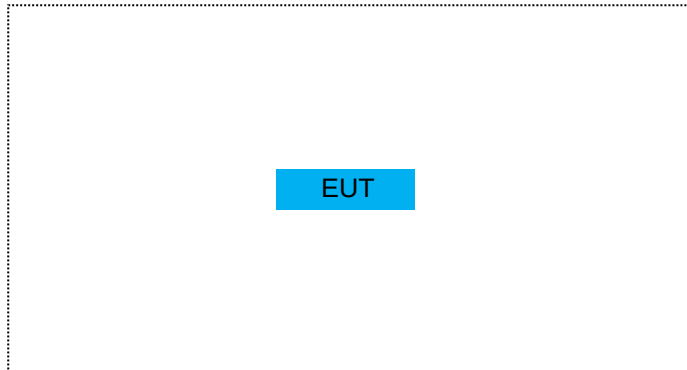

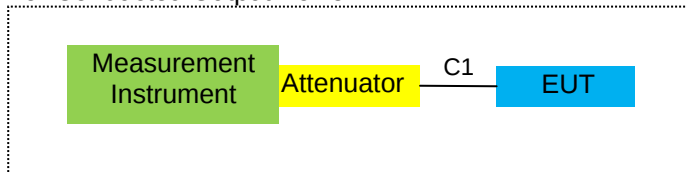

5.1 BLOCK DIAGRAM CONFIGURATION OF TEST SYSTEM

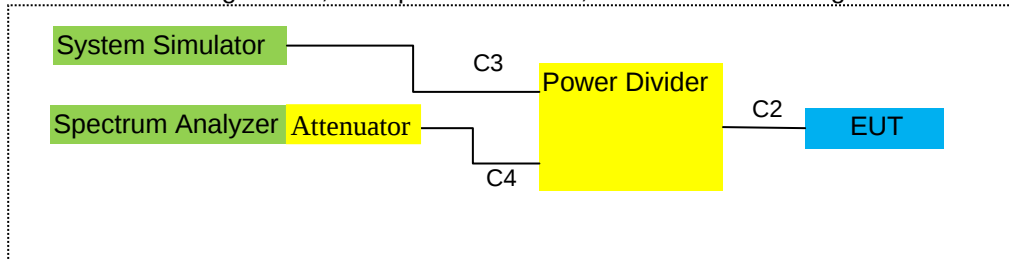
For Radiated Test Cases



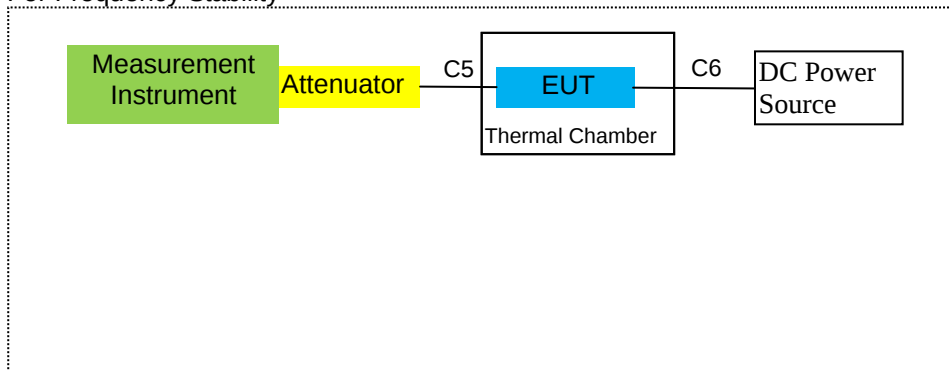
For Conducted Output Power

6 TEST REQUIREMENTS

6.1 FIELD STRENGTH OF SPURIOUS RADIATION

6.1.1 Applicable Standard

According to FCC KDB 971168 D01 v03 Section 5.8 and ANSI/TIA-603-E-2016 Section 2.2.12

6.1.2 Conformance Limit

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitter power (P) by a factor of at least $43 + 10 \log (P)$ dB. The spectrum is scanned from 30 MHz up to a frequency including its 10th harmonic.

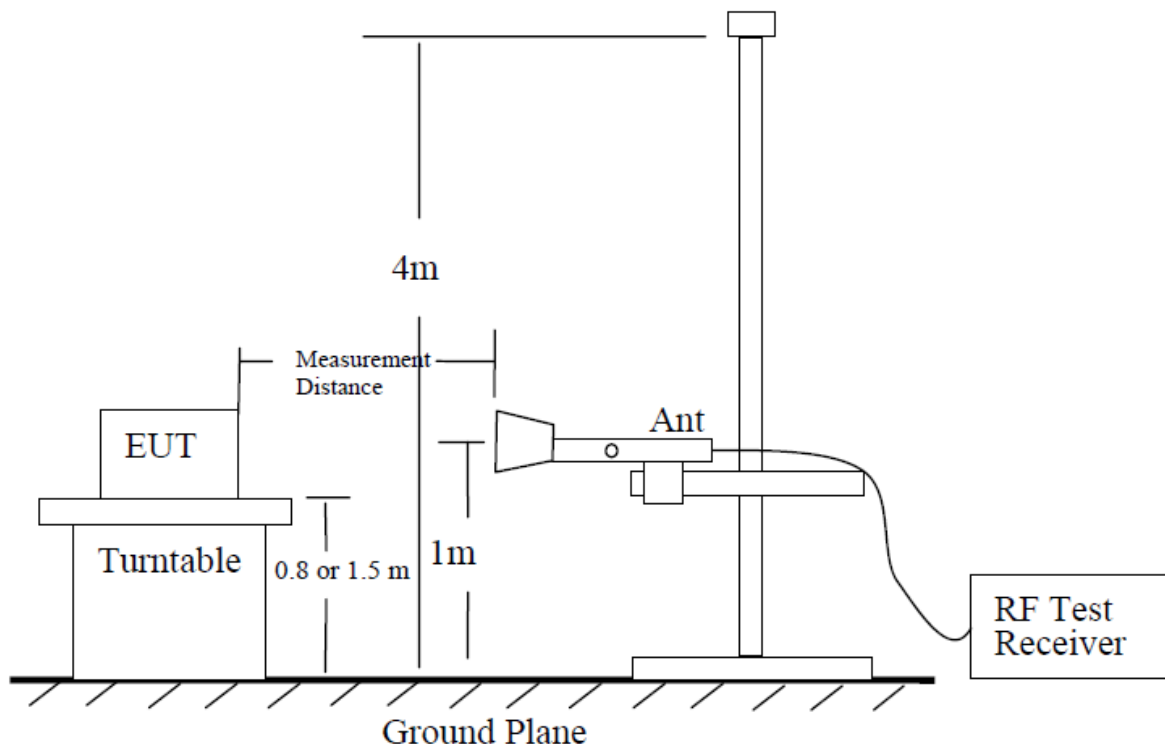
6.1.3 Measuring Instruments

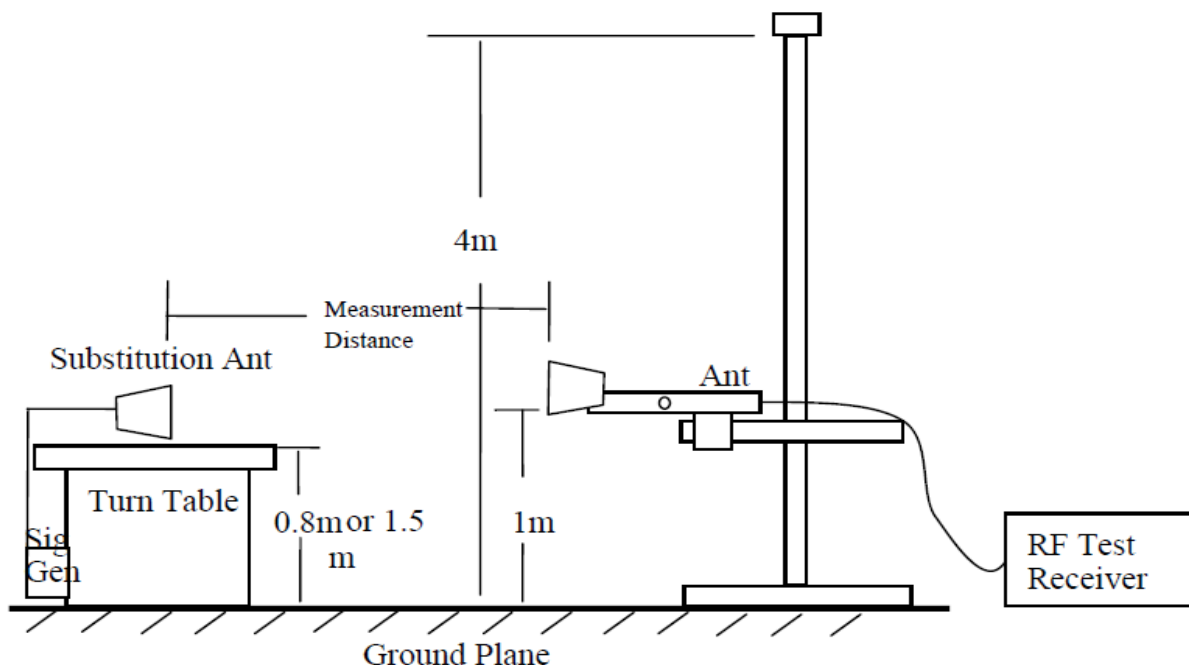
The Measuring equipment is listed in the section 6.3 of this test report.

6.1.4 Test Configuration

According to the ANSI/TIA-603-E-2016 test method, The Receiver or Spectrum was scanned from 9 KHz to the 10th harmonic of the highest frequency generated within the equipment, which is the transmitted carrier that can be as high as 1910 MHz. The resolution bandwidth is set as outlined in Part 24.238, Part 22.917. The spectrum is scanned with the mobile station transmitting at carrier frequencies that pertain to low, mid and high channels of WCDMA Band II / V / GSM 850 / 1900.

6.1.5 Test Procedure

1. EUT was placed on a 0.8 meter (For frequency above 1G, EUT should be placed on 1.5m) high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the EUT for emission measurements. The height of receiving antenna is 1.50 meter. Detected emissions were maximized at each frequency by rotating the EUT through 360° and adjusting the receiving antenna polarization. The radiated emission measurements of all transmit frequencies in three channels (High, Middle, Low) were measured with peak detector.
2. A log-periodic antenna or double-ridged waveguide horn antenna shall be substituted in place of the EUT. The log-periodic antenna will be driven by a signal generator and the level will be adjusted till the same power value on the spectrum analyzer or receiver. The level of the spurious emissions can be calculated through the level of the signal generator, cable loss, the gain of the substitution antenna and the reading of the spectrum analyzer or receiver.
3. The EUT is then put into continuously transmitting mode at its maximum power level during the test. Set Test Receiver or Spectrum RBW=1MHz, VBW=3MHz, And the maximum value of the receiver should be recorded as (P_r).
4. The EUT shall be replaced by a substitution antenna. In the chamber, an substitution antenna for the frequency band of interest is placed at the reference point of the chamber. An RF Signal source for the frequency band of interest is connected to the substitution antenna with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A power (SG Level) is applied to the input of the substitution antenna, and adjust the level of the signal generator output until the value of the receiver reach the previously recorded (P_r). The power of signal source (SG Level) is recorded. The test should be performed by rotating the test item and adjusting the receiving antenna polarization.
5. A amplifier should be connected to the Signal Source output port. And the cable should be connect between the Amplifier and the Substitution Antenna. The cable loss (Cable Loss), the Substitution Antenna Gain should be recorded after test.
The measurement results are obtained as described below:
 $\text{Power(EIRP)} = \text{SG Level} - \text{Cable Loss} + \text{Antenna Gain}$
6. This value is EIRP since the measurement is calibrated using an antenna of known gain (2.15 dBi) and known input power.
7. ERP can be calculated from EIRP by subtracting the gain of the dipole, $\text{ERP} = \text{EIRP} - 2.15\text{dBi}$.

6.2 EFFECTIVE RADIATED POWER AND EFFECTIVE ISOTROPIC RADIATED POWER

6.2.1 Applicable Standard

According to FCC KDB 971168 D01 v03 Section 5.2.1/ Section 5.2.2.2 and ANSI/TIA-603-E-2016 Section 2.2.17

6.2.2 Conformance Limit

The substitution method, in ANSI/TIA-603-E-2016, was used for ERP/EIRP measurement, and the spectrum analyzer configuration follows KDB 971168 D01 Power Meas. License Digital Systems v03r01. The ERP of mobile transmitters must not exceed 7 Watts (Cellular Band) and the EIRP of mobile transmitters are limited to 2 Watts (PCS Band) and the EIRP of mobile transmitters are limited to 1 Watts (AWS Band).

6.2.5 Test Procedure

The measurements procedures specified in ANSI/TIA-603-E-2016 were applied.
In an anechoic antenna test chamber, a half-wave dipole antenna for the frequency band of interest is placed at the reference centre of the chamber. An RF Signal source for the frequency band of interest is connected to the dipole with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A known (measured) power (P_{in}) is applied to the input of the dipole, and the power received (P_r) at the chamber's probe antenna is recorded.

The relevant equation for determining the ERP or EIRP from the conducted RF output power measured using the guidance provided above is:

$$ERP/EIRP = SGLevel - P_{cl} + G_a$$

where:

ERP/EIRP = effective or equivalent radiated power, respectively (expressed in the same units as SGLevel, typically dBW or dBm);

SGLevel = Signal generator output power or PSD, in dBm or dBW;

G_a = gain of the transmitting antenna, in dBd (ERP) or dBi (EIRP);

P_{cl} = signal attenuation in the connecting cable between the transmitter and antenna, in dB.²

The EUT is substituted for the dipole at the reference centre of the chamber and a scan is performed to obtain the radiation pattern.

From the radiation pattern, the co-ordinates where the maximum antenna gain occurs are identified.

The EUT is then put into continuously transmitting mode at its maximum power level.

Power mode measurements are performed with the receiving antenna placed at the coordinates determined in Step 3 to determine the output power as defined in Rule 24.232 (b) and (c). The "reference path loss" from Step1 is added to this result.

This value is EIRP since the measurement is calibrated using a half-wave dipole antenna of known gain (2.15 dBi) and known input power (P_{in}).

ERP can be calculated from EIRP by subtracting the gain of the dipole, $ERP = EIRP - 2.15\text{dBi}$.

Both horizontal and vertical antenna polarities were tested and performed pretest to three orthogonal axis. The worst case emissions were reported.

6.3.2 Conformance Limit

Extend coverage on a secondary basis into cellular unserved areas, as those areas are defined in §22.949, the ERP of base transmitters and cellular repeaters of such systems must not exceed 1000 Watts. The ERP of mobile transmitters and auxiliary test transmitters must not exceed 7 Watts(38.5dBm).

Mobile and portable stations are limited to 2 watts (33dBm)EIRP and the equipment must employ a means for limiting power to the minimum necessary for successful communications..

6.3.5 Test Procedure

Connect the EUT to Universal Radio Communication Tester CMU200 or CMU500 via the antenna connector. A call is set up by the SS according to the generic call set up procedure on a channel with ARFCN in the ARFCN range, power control level set to Max power. The frequency band is set as selected frequency, The RF output of the transmitter was connected to base station simulator.

Set EUT at maximum average power by base station simulator.

Set RBW = 1-5% of the OBW, not to exceed 1 MHz.

Set VBW $\geq 3 \times$ RBW.

Number of points in sweep $\geq 2 \times \text{span} / \text{RBW}$. (This gives bin-to-bin spacing $\leq \text{RBW}/2$, so that narrowband signals are not lost between frequency bins.)

Sweep time = auto.

Detector = RMS (power averaging).

Set sweep trigger to "free run".

Trace average at least 100 traces in power averaging (i.e., RMS) mode; however, the number of traces to be averaged shall be increased above 100 as needed such that the average accurately represents the true average over the on and off periods of the transmitter.

Compute power by integrating the spectrum across the OBW of the signal using the instrument's band power measurement function with band limits set equal to the OBW band edges. If the instrument does not have a band power function, sum the spectrum levels (in power units) at intervals equal to the RBW extending across the entire OBW of the spectrum.

Add $10 \log (1/x)$, where x is the duty cycle, to the measured power in order to compute the average power during the actual transmission times (because the measurement represents an average over both the on and off times of the transmission). For example, add $10 \log (1/0.25) = 6 \text{ dB}$ if the duty cycle is a constant 25%.

Measure lowest, middle, and highest channels for each bandwidth and different modulation.

Measure and record the results in the test report.

6.4 FREQUENCY STABILITY

6.4.1 Applicable Standard

According to FCC Part 2.1055 and FCC Part 22.355 and FCC KDB 971168 D01 Section 9.0

6.4.2 Conformance Limit

The frequency stability shall be measured by variation of ambient temperature and variation of primary supply voltage to ensure that the fundamental emission stays within the authorized frequency block. The frequency stability of the transmitter shall be maintained within $\pm 0.00025\%$ ($\pm 2.5\text{ppm}$) of the center frequency.

6.6 26DB BANDWIDTH AND 99% OCCUPIED BANDWIDTH

6.6.1 Applicable Standard

According to FCC Part 2.1049 and FCC Part 22H and FCC KDB 971168 D01 Section 4

6.6.2 Conformance Limit

The occupied bandwidth is the width of a frequency band such that, below the lower and above the upper frequency limits, the mean powers emitted are each equal to a specified percentage 0.5% of the total mean transmitted power.

The 26 dB emission bandwidth is defined as the frequency range between two points, one above and one below the carrier frequency, at which the spectral density of the emission is attenuated 26 dB below the maximum in-band spectral density of the modulated signal. Spectral density (power per unit bandwidth) is to be measured with a detector of resolution bandwidth equal to approximately 1.0% of the emission bandwidth.

Determine the “-26 dB down amplitude” as equal to (Reference Value – X).

Place two markers, one at the lowest and the other at the highest frequency of the envelope of the spectral display such that each marker is at or slightly below the “-X dB down amplitude” determined in step 6. If a marker is below this “-X dB down amplitude” value it shall be placed as close as possible to this value. The OBW is the positive frequency difference between the two markers.
