Press the selfie button for 3-5s,Blue light will turn on,then the light flashing bluetooth signal can be searched.

Step 3

Turn on the Bluetooth of your telephone,Search "X1" to connected (Not require password).

Step 4

If connection failed within 5 minutesmit will enter sleeping mode and the light will turn off.You can press the selfie button to activate.
