Blue: Stand by.

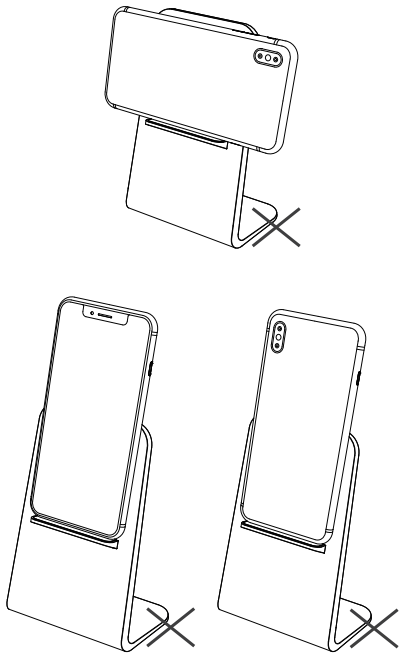
Red blink: Charging.
