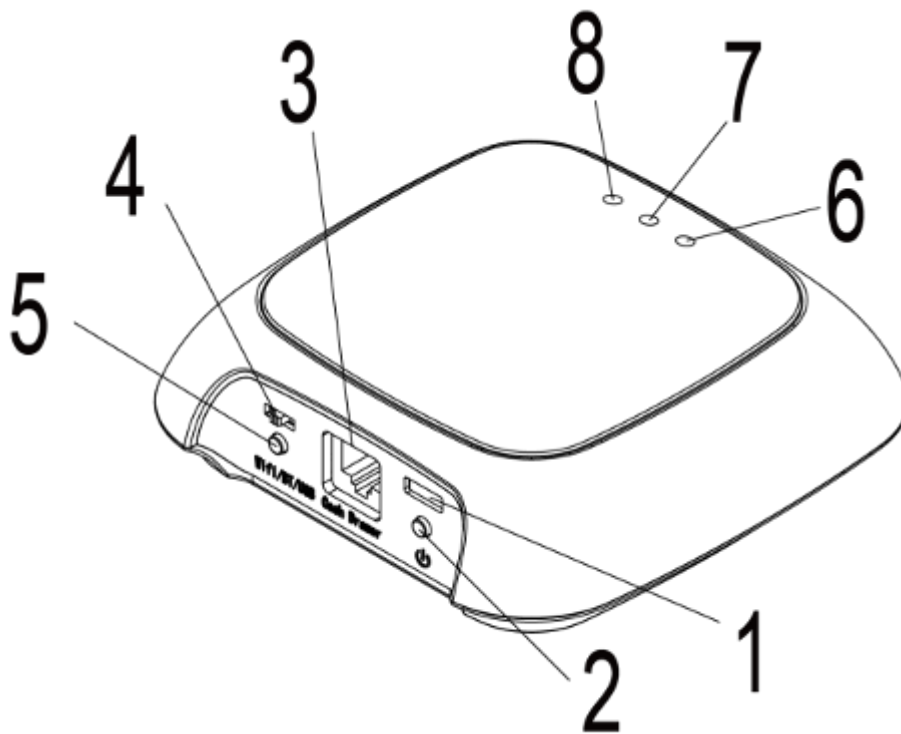


Product Instruction

1、 Inventory :

2、 Key Interface Description :



1. Power port (Micro USB)
2. Power switch
3. Cashbox interface (RJ12)

Note: the money box must be equipped with a micro switch, and the micro switch is normally closed. Special note:

4. Communication mode select key

WIFI/Bluetooth

5. Configuration key

Only WIFI mode is effective.

6. Power Light

Bright : Starting up

Not bright : Shutdown

7. Money box indicator light

Bright : The box open

Not bright : The box cloth

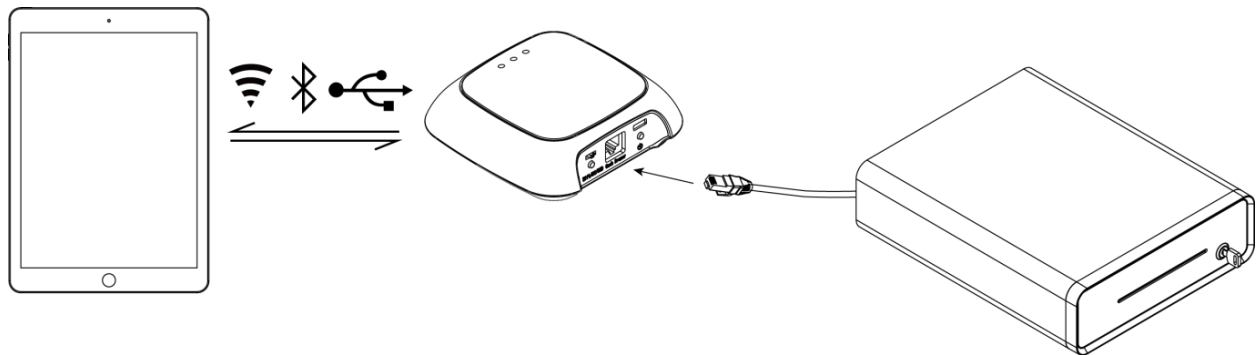
8. Communication light

WIFI mode Bright : connected; Glitter : ununited ; fast blink : Configuration state

BT mode Bright : onnected ; Glitter : ununited

3、 Operating Instructions :

1. Connection method : Panel computer-TPT-200-cashbox



2. Open the APP on the tablet and select the same communication mode as the target TPT200 (WIFI mode requires the TPT200 and the tablet to be on the same network segment), click Search, the device list displays all the TPT200 products found, select the target device, and establish a connection. Press the unlock button and the cash box opens.
3. WIFI configuration: The communication mode selection button is switched to the WIFI gear position, press the configuration button to enter the configuration state. At this time, the indicator light flashes rapidly, the tablet APP selects the WIFI mode, enters the configuration page, fills in the WIFI user name and password, and sends the indicator light. It is always on and the configuration is successful.

4、FCC Compliance

1.This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions:
