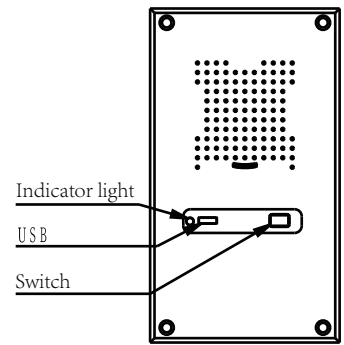


Step 1

The usage instruction of bluetooth speakers

1. Turn on the both two speakers at the same time, this is important to ensure you can sync both speakers successfully , then you'll see instruction light on the speaker flash that indicated the speaker is on working.
2. Turn on Mobile's Bluetooth, search for name "taipeng" , then try to matches it and you'll hear sound "bee" indicated that you're successfully matches with both speakers.
3. Congratulation you can play music through your mobile.
4. If you powers off , you only click one switch so thay you can turn off all speakers.
5. When the power is low, the sound prompt " Battery is low, please recharge in time", then you will hear "bee, bee"that indicate the speakers turn off.
6. When charging, the indicator light will turn red. During charging, the indicator light will slowly dim..When fully charged, the red light will be extinguished.

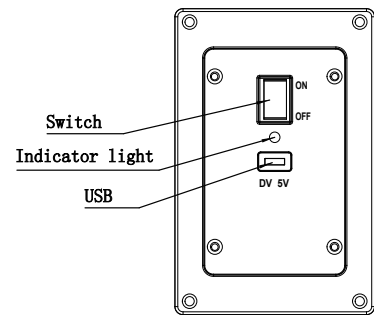

1. When the switch is pressed, the light illuminates and can be used normally.
2. When the light is weak, please recharged immediately by USB interface.
3. The red light is on during chargeing and off when full.
4. It can continue for 10 hours after charged completely.

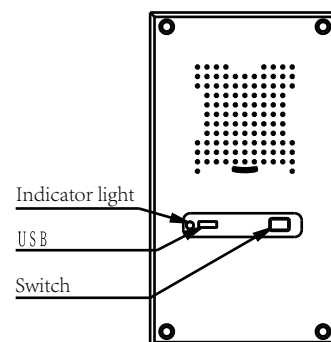
