Hopping Channel Number_DH5



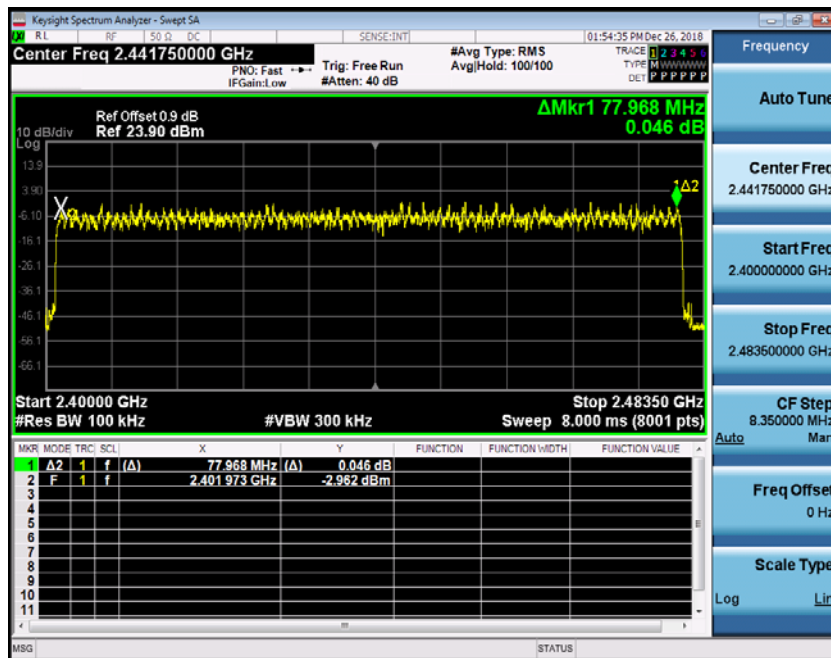
