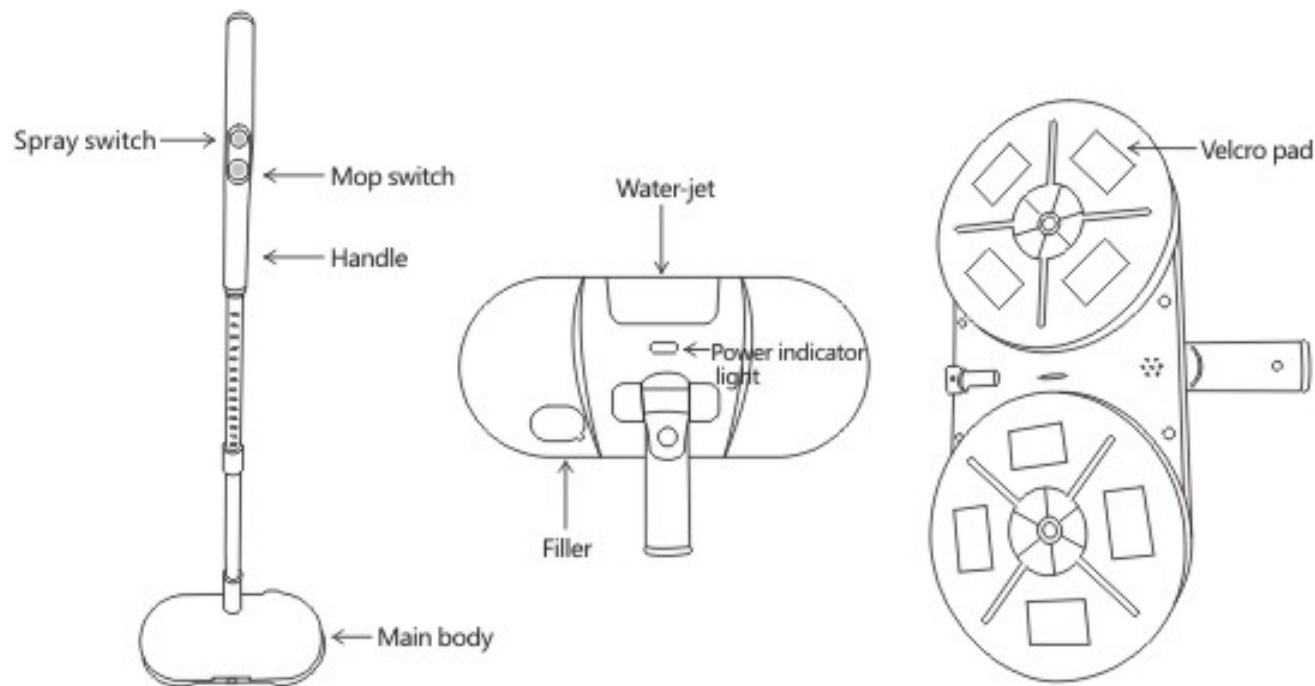

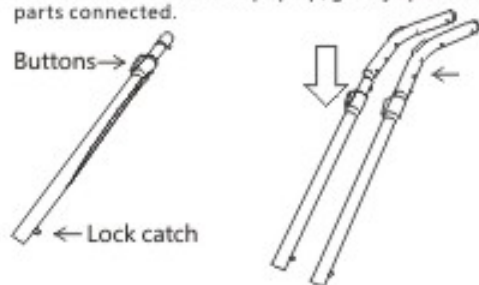

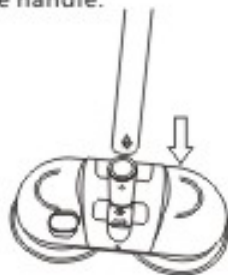
## Installation Instructions

1. Press the lock catch on the metal pipe; connect the metal pipe with the handle and the casing in succession.

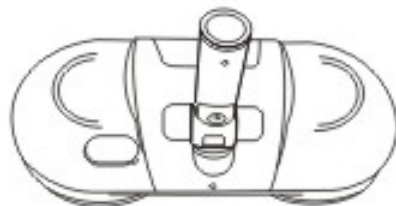
Note: If the lock catch doesn't pop up, gently spin the two parts connected.



3. Put the main body onto the floor, press the lock catch on the metal pipe, and insert the handle module just assembled into the main body's moveable handle.



2. Straighten up the movable handle on the main body and put the main body onto the floor.



4. Place the mop onto the floor, lift the washer and aim it at the mop, where the cross on the rotary disc should match that on the mop to attach with it.



## Instructions for Use

### Power on / off

Pull the handle back until the release of lock catch; then the power indicator light will be on and the washer powered on. Straighten the handle forward and the washer will be powered off.

Note: \*The washer will become dormant after 2 minutes on standby, while the power indicator light will be off; activate the washer again by powering it off.



### Start working / spraying

The washer uses a wireless control to start working or spraying. Press the start button on the handle and the washer will start operating as the mops begin reciprocating; press the start button again and the operating will stop. Long-press the spray button and the nozzle will spray water; press the spray button again and the spraying will stop.

Notes: \*Remote control is unavailable when the washer is being charged.

\*When long-pressing the spray button, each spraying will last up to 3 seconds.

\*To ensure the sensitivity of remote control, press the button at an interval not less than 15 seconds.

### Add water

Turn up the lid of the filler and secure it with a hand. Add clean water to the tank with the measuring cup, until the water reaches the "MAX" level. Cover the filler again.

Notes:

\*The water tank has a capacity of 180ML.

\*Detergent or wax oil can be added in the water tank.

\*Please ensure that the water added is clean, or the nozzle or pump might be blocked.



## Power indicator light

The 3 lamps indicate 100%, 65% or 30% battery life respectively if three, two or only one of them is / are on.

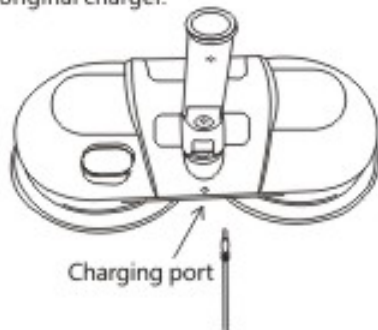


- \*3 lamps on indicates 100% battery life.
- \*2 lamps on indicates 65% battery life.
- \*1 lamp on indicates 30% battery life.
- \*3 lamp flashing indicates the washer is about to shut down.

## First charge

Ensure that the charger and the charging port are free of foreign objects, and insert the charger into the charging port on the washer's main body

Note: Please use an original charger.



## Replace the mop

Invert the washer and tear the mop down by its edge.



## Before You Start

### The handle

- \* When you push up the handle to power off, straighten it for autolocking

### The Velcro pad

- \* The Velcro pad may be attached with some fiber after repeated use, which can lower its performance. It's recommended to slightly clean it with a tooth brush.

### The mop

- \* Remove the mop after each use to wash and dry it timely; or use disposable mops.

## Troubleshooting

If the washer malfunctions, please refer to the following table to troubleshoot

The washer fails to run	1. The battery runs low. Recharge it before use.
	2. Replace battery for the remote controller (open the cover on back of the handle).
	3. Ensure it isn't being charged (remote control is unavailable when the washer is being charged; if so, unplug and press the power button).
The nozzle can't spray	1. Check if the tank has water.
	2. Replace battery for the handle (open the cover on back of the handle).
	3. The product can spray only while the mopping mode is on.
The mop is heavy	Check if there is enough power.
	It may be caused by excessive water contained in the mop, or the mop wasn't used properly.
	Adopt different cleaning speed as the floor's condition may be. Speed up at relatively clean areas.
It leaves water stain on the floor	1. The mop needn't to be wetted before use.
	2. Excessive water was sprayed.
	3. Use dry mop to clean it.

## Safety Information

### Service Restrictions

- The product is only used for cleaning of the home environment, not the commercial or industrial environment
- Before use, the large particle waste shall be removed. The machine has no functions of sweeping and dust collection
- The machine is not waterproof, shall not be sprayed with water and shall not be used to clean the impounded and sticky floor
- For cleaning of the narrow space, the obstruction or blockage of the moving parts of the machine resulting from the environmental objects shall be avoided. If there is the situation, please shut down the product with the handle for start-up button and then remove the product
- The floor washer shall not be the toy for children
- The appearance of the machine shall be cleaned with the rag during its shutdown mode
- The metal bar shall not be pressed heavily or the product shall not be carried with your arms
- The wooden floor shall be waxed carefully and attention shall be paid to the safety
- The product shall be used in accordance with the instructions of the manual. The users shall bear any losses and damages resulting from improper use

### Battery and Charging

- Third-party battery and charger shall not be used
- The battery and charger shall not be dismantled, repaired or refitted personally
- The charger shall not be close to the heat generating device (such as the heating radiator)
- The charger shall not be wiped or cleaned with the wet cloth or hands
- The wasted battery shall not be discarded carelessly and shall be submitted to the professional recovering bodies for disposal
- If the power line of the charger is broken or fractured, please stop using the charger immediately and contact the customer service timely or replace it in the nearby maintenance shop
- If the product is needed to be transported, please ensure that the machine is in shutdown mode and it's suggested that the machine be packed with the original box
- If the machine is not used for a long time, please charge it fully and shut it down. It shall be placed in a cool dry place and be charged once every three months to avoid the over-discharge of the battery

2. If there are performance faults listed in Product Performance Faults Table occurred in the product within 8 to 15 days from the date of lodgment which are detected and confirmed by our Company's after-sales service center, you can enjoy free maintenance service
