


In-car wireless charger

Please read this manual before using and keep it for future reference.





PRODUCT FEATURES

1. Single hand operation, easy to install and remove.
2. Gravity clamp.
3. Smart lock & release.
4. 360 degree rotation, support different viewing angles, do not block the line of sight, safe driving.



HOW TO USE

1. Fit the outlet stand to the wireless charger device.
2. Attach car mount on an appropriate place inside the vehicle.
3. Put your device on the holder and it will be automatic lock the device.
4. Adjust the Angle or rotation according to your needs.
5. Connect the cable to the base socket and the other end to the in-car charger.

NOTES

1. Do not squeeze or collisions.
2. Do not disassemble or throw into fire or water, to avoid causing a short circuit leakage.
3. Do not use wireless charger in severely hot, humid or corrosive environments, to avoid circuit damage and occurs leakage phenomenon.
4. Do not close with magnetic stripe or chip card (ID card, bank cards, etc) to avoid magnetic failure.
5. To take care of the children, to ensure that they won't play the wireless charger as a toy, to avoid unnecessary accidents.
