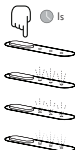
QUICK START GUIDE

CARRY

Wireless Charging Power Bank

Power On

Press and hold the button for 1 second
to power on your CARRY.



Initial press indicates charge level

Light flashes twice

Breathing light indicates searching

Charge Wirelessly

Place your wireless charging device
on the CARRY to charge.

*Note: Improper alignment may impact connection.
You may also charge your device using a USB-C cable.*



Full battery

Medium battery

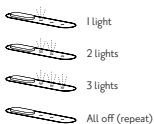
Low battery

Constant light with corresponding charge indication
(Ex. 3 steady lights – charging with full battery)

Re-Charge, Wirelessly

Place your CARRY on a compatible wireless charger to re-charge.

*Note: All Courant charging trays are compatible. CATCH:I shown below.
You may also re-charge your CARRY using the provided USB-A to USB-C cable.*



Wireless In, Wireless Out

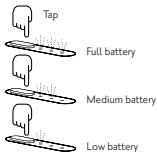
Your CARRY can charge a device and be re-charged wirelessly, at the same time.

Note: Charging speeds may be affected.



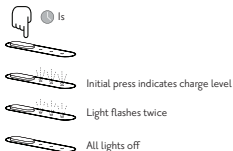
Battery Check

Tap button to check battery level.



Power Off

Press and hold the button for 1 second

USB-C Input & Output

CARRY is compatible with USB-C, allowing you to charge both in & out at 18W Power Delivery.

Note: only "USB-C to USB-A" cable included in the box.



Power for Two

One via wireless, one via USB-C.

Note: only "USB-C to USB-A" cable included in the box.
