Plug In.

Charge Wirelessly and Organize.

Magnetically snap on your MagSafe compatible iPhone on the left of the charging section, and place your Qi-compatible AirPods on the right.

Use the catch-all section on the right to organize your accessories

Note: Improper alignment may impact connection.
