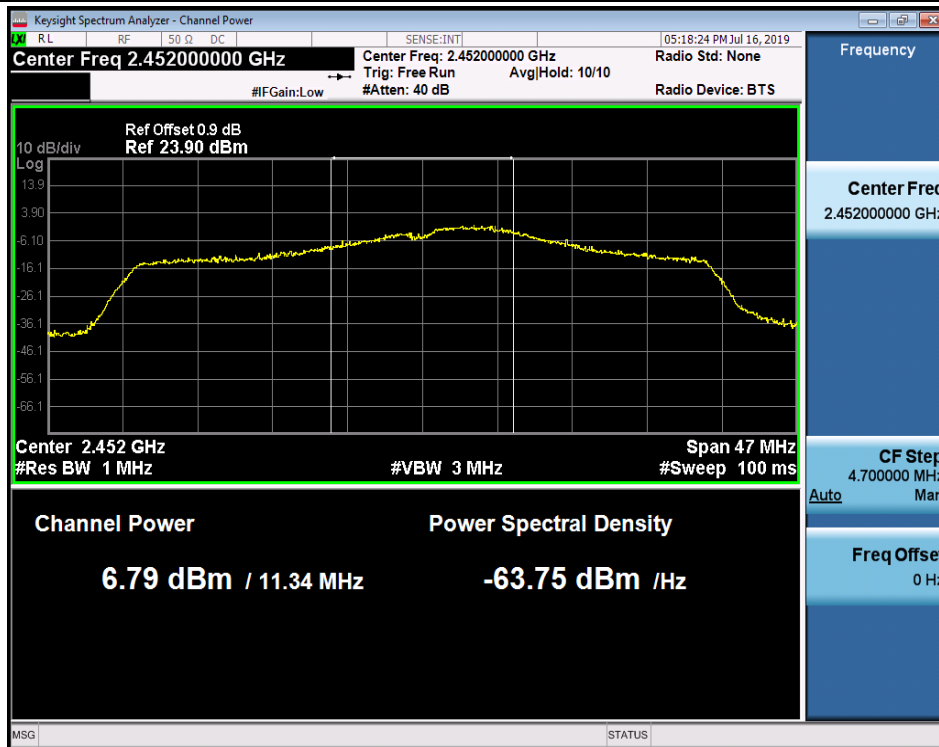
Maximum peak conducted output power_11N40SISO_2422_Ant1

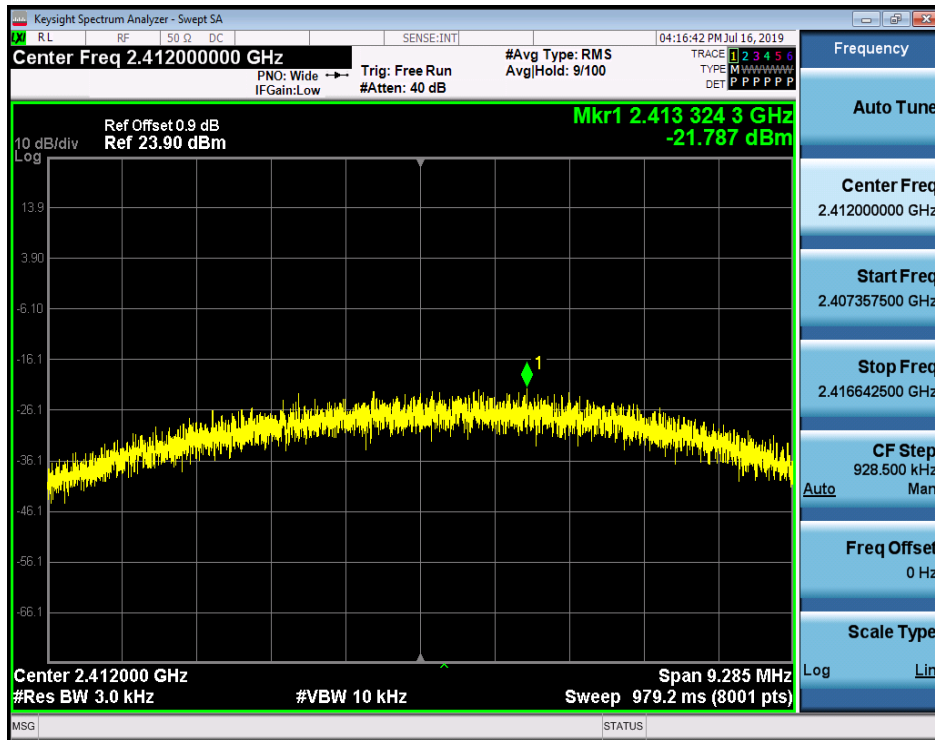

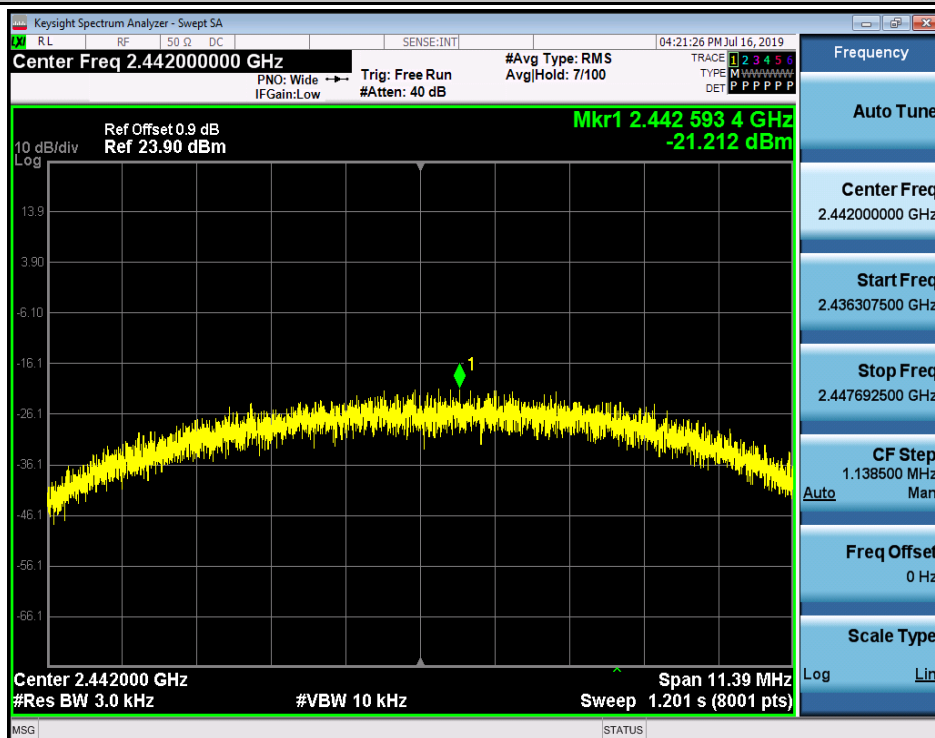

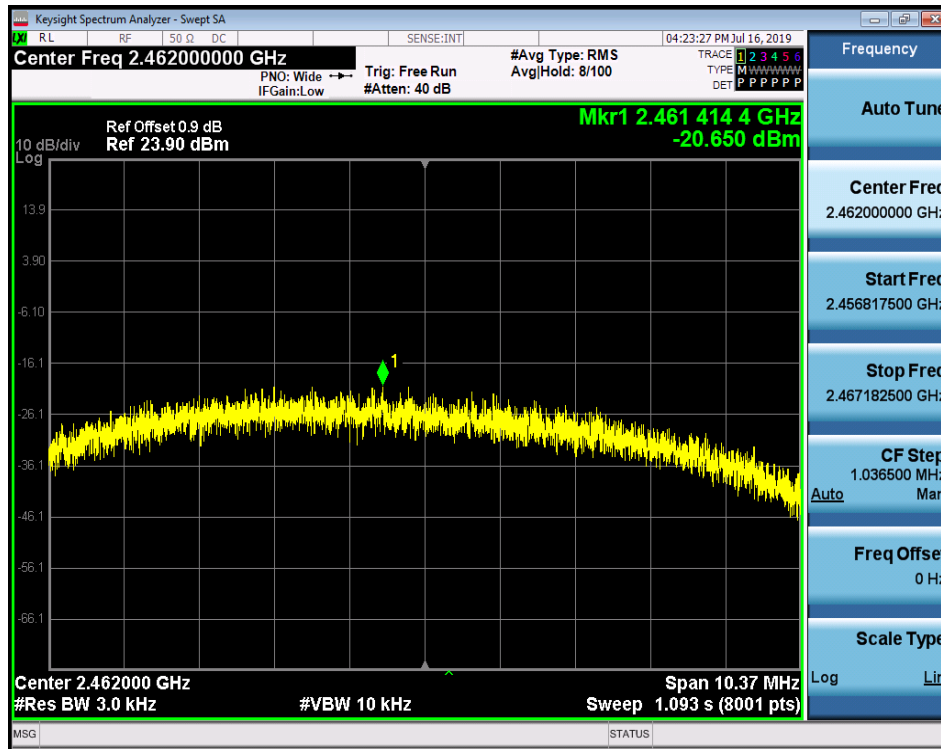
Maximum Peak power spectral density_11B_2412_Ant1



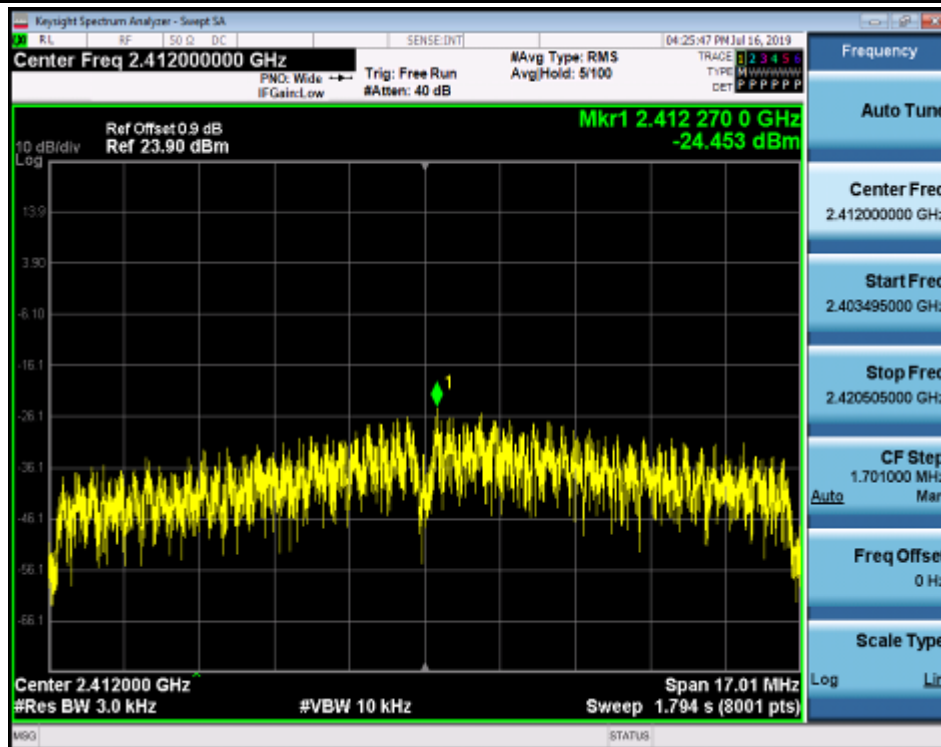
Maximum Peak power spectral density_11B_2442_Ant1

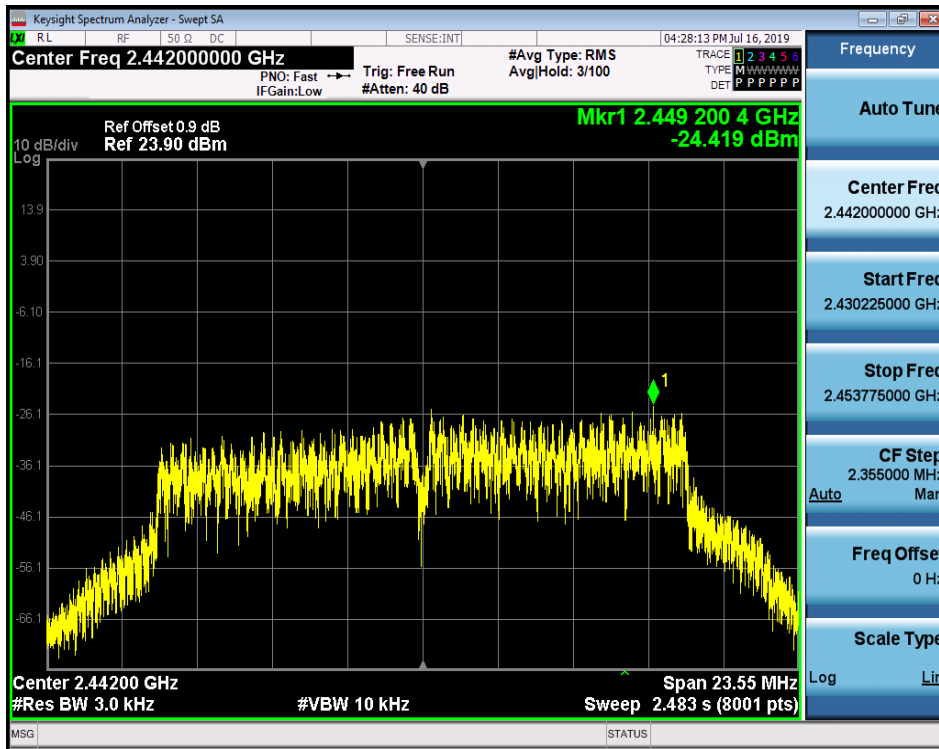

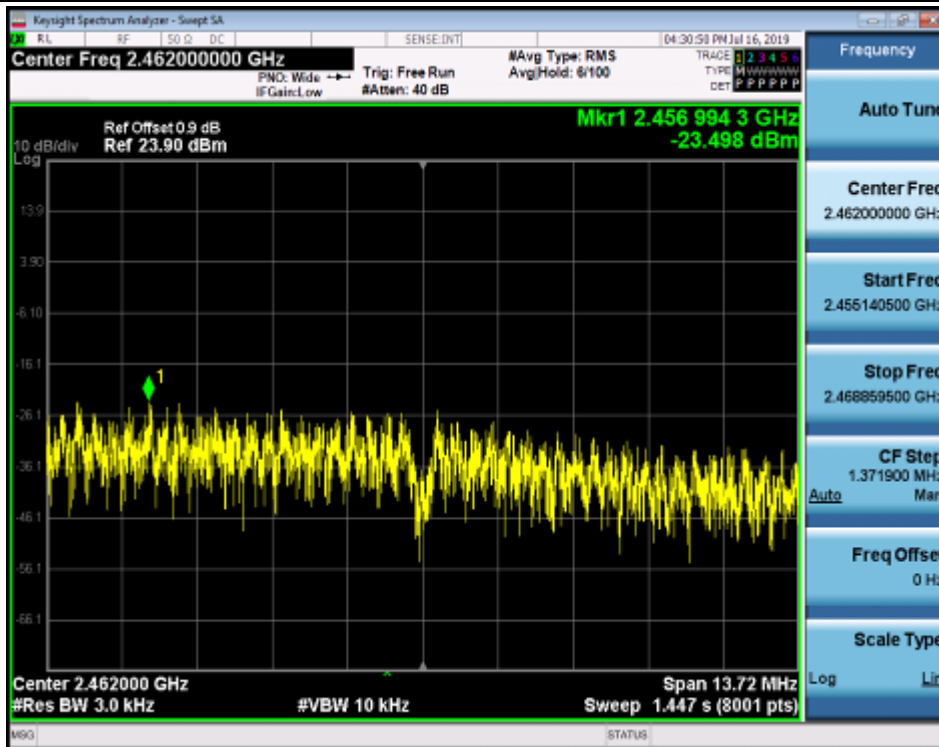

Maximum Peak power spectral density_11G_2442_Ant1



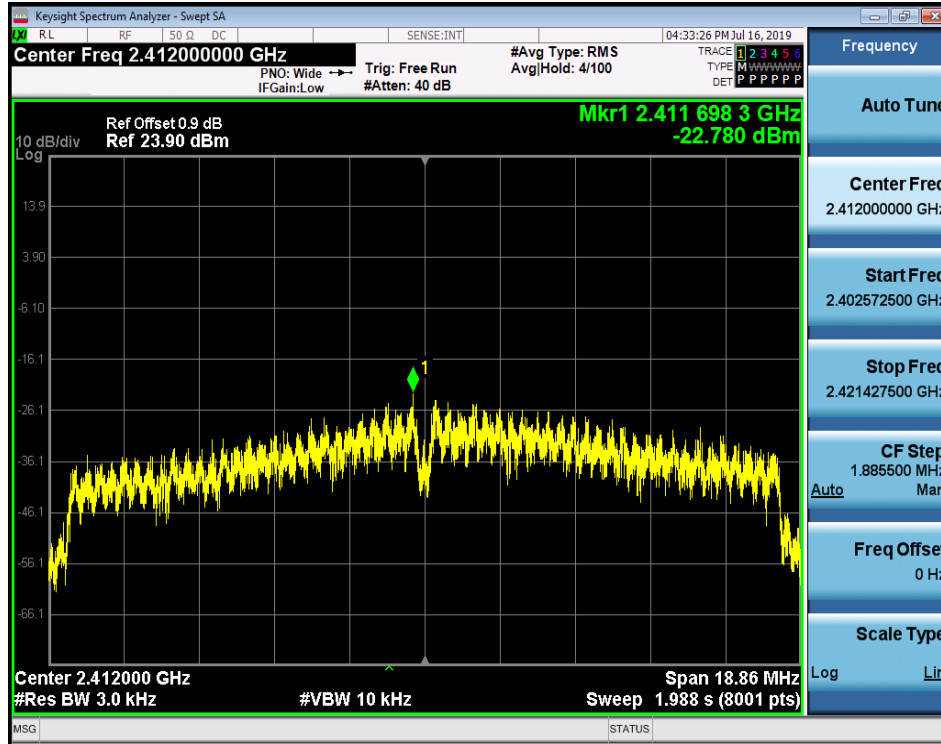

Maximum Peak power spectral density_11N20SISO_2462_Ant1



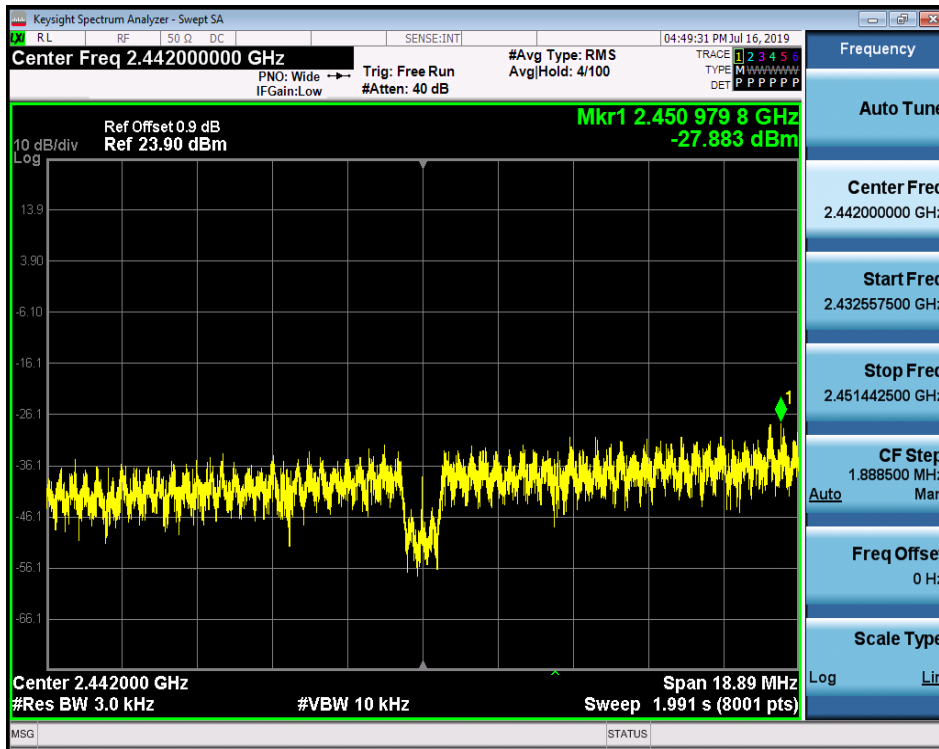
Maximum Peak power spectral density_11N40SISO_2422_Ant1



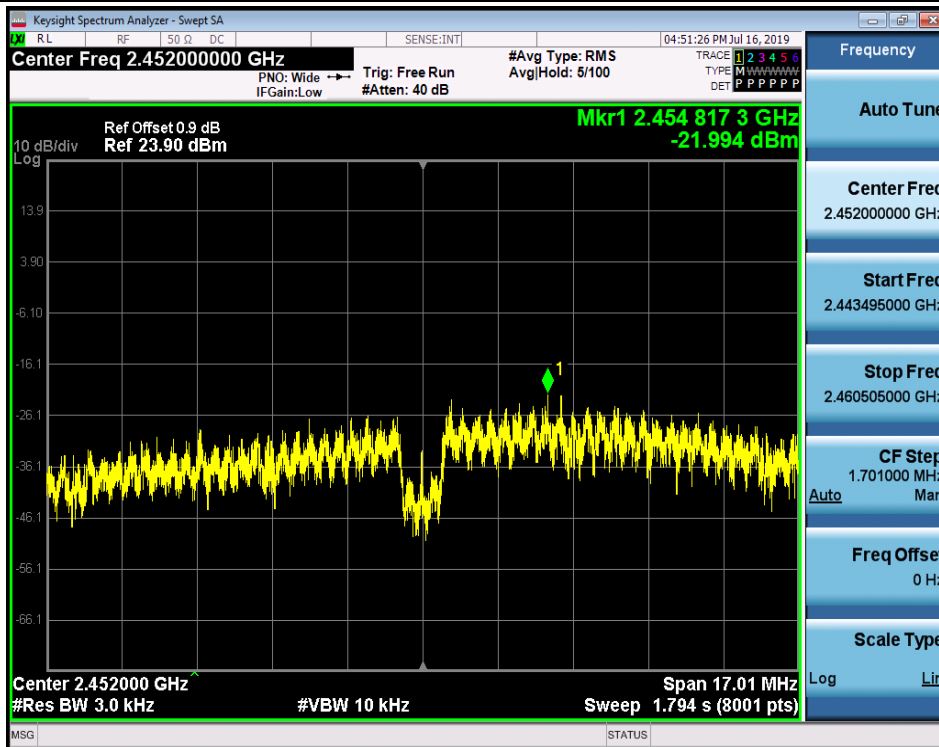

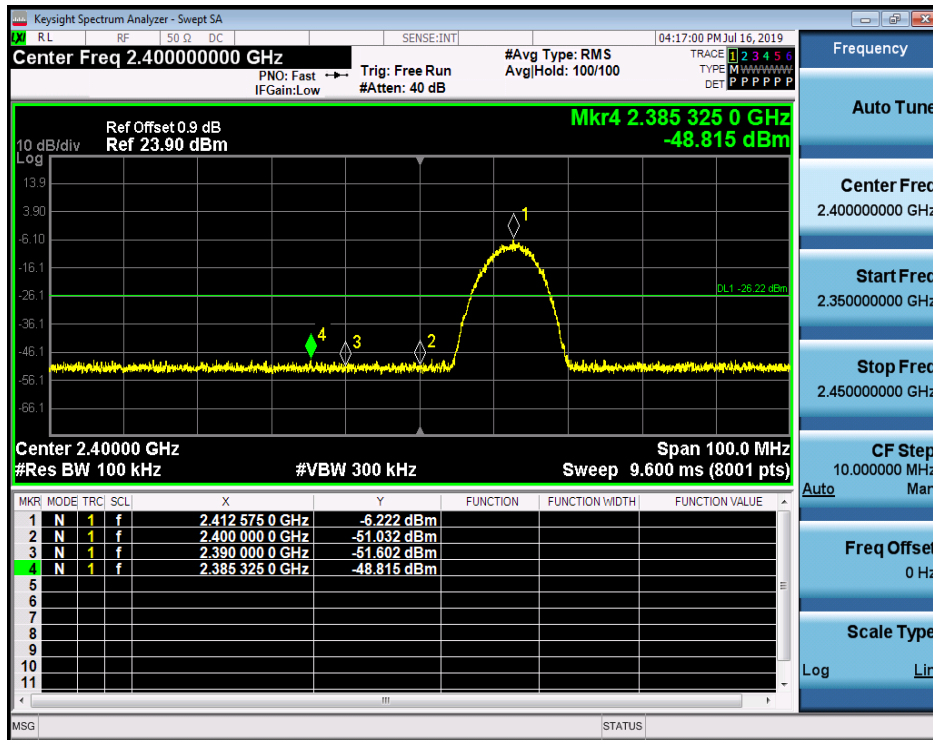

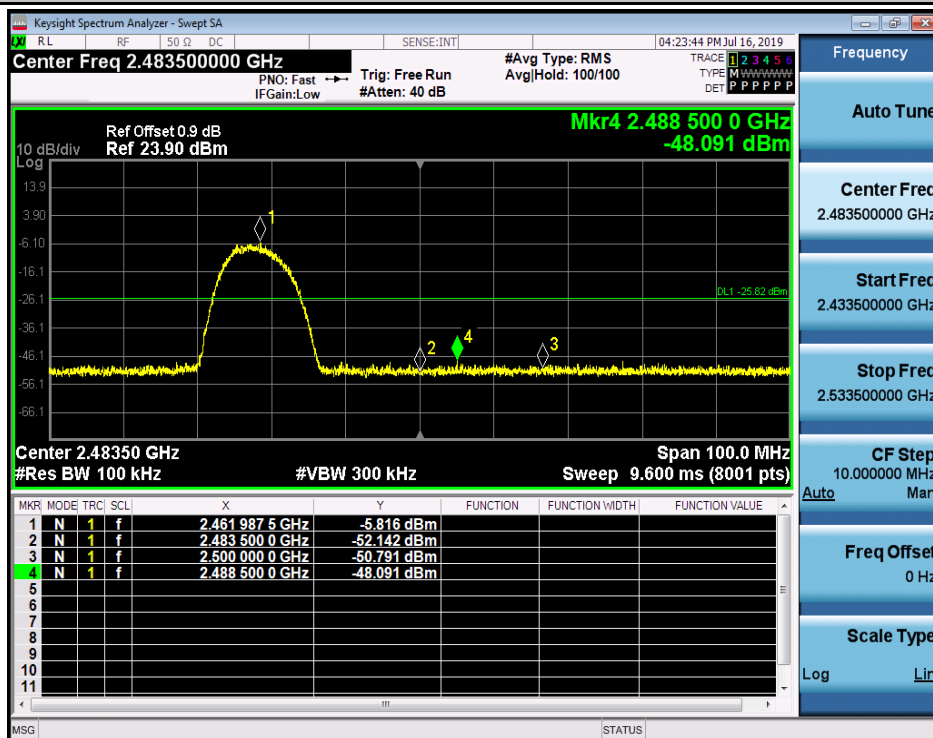

Band-edge for RF Conducted Emissions_11B_2412_Ant1



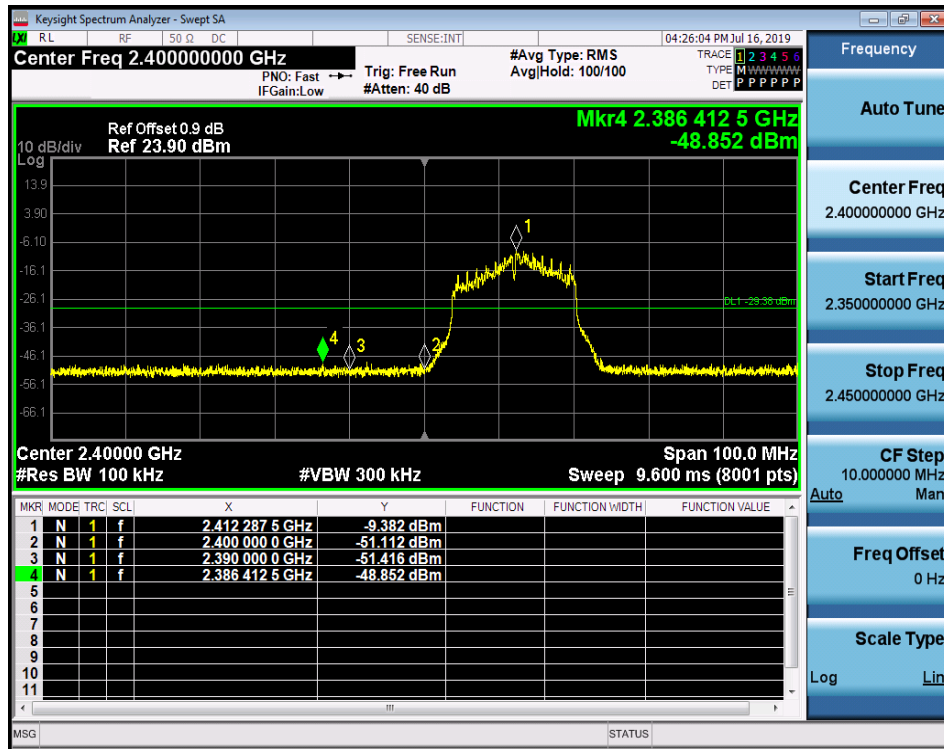
