### **2. Name and Function of each Part**

#### 1. Connector

Connecting 1-1 and 1-2, you can extend the ground.

#### 2. LED Indicator

According to white LED pattern, you can confirm its state.

Hold mode | LED Off

Charging mode | LED On in case of normal charging

Module connection | LED flickers once.

Movement error | LED flickers at the interval of 1 seconds.

#### 3. Micro 5pin Jack

If you want to use a high-speed charge function, please use a quick charging adapter.

## **4. Precautions for the safety of use**

◦Please read all the following contents for the safe use.

Please use it only with its designated power.

For strange noise, smoke, smell, damage, etc, please unplug it immediately and ask for its purchaser and service center.

Don't let it be exposed to rain or humidity.

Don't install it near a heat source such as radiator, heater and stove.

Don't throw it in the fire nor give it a strong impact.

Don't disassemble, repair or remodel it in person as it has a risk of fire and electric shock.

Don't touch it with a wet hand for the electric shock.

Put it out of children's reach.

Don't insert the conductive thing in the product.

Don't use the magnetic part of charger for the other use beside its attachment between chargers.

Don't put it in a place with a direct light or a enclosed place with high temperature, but inside well-ventilated.

If the user transformed the product provisionally, it shall be excluded from its free repair service.

If some foreign substance is applied on the product, don't use chemical products(such as alcohol and benzene) but clean it with soft cloth.

Don't put any metal substance(such as coin and key) on the charger.

Only when the product to charge and the center of charger is well arranged, it could make the maximum charging efficiency.

In a silent environment, the bell sound of charger can be sound to the minimum, and this is not the failure.

## 5. Q & A

Q. Does it provide a high-speed charging?

A. Both iPhone(7.5w) and Android phone(10w) provide a high-speed charging function. Before use, verify if the adapter has Qualcomm Quick Charger 2.0 and more and AFC indicated. Specially, multiport multiple adapter and Apple's bundle adapter has its speed a little slow.

Q. I'm worried of its heating problem.

A. MOBILE ISLAND has a heating safety design. If the charger temperature is more 60° C, OTP function(Over Temperature Protection) interrupts the power temporarily and protects the user.

Q. How many grounds can be attached?

A. MOBILE ISLAND can use 3 with 1 base ground and 2 grounds at a high-speed charging. Being possible to attach more, its efficiency can be lowered or it cannot be charged. Therefore, it is recommended to use until 3.

Q. The wireless charging is not possible.

A. Please check if the type of smart phone provides a wireless charging function.

If the smart phone provides a wireless charging

- 1) Eliminate the metal and magnetic object behind the smart phone.
- 2) If it persists not to be charged, turn the smart phone and wireless charger off and on.

## 6. Provision of guarantee

◦This product guarantees the followings.

This product was manufactured through a strict quality management and inspection.

In case of requesting A/S, please present its guarantee. If not presenting the guarantee, the free repair cannot be provided.

The guarantee shall not be reissued, so please keep it valuably.

When the product produces a failure, please consult to its selling shop or service center.

### 1. Free Repair

This product can be freely repaired for 5 months. The manufacturing defect or failure generated during its normal use can be freely repaired during the term of guarantee from its purchase date. Within the term of guarantee, if the product was provisionally disassembled or failed by consumer's mistake, it shall be repaired with payment.

### 2. Exchange of Defective Product

In case that the product is initially defective, take it with its receipt to its selling shop within 7 days from its reception date for its exchange. If you lost the receipt or its product value was

damaged by opening it, it may not be exchanged and returned in 7 days, and in this case, it shall be repaired with product A/S according to the A/S rule of this company.

Requesting A/S, please send it through the designated delivery company, and the parcial service on delivery shall not be received but returned. Sending the product by the other mean not the designated delivery company, the client shall be responsible of its cost. After receiving the product defect notification, its own test shall be made, and if having no defect, it shall be returned by the parcial service cost on delivery, so please confirm it before requesting the repair.
