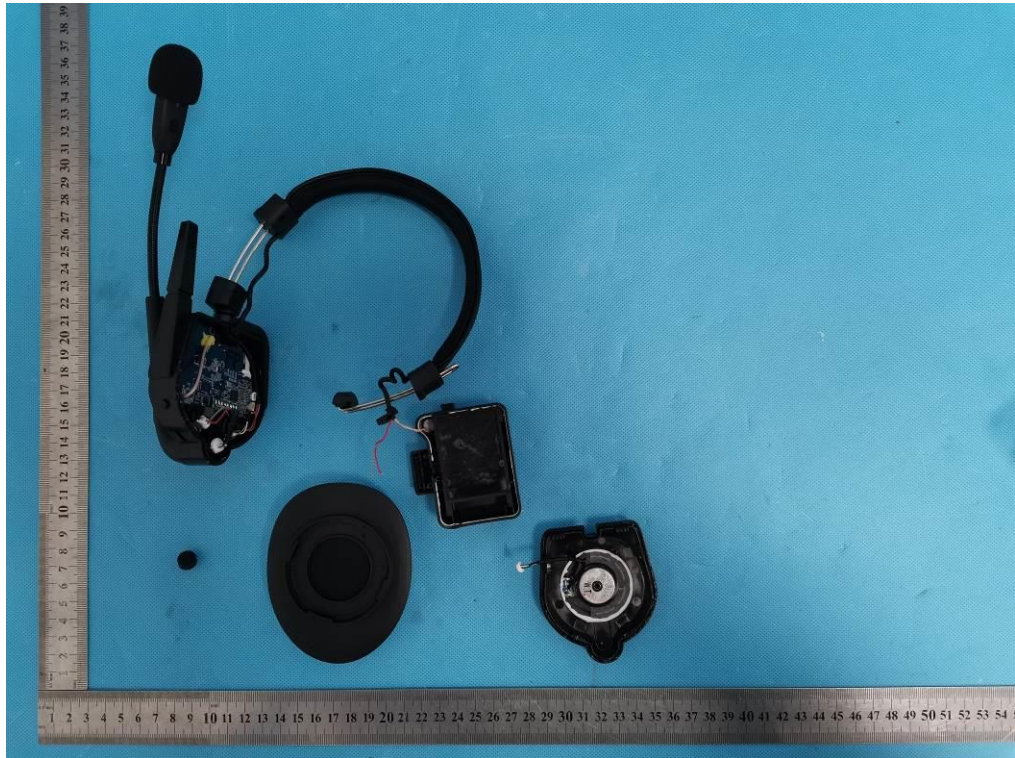

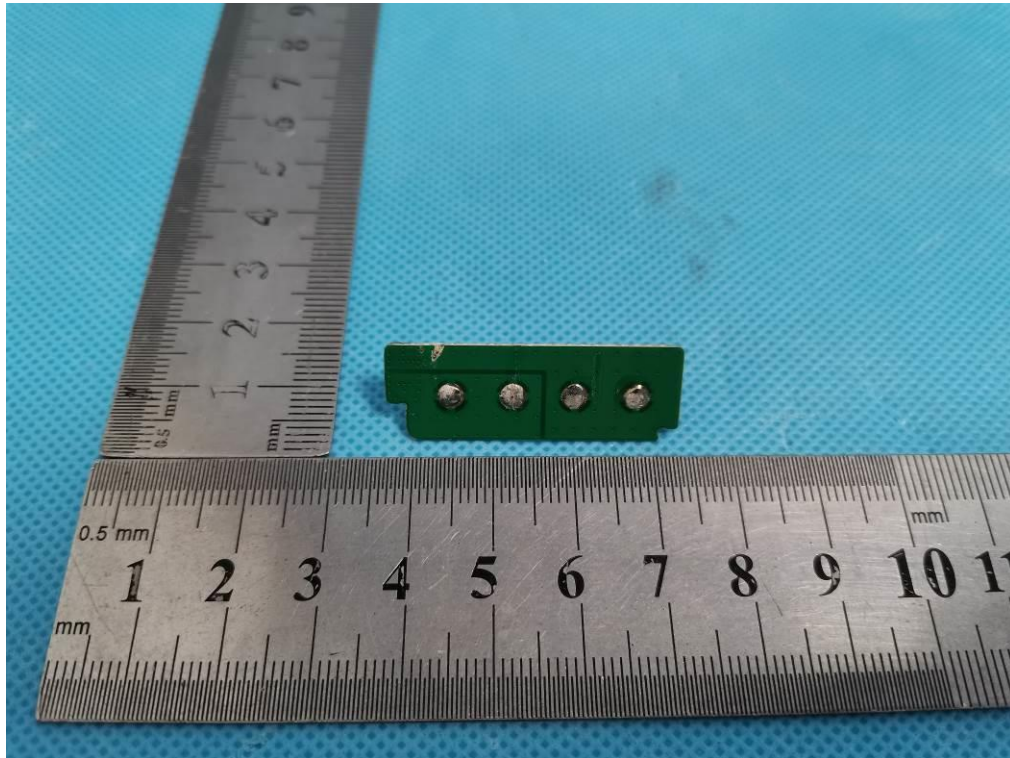

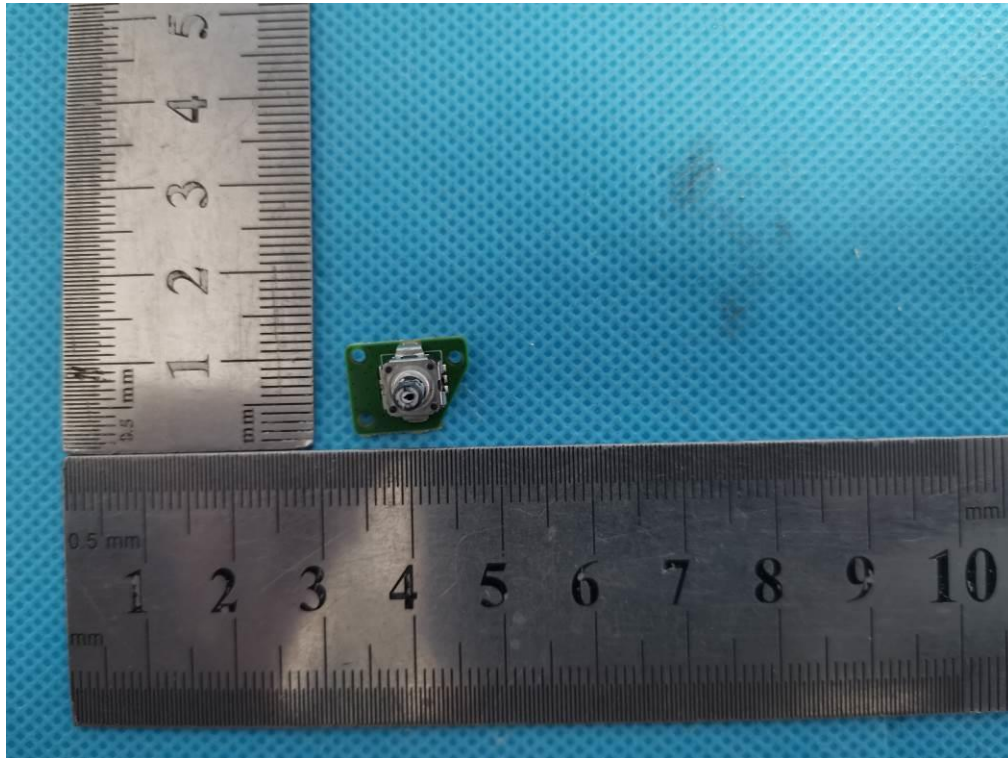

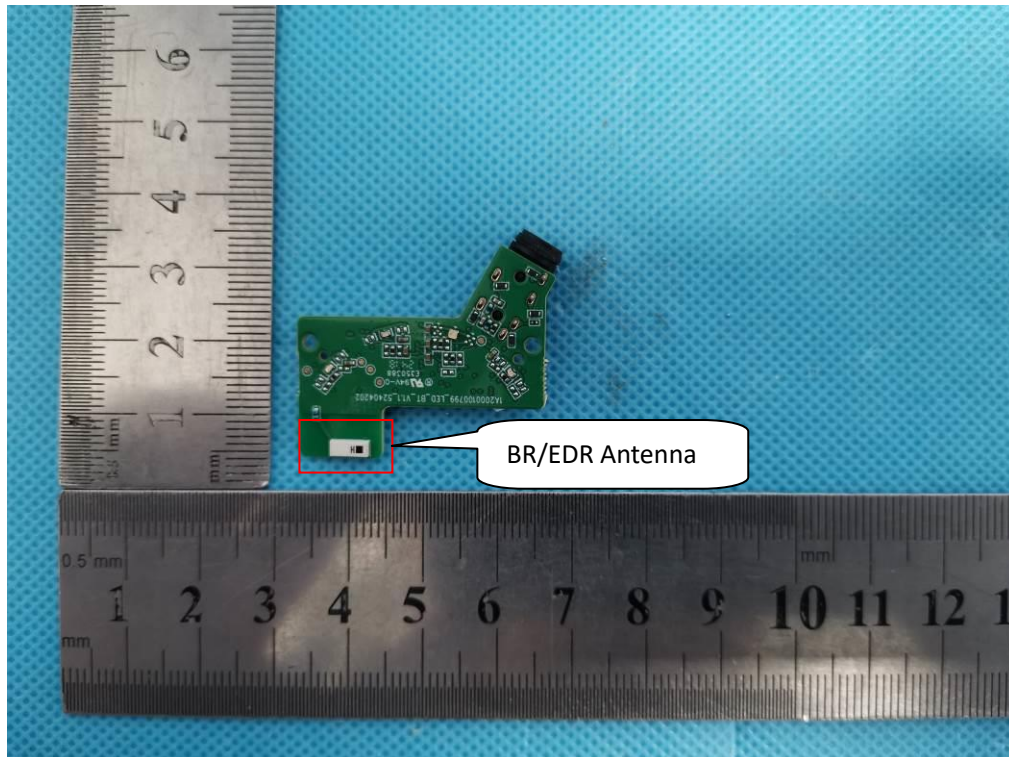

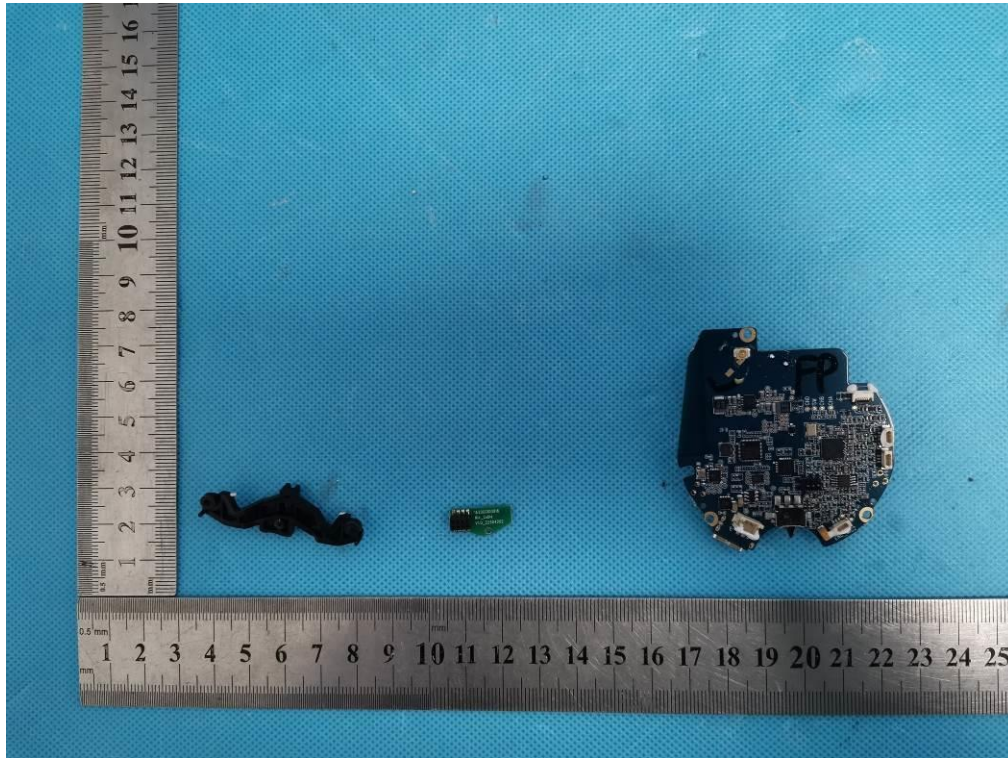

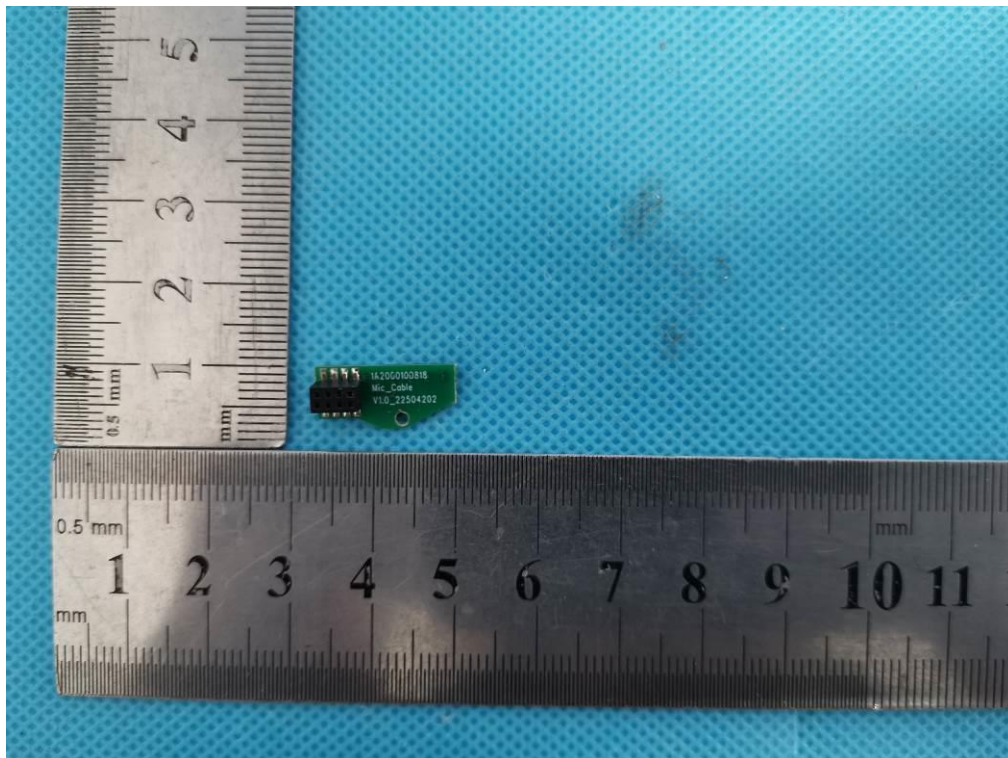

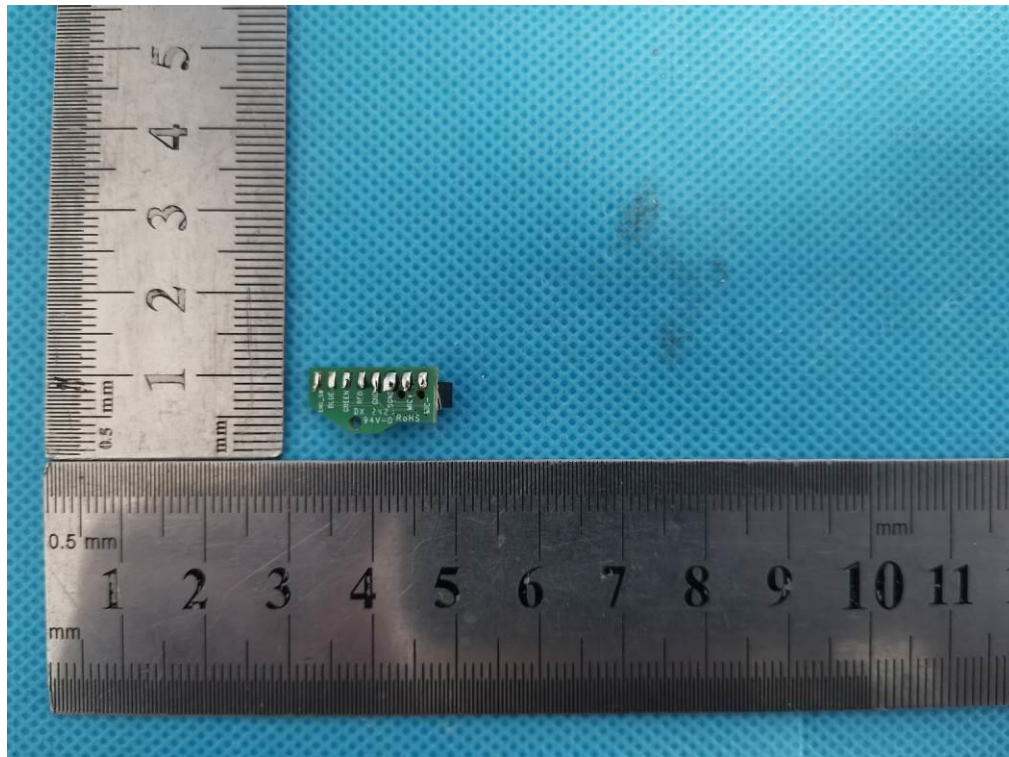

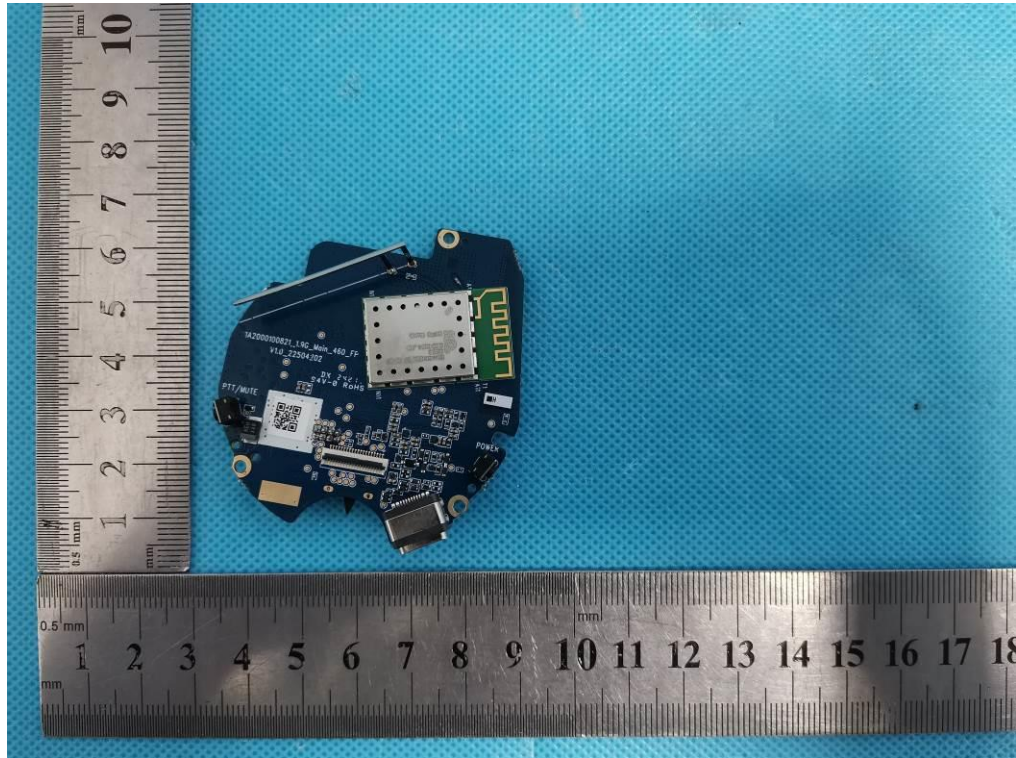

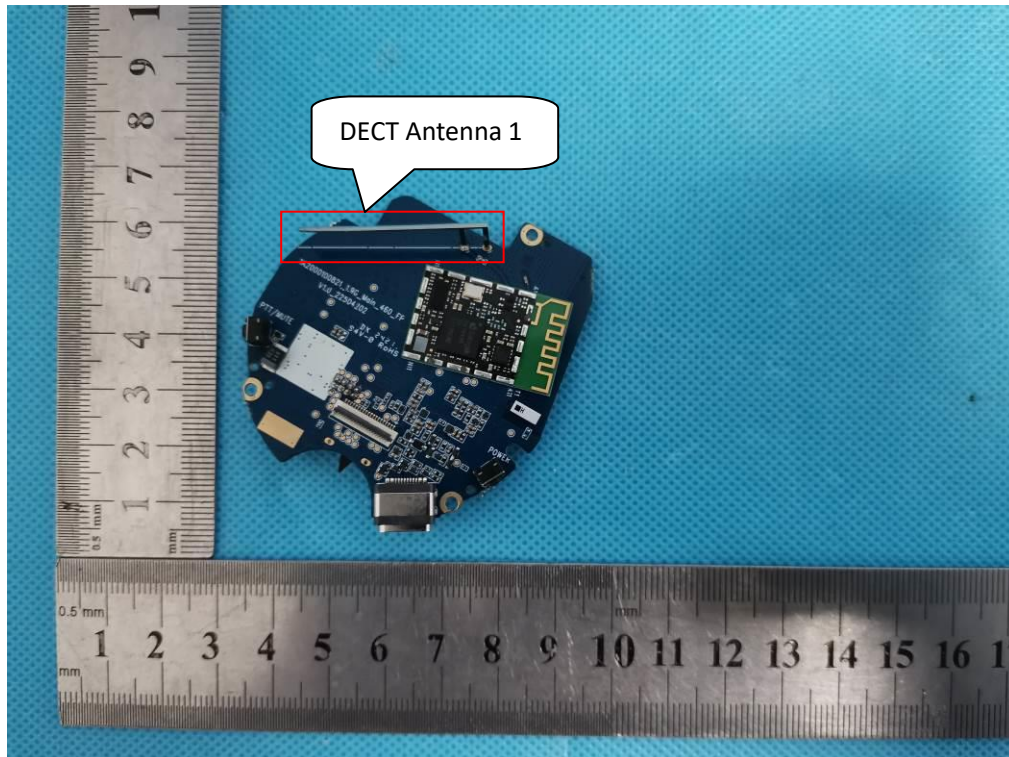


INTERNAL VIEW OF EUT (FIGURE 13)

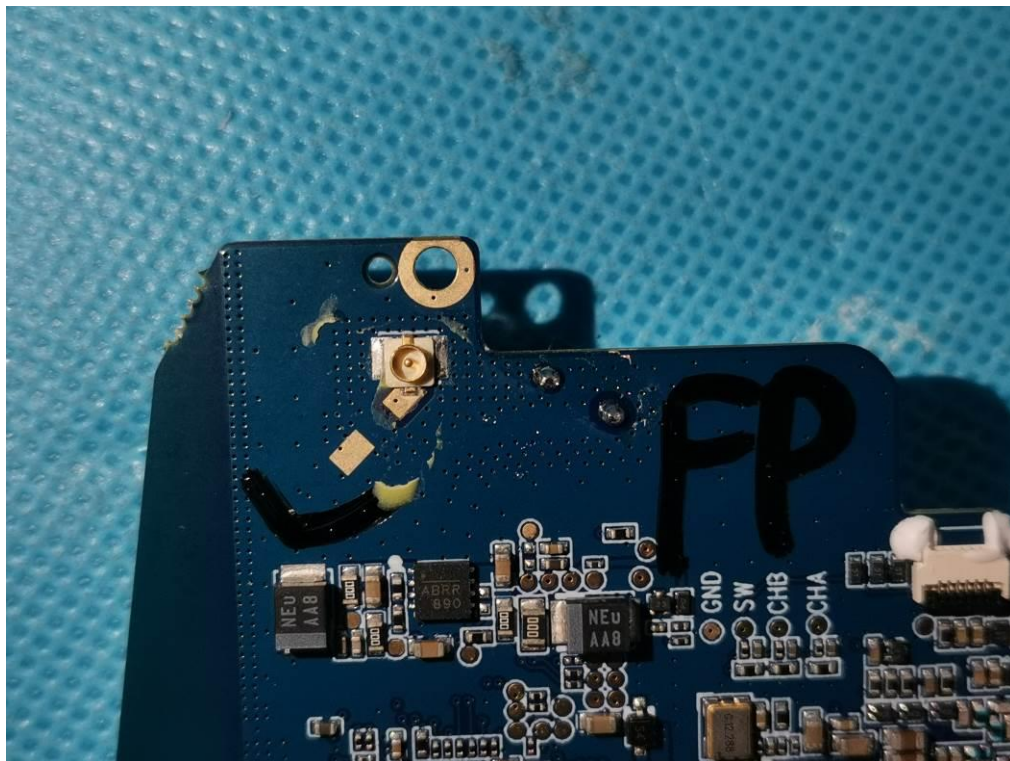

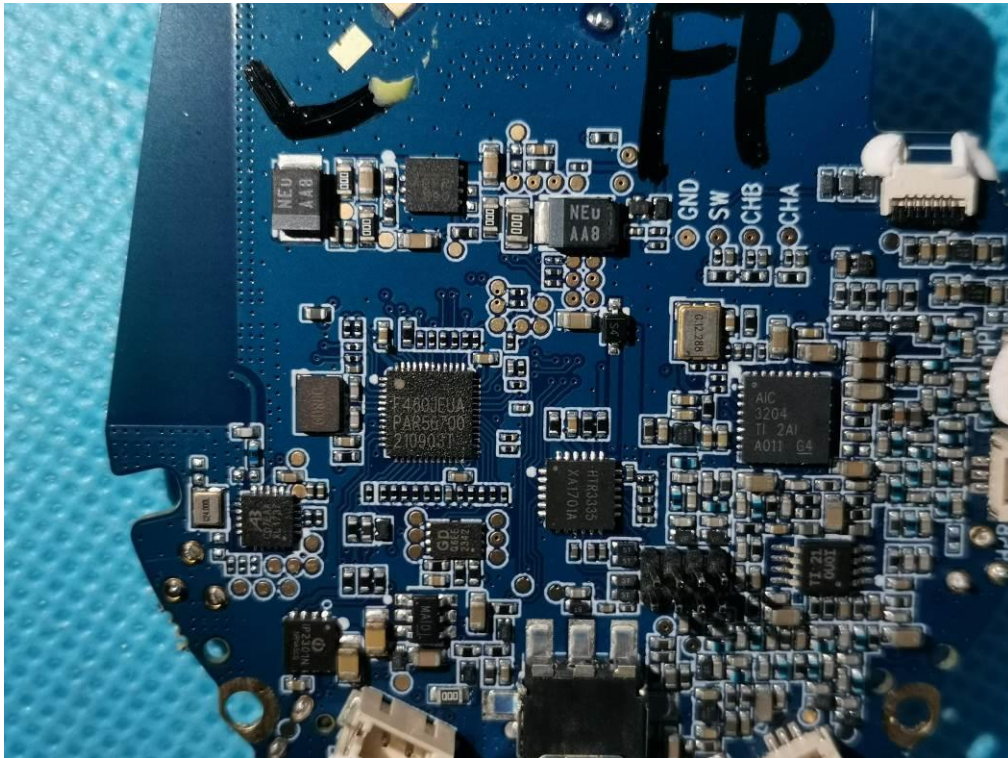


INTERNAL VIEW OF EUT (FIGURE 15)

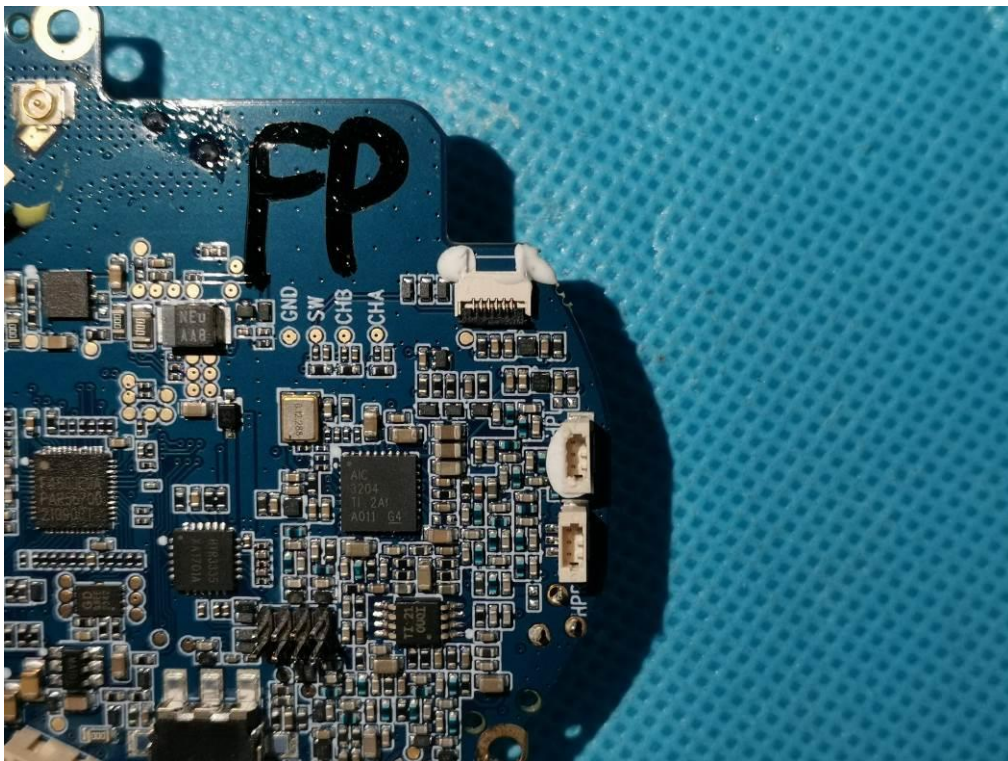

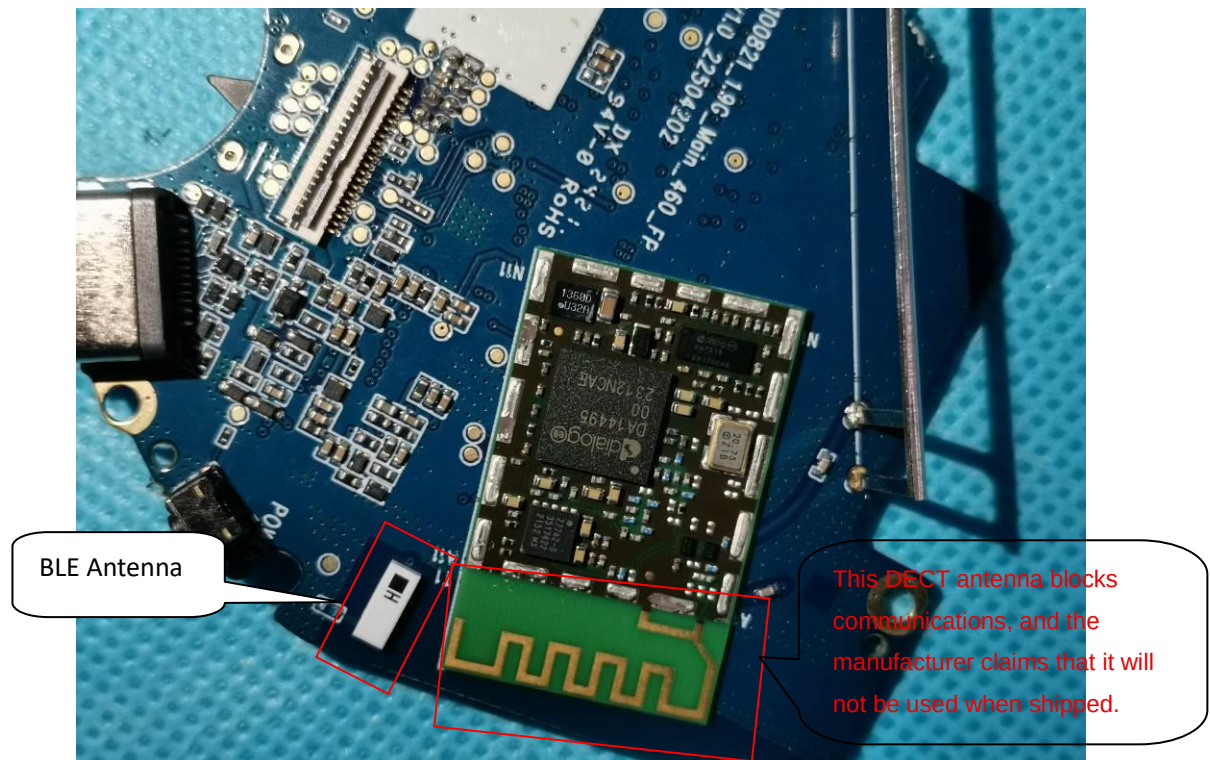

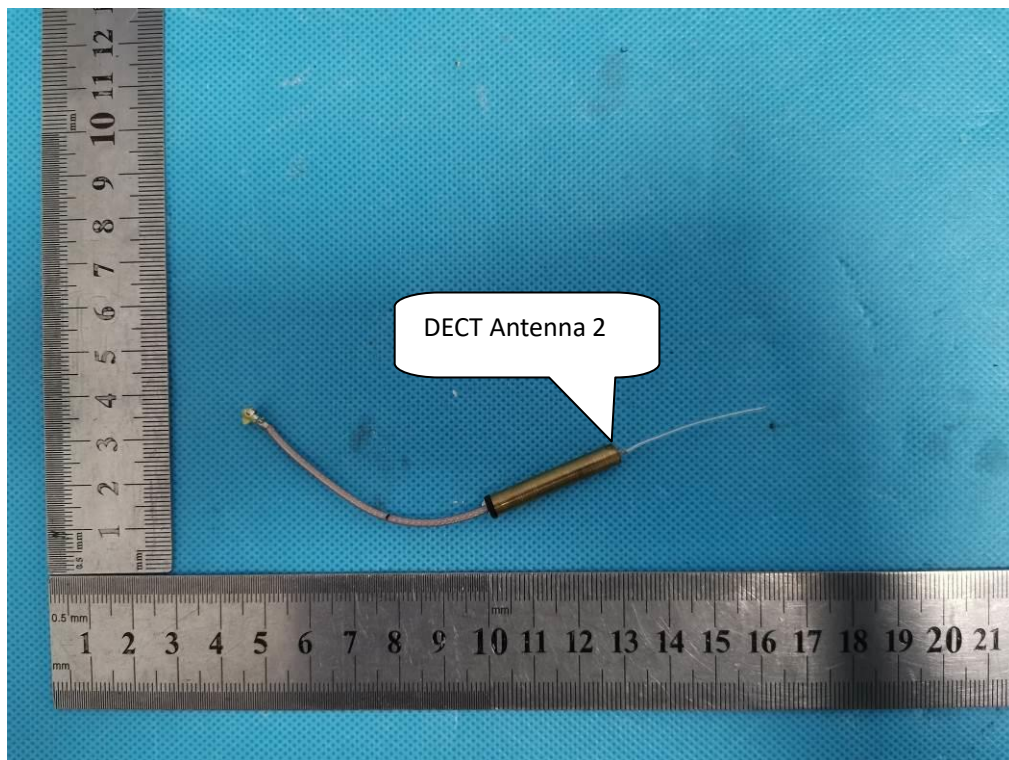
