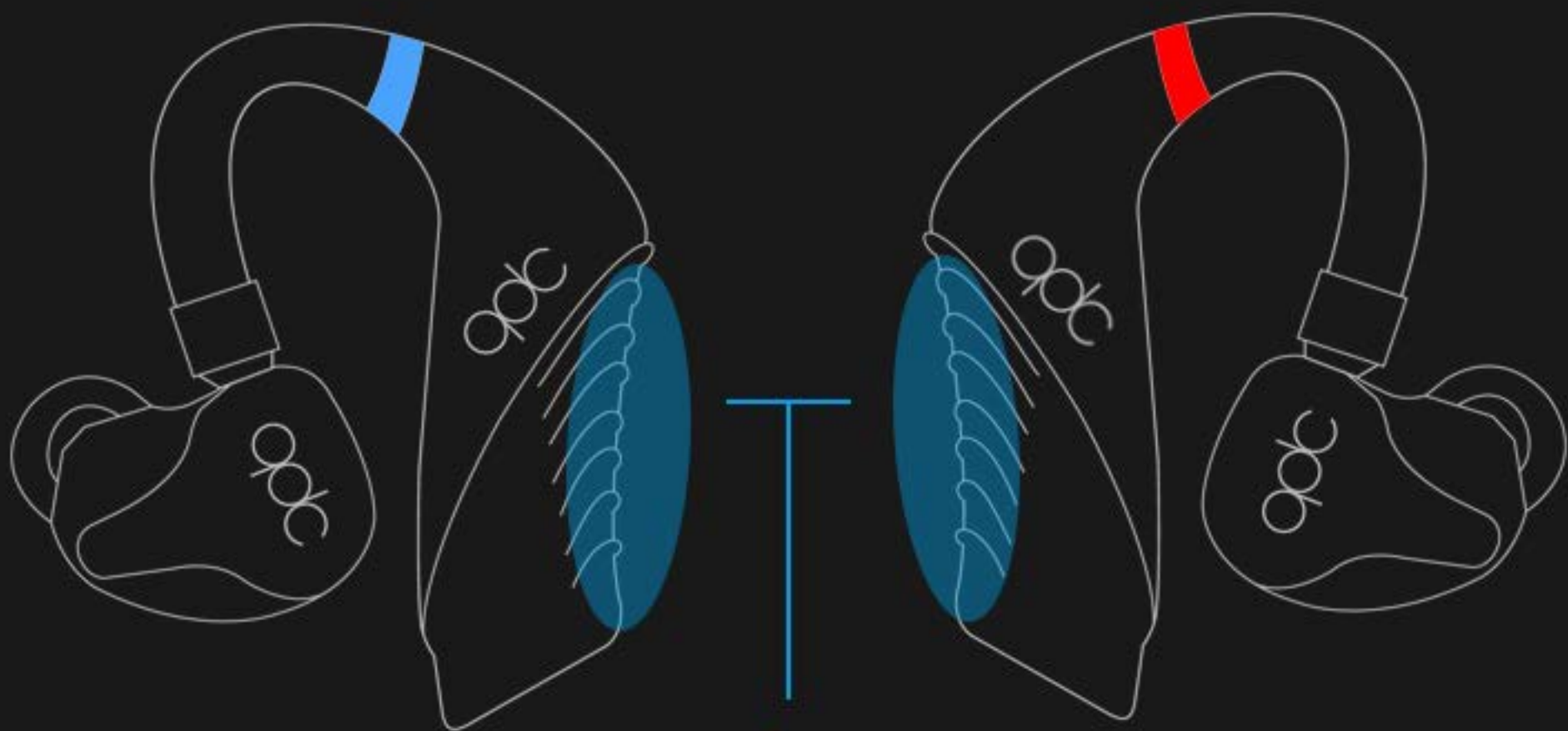

Function and operation

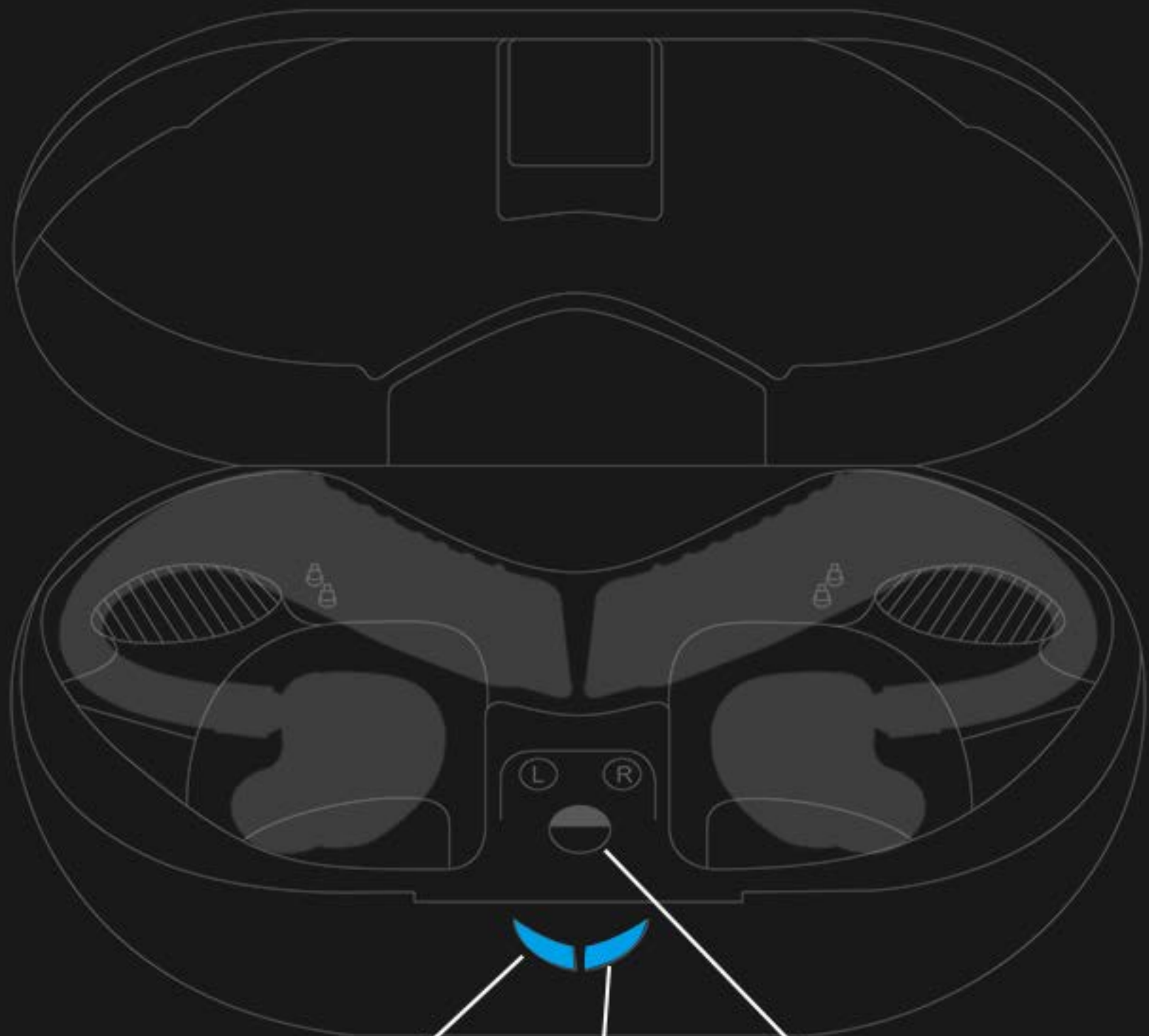

Touch area

Play, Pause Answer, Hang up	L or R single click
Refuse the call Next song (R) Previous song (L)	L or R double clicks
Voice assistant	R three clicks
Volume +	R Long press and hold
Volume -	L long press and hold
Power on	Open the charging box and automatically start up, under no connection state automatically enter the pairing mode, and automatically looking for the last connected device in the connection range
Power off	Put in charging box and close the cover of the charging box will switch off automatically, and shut down automatically without connecting any equipment or without load for 3 minutes
Pairing mode	No connected device when opens the charging box and automatically enter the pairing mode or long press the key of the charging box for more than 5 seconds to enter the pairing mode
Three mode switch	L three clicks Music mode "Ding" one sound Transparent mode "Ding, Ding" two sound, Game mode "Ding, Ding, Ding" three sound

Close the charging box, and the corresponding left and right lights will flash to indicate charging

Working mode

Music mode:

Support aptx protocol, so as to listen to higher quality music and feel more details brought by lossless music.

Transparent mode:

Monitor the external environment sound in real time and there has a sensitivity slider inside which can adjust the external volume independently.

Game mode:

Support low delay transmission and achieve sound and picture synchronously, so that the game has enough immersive feeling and is like being there.

EQ settings

10 EQ adjustment:

Support custom settings and a variety of presets to make the sound more personalized and controllable.
