



## CHANGE PATTERN:

1. Hold "play" on heart 3s to place into standby mode.
2. Hold "play" on the remote for 3s to turn on, then press "wavy" to switch patterns.
3. To pause vibration, hold for 3s "play". Within 20 minutes the remote can directly reactive the heart. After 20 minutes the device will be switched off. Repeat above to restart.
4. The heart can be independently controlled. After holding the "play" button for 3s, press again to switch modes. Hold for 3s to switch off.
