Pursuant to 47 CFR Sections 0.457 and 0.459 of the commission's rules, the applicant, CMR Surgical, hereby requests confidential treatment of the documents listed below, associated with the certification application referenced above:

- Internal Photographs

The materials above contain information that is not released to the public. The public disclosure of this information may be harmful to the business of the applicant and provide unjustified benefits to its competitors. The device meets the special conditions laid down in KDB 726920 D01 v01r02, clause II.3)a)+b) for Long-Term Confidentiality of Internal Photos and User Manual, which we hereby request. The circuit board and internal components are not accessible to end users, since the device is only to be used and serviced by CMR Surgical. The device is not accessible to the public, since the device is for installation solely into CMR Surgical's end products. The manual contains proprietary technical information intended for

professional technicians of CMR Surgical only. The device and user manual is not for sale and is for internal use only.

The radio module is installed into the Versius Surgical system by CMR surgical or trained service engineers only. The radio module with FCC ID: 2ASDBMA-0382 is not sold to the public. Access to internal PCBs and circuitry is achieved by specialised tooling.

TE-00001 is CMR Surgical's standard NDA that is in place with customers and third-party distributors before any confidential CMR Surgical product related information is exchanged. All sales and third-party sales are covered under such a confidentiality agreement.

An extract from TE-00001 for a definition of "Confidential information" under NDA control;
