What is OKU?

OKU is Your Personal Skin Coach – a skin scanning device & iPhone app – designed to help you achieve your best skin.



Analyze the health of your skin so you can see its moisture levels, oiliness, pigmentation, firmness, and texture.



Get personalized advice tailored just for you – which skincare products to use, which ones are working, new regimens to try.



Set goals and track progress – Get a personalized SkinScore with every scan.



Access a community – get connected with others with skin like yours and see what works for them!

How it Works

Your SkinScore™

We created OKU after years of research by our team of dermatologists, plastic surgeons, nanotechologists, scientists and engineers.

Using dermoscopy and spectroscopy, OKU is able to scan beneath the surface of your skin to show it's moisture levels, oil levels, firmness, texture & pigmentation. OKU analyzes the structure of your skin, and lets you see real-time images of your skin's activity, including active oil glands, uneven pigmentation, and texture including fine lines and wrinkles. OKU analyzes your skin's health along these key dimensions to provide a SkinScore and detailed analysis. It's like having a lens into what's really happening underneath your skin!

OKU measures over 29 surface and subsurface characteristics of your skin to derive your SkinScore™. Your SkinScore is a numerical value from 1-100.

Your SkinScore™ is comprised of 5 different areas of your skin:

- Moisture levels
- Oiliness
- Firmness
- Pigmentation
- Texture

Your SkinScore™ may change from day to day, depending on the condition of your skin.

OKU is an independent, unbiased platform that provides skincare advice tailored to you. We offer product recommendations across all brands, be it drugstore brands or department store brands. Your customized advice and product recommendations are based on your personal skin scans, and what is working best for your SkinTwins, others with skin just like yours.

Get matched with SkinTwins™

Access a community of your SkinTwins™ – others with skin just like yours. OKU automatically matches you with your SkinTwins, so that any advice you receive are relevant to your type of skin.

Compatibility:

The OKU App is current available only on iPhones. Nearly all iPhone models can be with OKU. OKU is a separate device (sleek white cube!) and does not need to be connected directly to your iPhone to work.

Set up your OKU

This current version of OKU is compatible with a 2.4GHz network only. If you are not on a 2.4GHz network, your OKU App will let you know. Most likely, you have a dual-band router and will need to switch to the 2.4GHz network.

If your phone is not on a 2.4 GHz network, you most likely have a dual-band router (like many of us!) A dual-band router means that you can access both a 2.4GHz network AND a 5.0GHz network. You simply need to select the 2.4GHz network. To do so:

- Go to Settings on your iPhone.
- Tap on WiFi to see a list of all WiFi networks.
- Select the 2.4GHz network. In dual-band routers, the 2.4GHz network and 5.0GHz network will often have similar names (for instance, they might be named “Jones Family WiFi” and “Jones Family WiFi-5G”) Select the 2.4GHz network (In this example, it would be the “Jones Family WiFi”) If the network names are not clearly labeled, try both to see which works. It should only take a few seconds.

Understanding the LED light button on OKU:

Color of square LED button	What it means
glows RED	OKU does not have enough charge and needs to be put back into the base for charging.
glows BLUE	OKU has enough charge to do scans.
glows YELLOW	OKU is in the process of taking images/scanning.
stays solid BLUE	The app has established a stable WiFi connection between your iPhone and OKU.
does not glow	It means OKU has powered off to conserve power. To check status of OKU simply put OKU back into the base or power it on to check the LED button and determine status.

Please Note:

OKU automatically stops glowing 5 minutes after any activity, whether it is in the base or outside, to conserve battery power. Make sure you turn OKU back on before trying to scan. While scanning, do NOT place OKU back in base.

After using, place OKU back in the base to charge when not in use.

- After using it, put it on the OKU base for charging.
- Clean it only with fiber cloth

Troubleshooting OKU system

In case of any device issues, restart your OKU device by pressing device button for 20 seconds. It will buzz for 20 seconds and the reset will begin when the buzz sound speed up and stop.
