7.1. MEASUREMENT PROCEDURE

For peak power test:

1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
2. $RBW \geq DTS$ bandwidth
3. $VBW \geq 3 \times RBW$.
4. $SPAN \geq VBW$.
5. Sweep: Auto.
6. Detector function: Peak.
7. Trace: Max hold.

Allow trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission. The indicated level is the peak output power, after any corrections for external attenuators and cables.

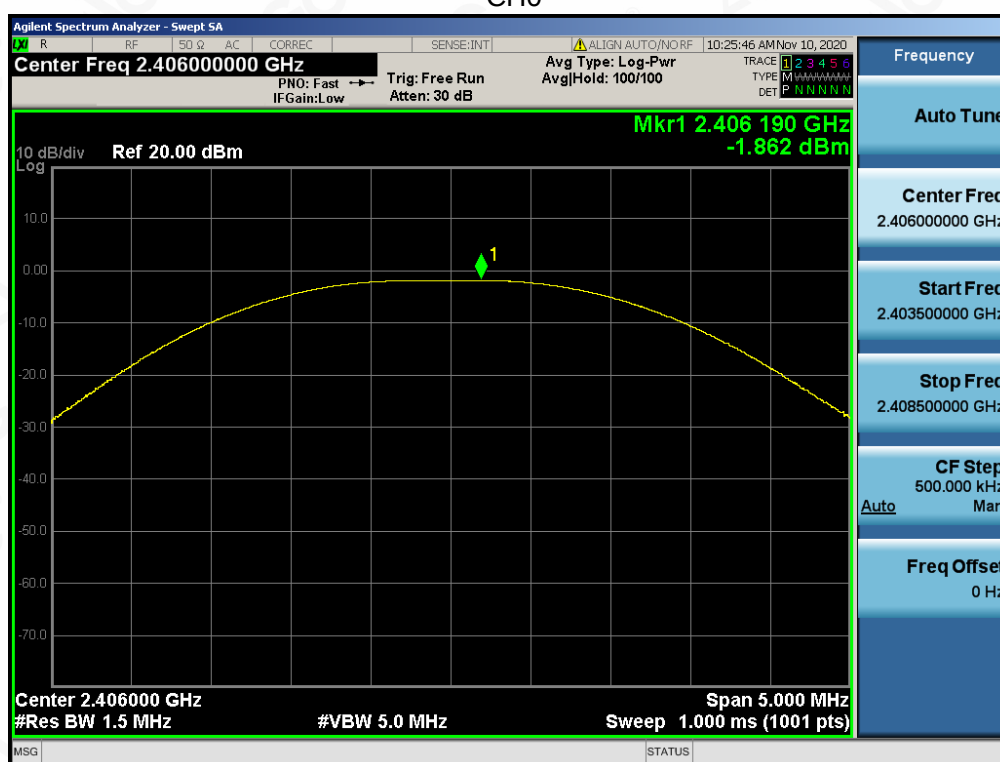

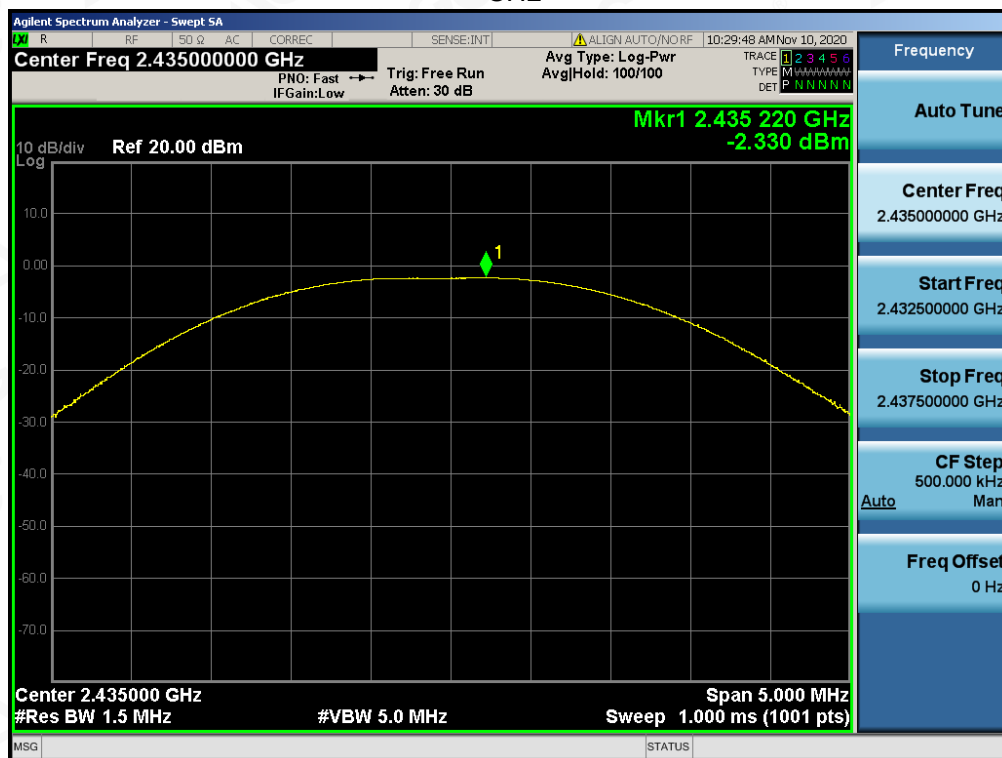

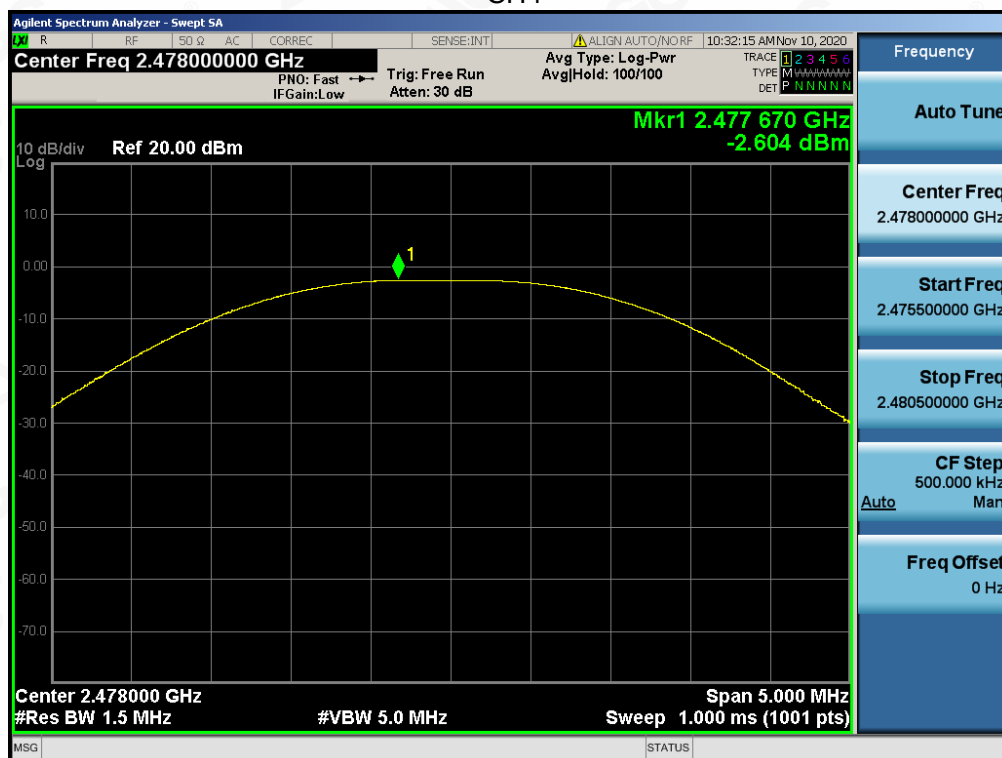

2. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
3. Set SPA Centre Frequency = Operation Frequency, RBW= 100 kHz, VBW $\geq 3 \times$ RBW.
4. Set SPA Trace 1 Max hold, then View.

Note: The EUT was tested according to ANSI C63.10 for compliance to FCC PART 15.247 requirements.

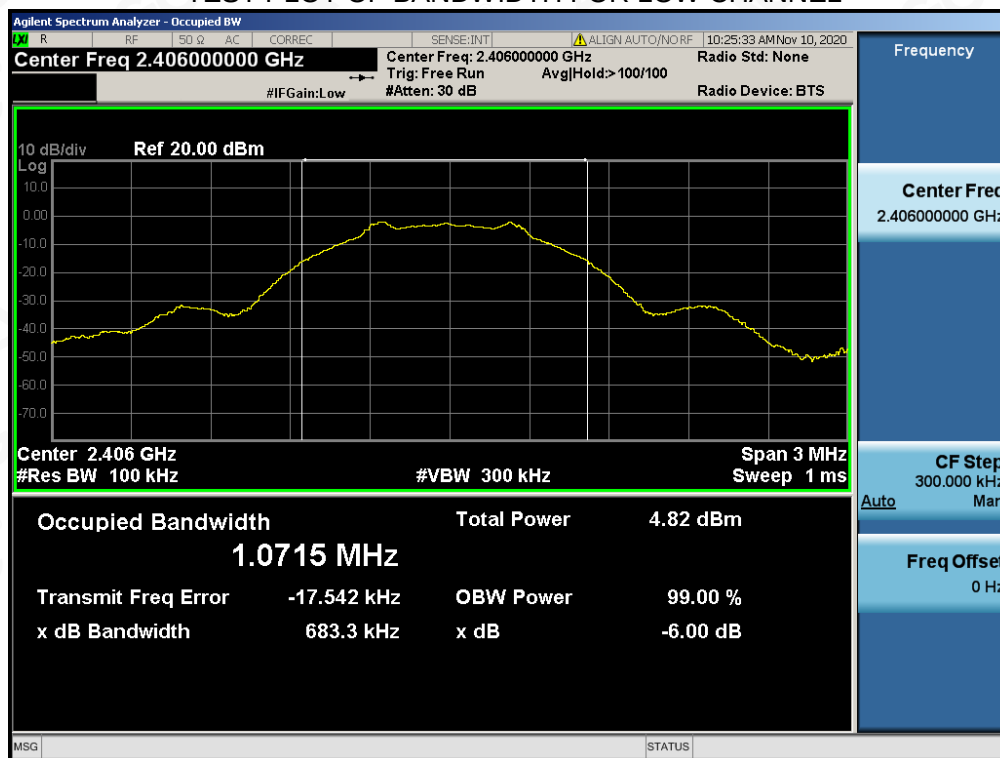

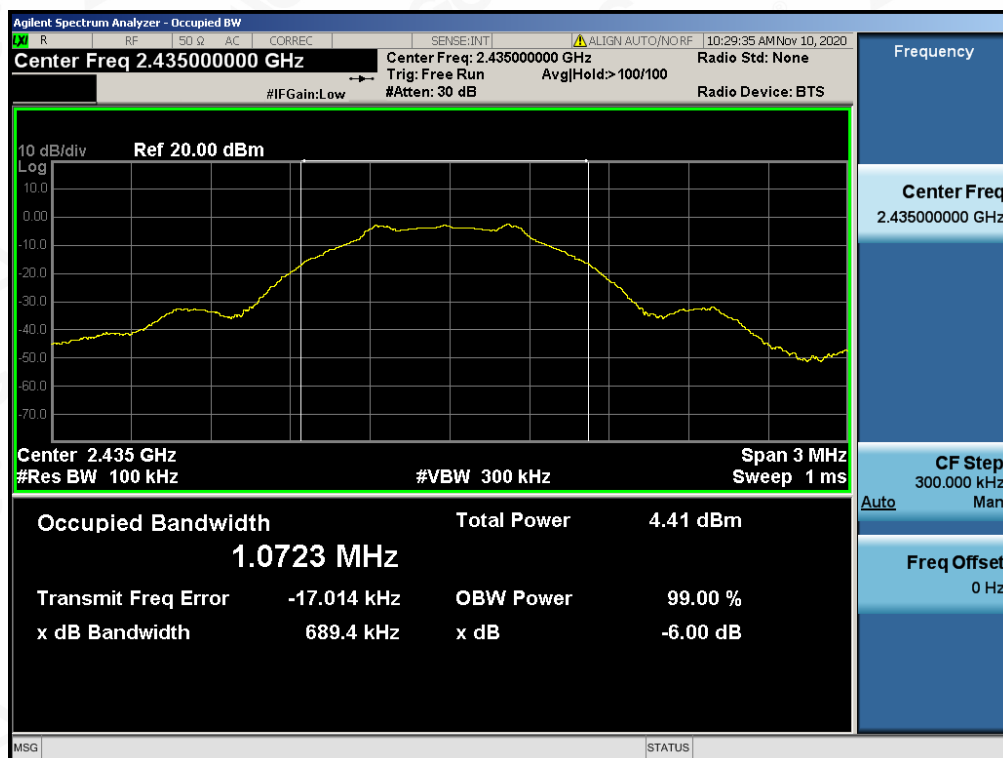

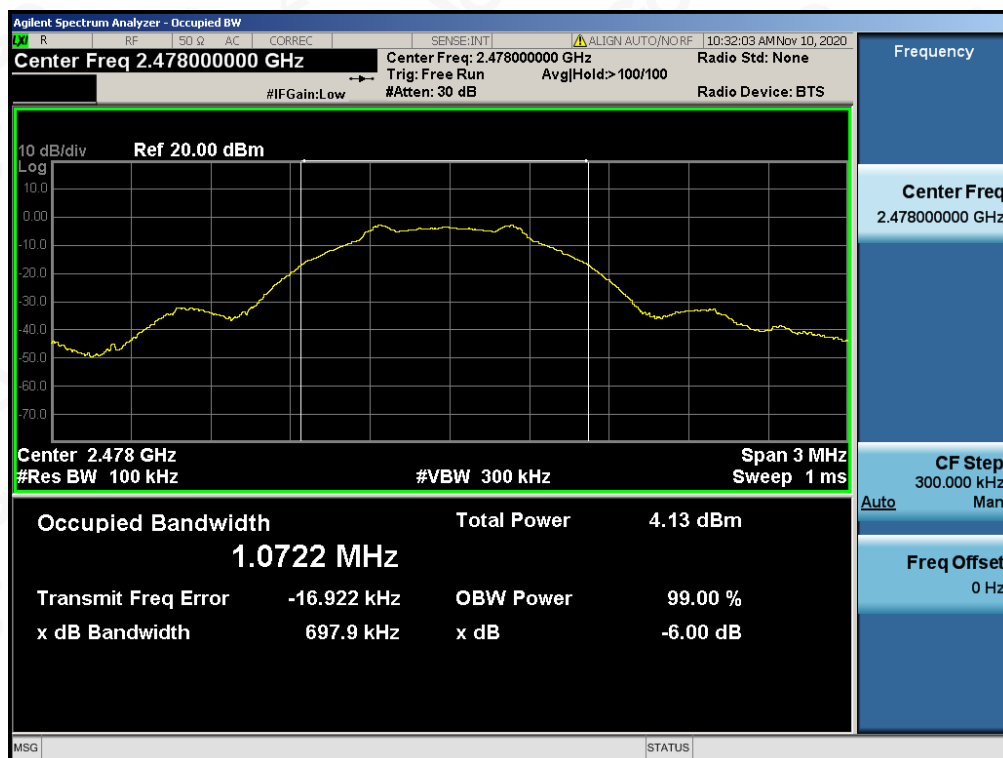

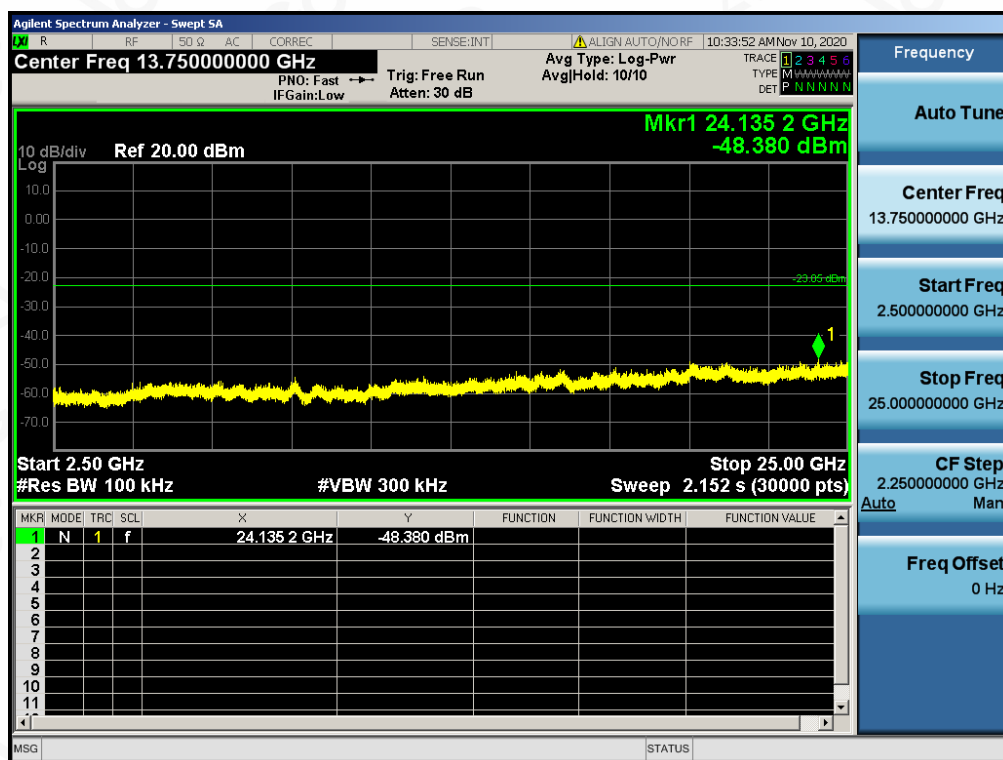

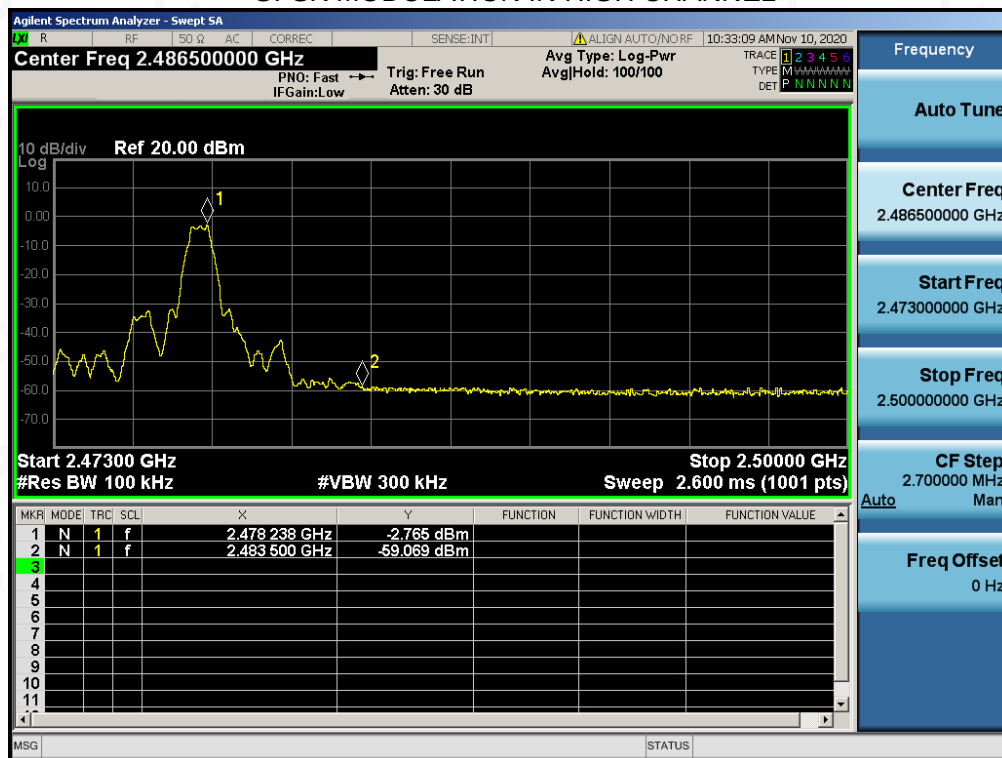

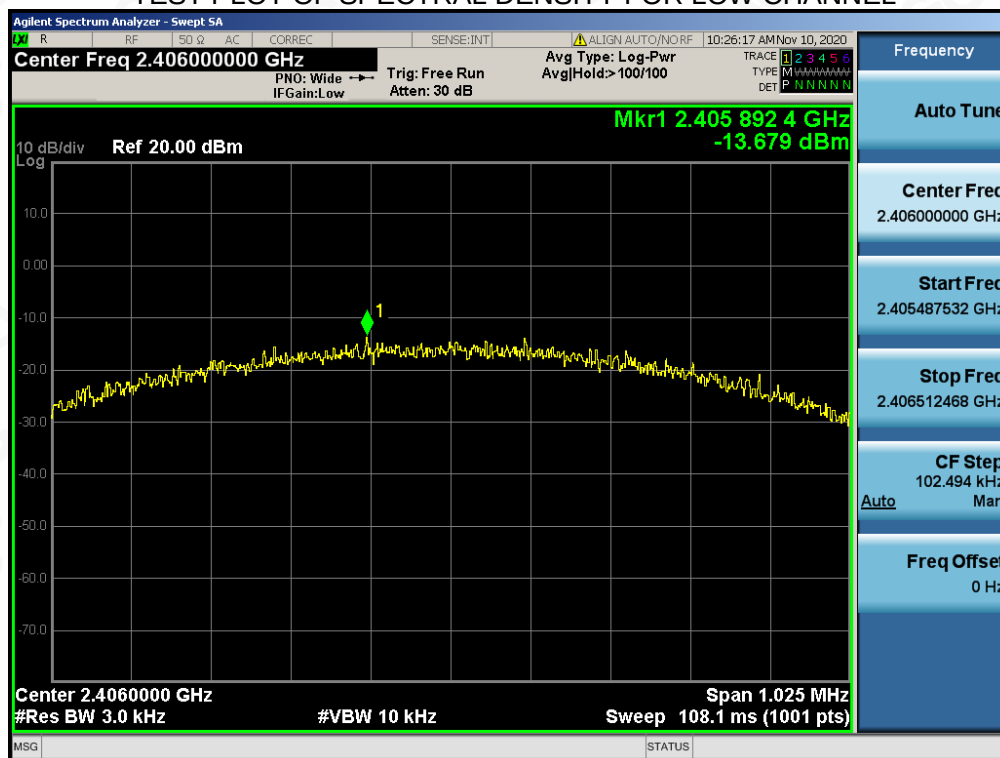
