### INSTRUCTIONS

- Connect the power adapter to an AC outlet
- Connect power adapter to the USB-A to USB-C cable
- Connect USB-C end of cable to the wireless charger
- The LED will flash rapidly then return to off

Note: Only QC 2.0 and QC 3.0 power adapters support this product's quick charge function.
