Connect to the Ethernet cable, Settings>More>Ethernet, Plug in Lan cable if show the IP address, that the Ethernet connect is ok.

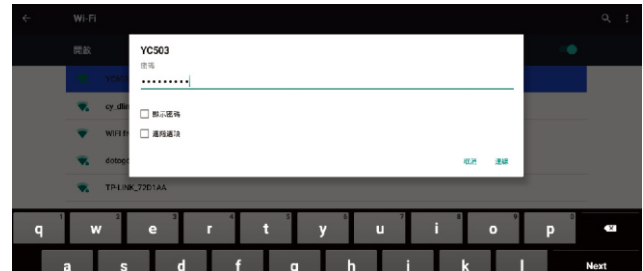


Wireless Connections

Top Tips :

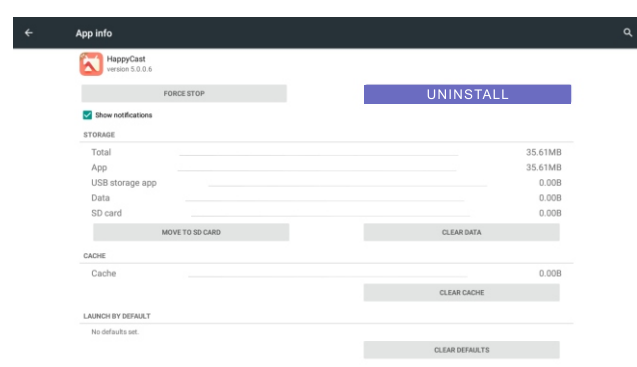

Settings>Apps : Select the Applications that you want to remove, click upper right corner "UNINSTALL" and choose "OK"

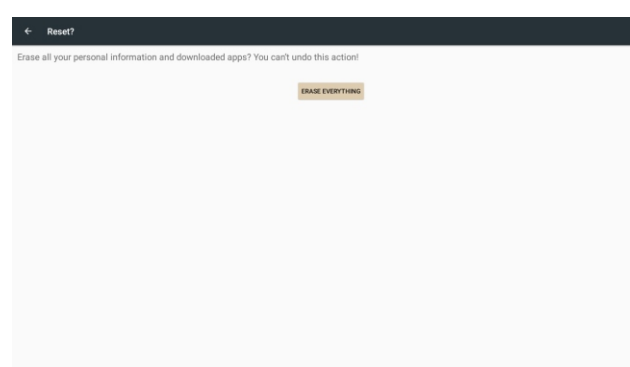
