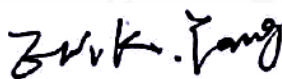

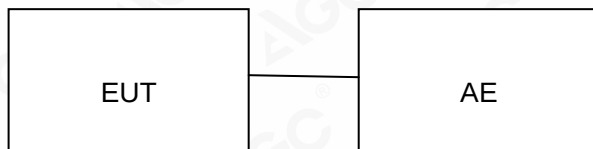

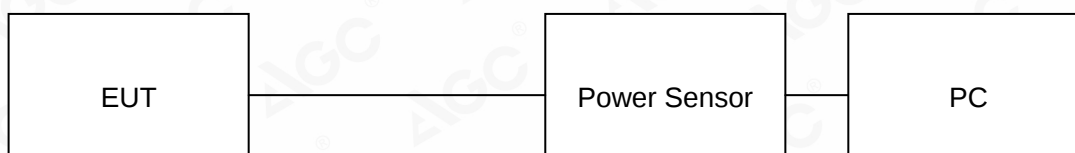

4. Set SPA Trace 1 Max hold, then View.

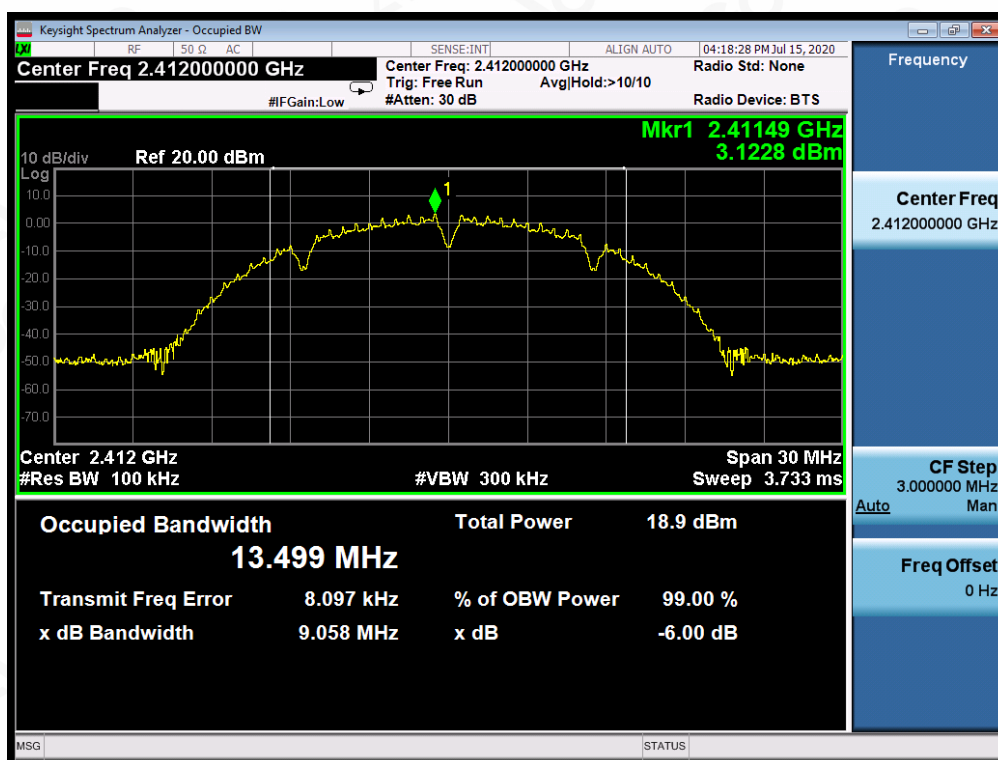

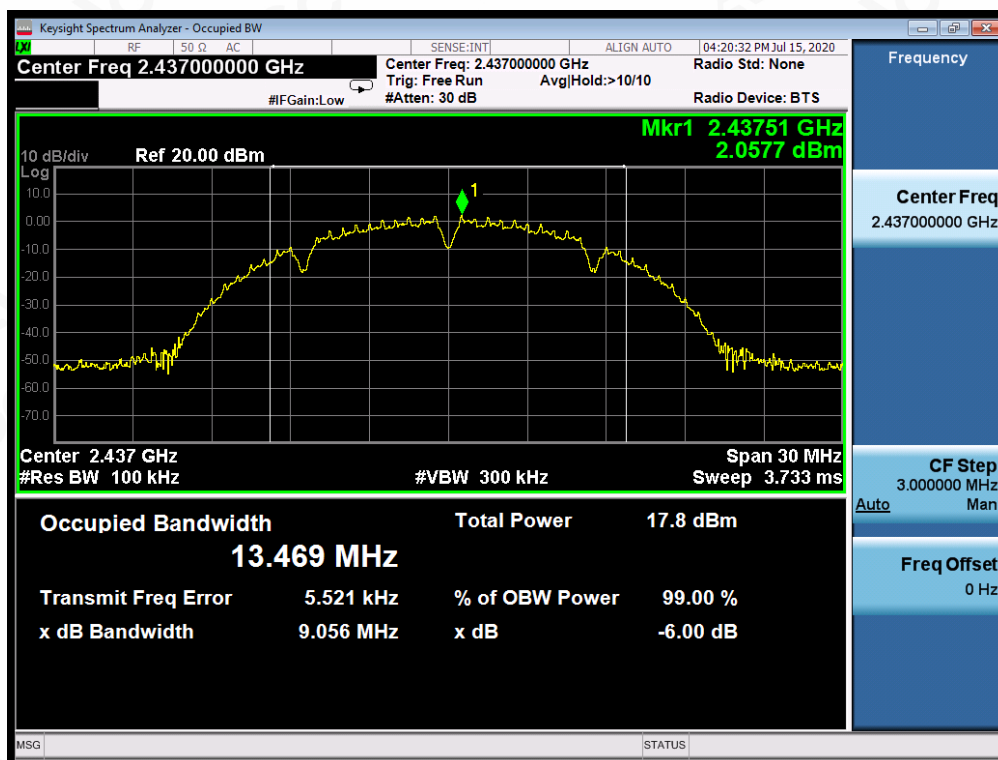

TEST PLOT OF BANDWIDTH FOR MIDDLE CHANNEL

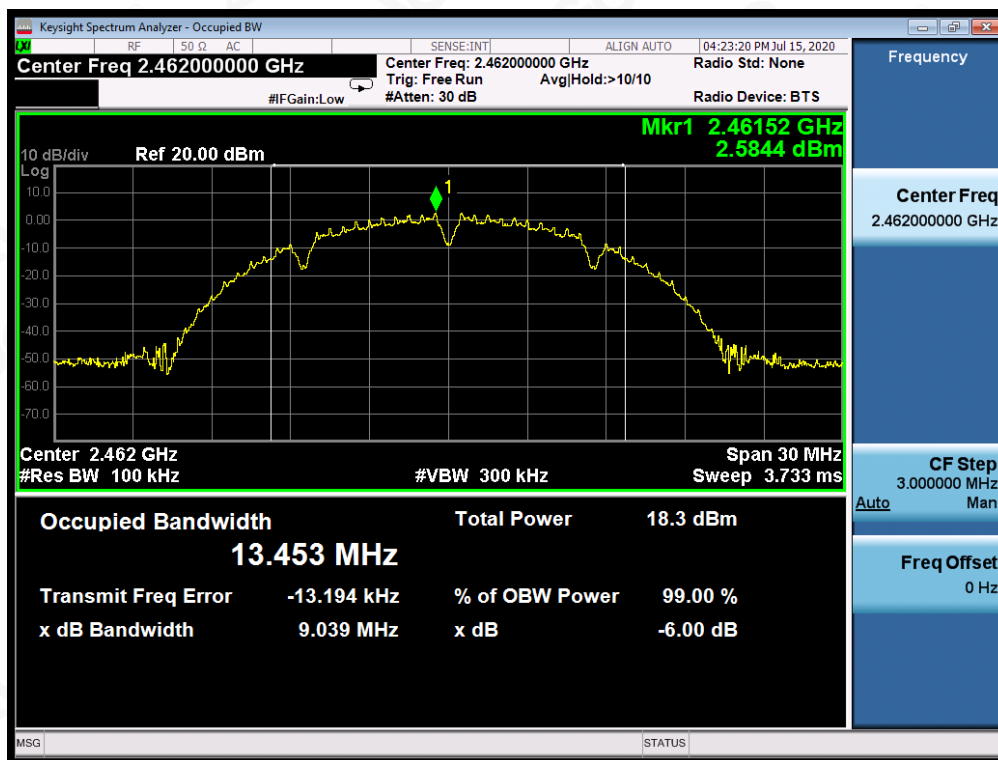

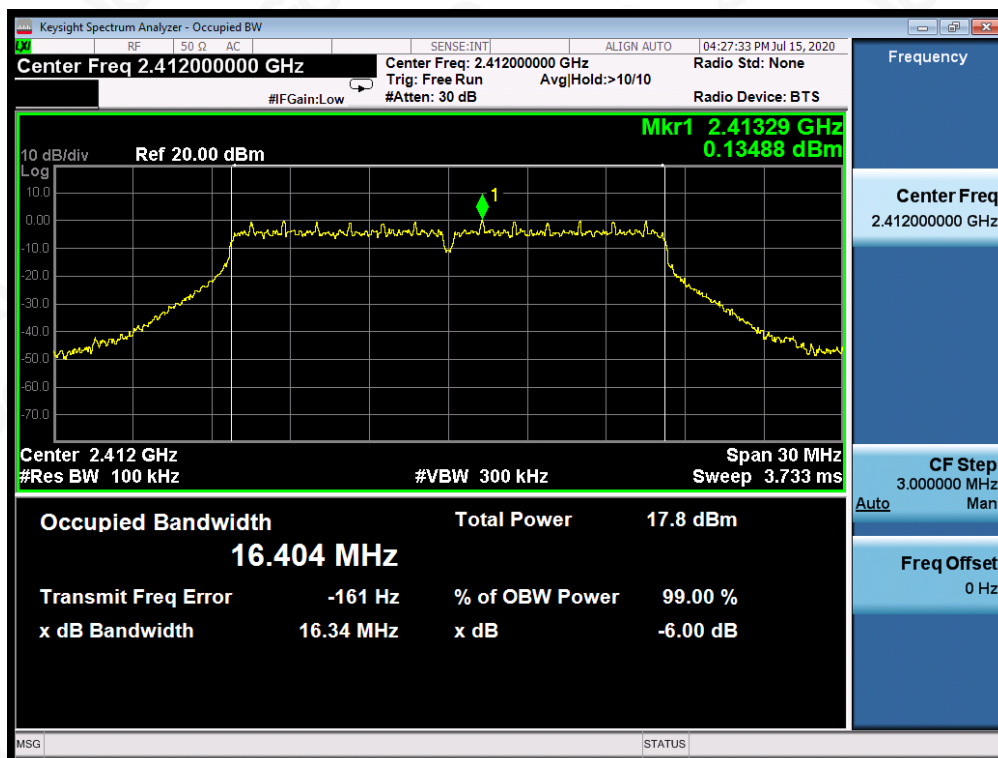


TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL

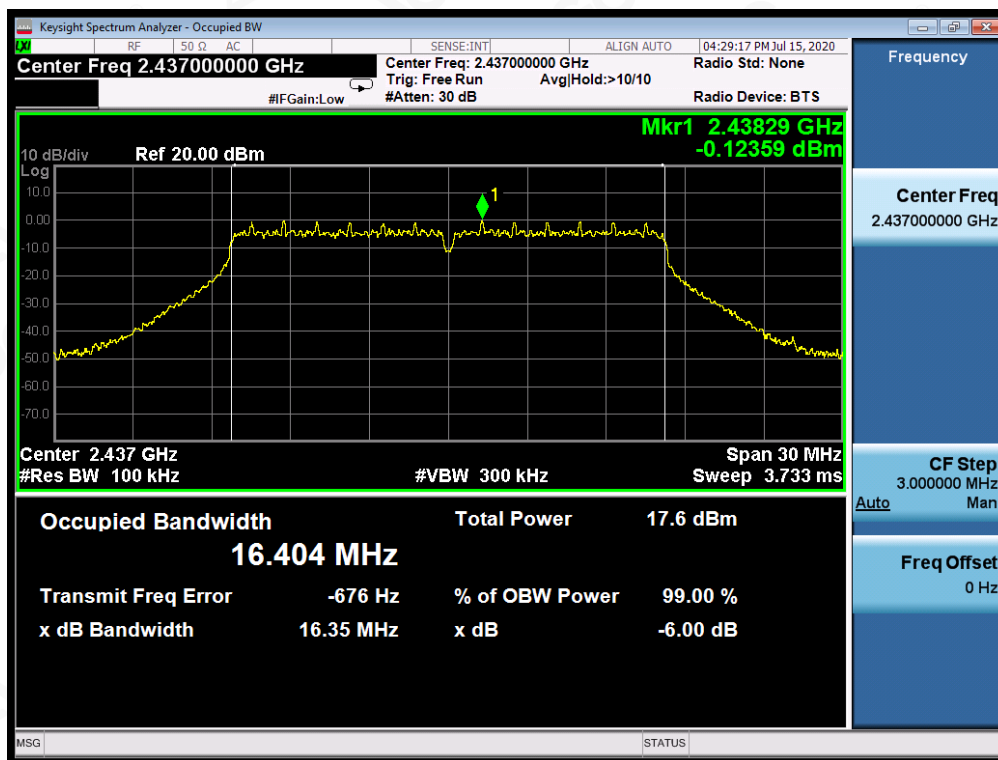

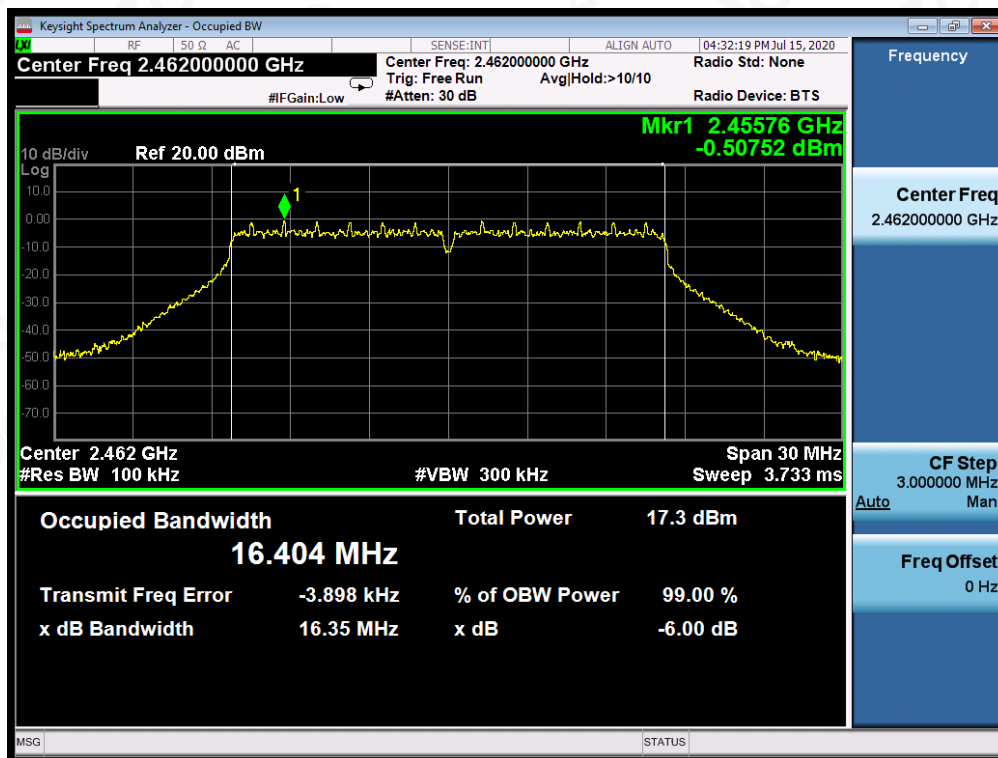

TEST PLOT OF BANDWIDTH FOR HIGH CHANNEL



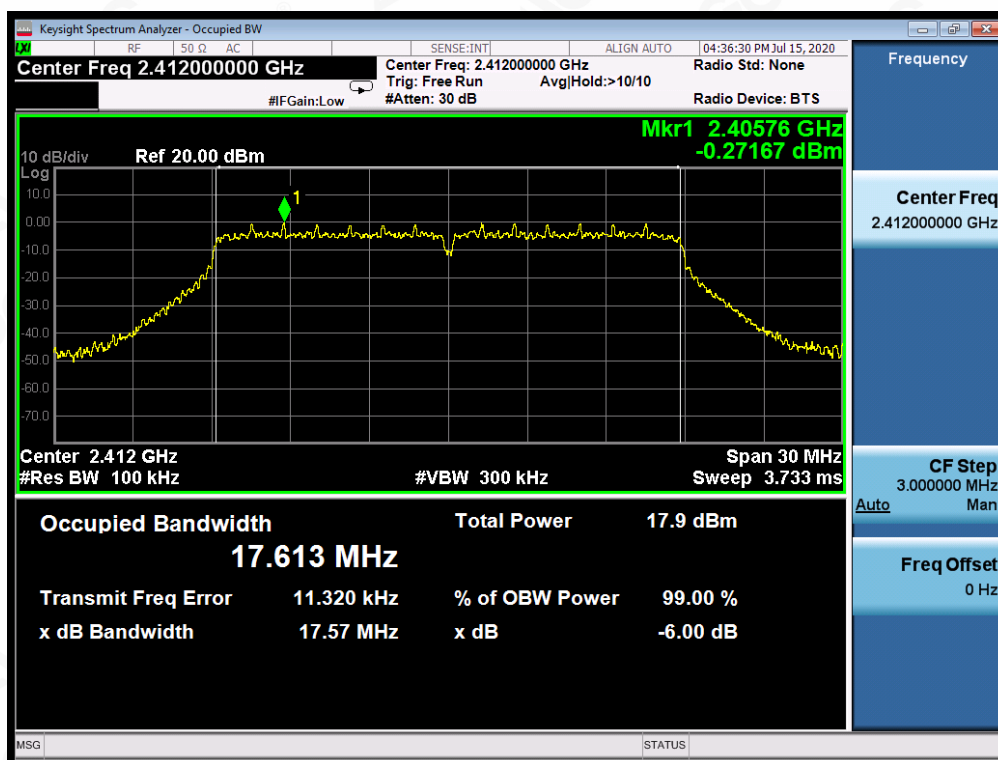

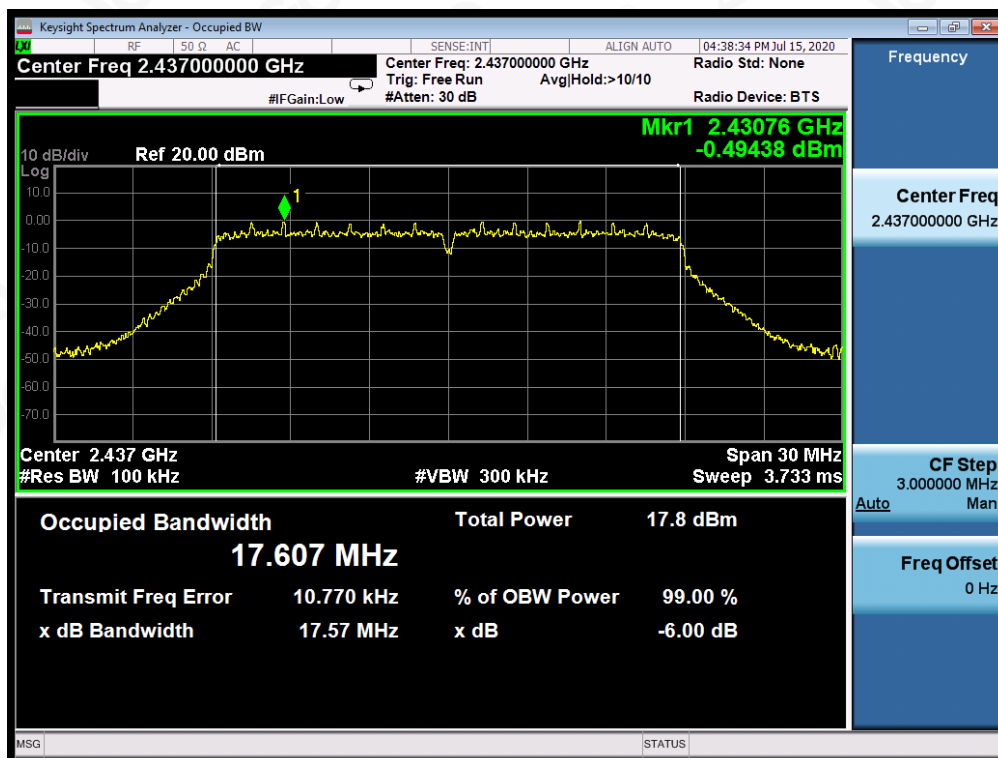
