

I. Executive Summary

A. Purpose of Test

An EMC evaluation was performed to determine compliance of the GridPlus, Inc. Lattice1 with WiFi Module, with the requirements of Part 15, §15.247. All references are to the most current version of Title 47 of the Code of Federal Regulations in effect. In accordance with §2.1033, the following data is presented in support of the Certification of the Lattice1 with WiFi Module. GridPlus, Inc. should retain a copy of this document which should be kept on file for at least two years after the manufacturing of the Lattice1 with WiFi Module, has been **permanently** discontinued.

E. Description of Test Sample

The GridPlus, Inc. Lattice1 with WiFi Module, Equipment Under Test (EUT), is an anti-tamper consumer electronic security device which is used for verifying and signing cryptographic messages usually related to blockchains. While waiting for either an external signature request or locally initiated request (via onboard screen input) the device generally sits idle. The device saves signing privileges on an internal flash chip, checks signing requests against those privileges, and then uses a smart card chip for signing the requested message. The Lattice1 with WiFi Module can receive requests via WiFi, ZigBee, Ethernet, or the touch screen interface. The Lattice1 with WiFi Module is intended to be used by consumers in residences as well as IT and finance professionals in an office building.




Figure 1. Block Diagram of Test Configuration

I. Mode of Operation

Operation Test Mode – The Lattice1 will monitor both the WiFi, ZigBee, and Ethernet for requests. The Lattice1 will internally generate events emulating both external requests and direct user interactions once every 10 seconds. These events will cause the Lattice1 to behave in a manner similar to if the requests were received via user interaction. The requests will include processes which cause all of the subsystems to be exercised as if a user event was received, including the SPI buses, internal memory, the user interface, the smart card interface, the graphics processor, the Linux environment, the ethernet interface, and the SD card. This is level of event generation is 100 times more frequent than typical operation by a user.

Radio Test Mode – The Lattice1 will operate normally except for the operation of the WiFi and ZigBee interfaces. The radios will be controllable via the ethernet connection and an external computer. All channels, power levels, frequency and modulation will be set by the external computer.

J. Method of Monitoring EUT Operation

The Lattice1 will be in Operation test mode when:

1. The screen changes without user interaction approximately once every 10 seconds.

The Lattice1 will be in Radio Test Mode when:

1. The WiFi test tool is running on connected computer and responsive to inputs.

The ZigBee test tool is running on connected computer and responsive to inputs.

The structure and application of the EUT were analyzed to determine compliance with Section 15.203 of the Rules. Section 15.203 states that the subject device must meet at least one of the following criteria:

- a.) Antenna must be permanently attached to the unit.
- b.) Antenna must use a unique type of connector to attach to the EUT.
- c.) Unit must be professionally installed. Installer shall be responsible for verifying that the correct antenna is employed with the unit.

Results: The EUT as tested is compliant the criteria of §15.203. The EUT utilizes an etched PCB antenna, which is to be considered permanently attached to the EUT.

Test Procedure: The EUT was placed on a 0.8 m-high wooden table inside a screen room. The EUT was situated such that the back of the EUT was 0.4 m from one wall of the vertical ground plane, and the remaining sides of the EUT were no closer than 0.8 m from any other conductive surface. The EUT was powered from a 50 Ω /50 μ H Line Impedance Stabilization Network (LISN). The EMC receiver scanned the frequency range from 150 kHz to 30 MHz. Conducted Emissions measurements were made in accordance with *ANSI C63.10:2013*. The measurements were performed over the frequency range of 0.15 MHz to 30 MHz using a 50 Ω /50 μ H LISN as the input transducer to an EMC/field intensity meter. 




Plot 1. Conducted Emissions, 15.207(a), Phase Line


Figure 2. Block Diagram, Occupied Bandwidth Test Setup









Plot 3. 6 dB Occupied Bandwidth, 2412 MHz – 9.617 MHz




Plot 4. 6 dB Occupied Bandwidth, 2437 MHz – 9.145 MHz






Figure 4. Maximum (Average) Output Power, 802.11b, 2412 MHz , 15.80 dBm




Figure 5. Maximum (Average) Output Power, 802.11b, 2437 MHz, 15.59 dBm




Figure 8. Maximum (Average) Output Power, 802.11g, 2437 MHz, 14.72 dBm




Figure 9. Maximum (Average) Output Power, 802.11g, 2462 MHz, 14.81 dBm





Figure 10. Radiated Emissions Test Setup



Figure 11. Radiated Emissions, 802.11b, 2412 MHz, 30 – 1000 MHz, Vertical




Figure 12. Radiated Emissions, 802.11b, 2412 MHz, 30 – 1000 MHz, Horizontal




Figure 13. Radiated Emissions, 802.11b, 2437 MHz, 30 – 1000 MHz, Vertical




Figure 14. Radiated Emissions, 802.11b, 2437 MHz, 30 – 1000 MHz, Horizontal




Figure 15. Radiated Emissions, 802.11b, 2462 MHz, 30 – 1000 MHz, Vertical




Figure 16. Radiated Emissions, 802.11b, 2462 MHz, 30 – 1000 MHz, Horizontal




Figure 17. Radiated Emissions, 802.11b, 2412 MHz, 1 – 7 GHz, Peak, Vertical




Figure 18. Radiated Emissions, 802.11b, 2412 MHz, 1 – 7 GHz, Peak, Horizontal




Figure 19. Radiated Emissions, 802.11b, 2437 MHz, 1 – 7 GHz, Average, Vertical




Figure 20. Radiated Emissions, 802.11b, 2437 MHz, 1 – 7 GHz, Average, Horizontal




Figure 21. Radiated Emissions, 802.11b, 2437 MHz, 1 – 7 GHz, Peak, Vertical




Figure 22. Radiated Emissions, 802.11b, 2437 MHz, 1 – 7 GHz, Peak, Horizontal




Figure 23. Radiated Emissions, 802.11b, 2462 MHz, 1 – 7 GHz, Average, Vertical




Figure 24. Radiated Emissions, 802.11b, 2462 MHz, 1 – 7 GHz, Average, Horizontal




Figure 25. Radiated Emissions, 802.11b, 2462 MHz, 1 – 7 GHz, Peak, Vertical




Figure 26. Radiated Emissions, 802.11b, 2462 MHz, 1 – 7 GHz, Peak, Horizontal




Figure 27. Radiated Emissions, 802.11b, 2412 MHz, 7-18 GHz, Average, Vertical




Figure 28. Radiated Emissions, 802.11b, 2412 MHz, 7-18 GHz, Average, Horizontal




Figure 29. Radiated Emissions, 802.11b, 2412 MHz, 7-18 GHz, Peak, Vertical




Figure 30. Radiated Emissions, 802.11b, 2412 MHz, 7-18 GHz, Peak, Horizontal




Figure 31. Radiated Emissions, 802.11b, 2437 MHz, 7 - 18 GHz, Average, Vertical




Figure 32. Radiated Emissions, 802.11b, 2437 MHz, 7 - 18 GHz, Average, Horizontal




Figure 33. Radiated Emissions, 802.11b, 2437 MHz, 7 - 18 GHz, Peak, Vertical




Figure 34. Radiated Emissions, 802.11b, 2437 MHz, 7 – 18 GHz, Peak, Horizontal




Figure 35. Radiated Emissions, 802.11b, 2437MHz, 18 - 40 GHz, Average, Vertical




Figure 36. Radiated Emissions, 802.11b, 2437MHz, 18 - 40 GHz, Average, Horizontal




Figure 37. Radiated Emissions, 802.11b, 2437MHz, 18 - 40 GHz, Peak, Vertical





Figure 38. Radiated Emissions, 802.11b, 2437MHz, 18 - 40 GHz, Peak, Horizontal

Figure 39. Radiated Emissions, 802.11g, 2412 MHz, 30 – 1000 MHz, Vertical





Figure 40. Radiated Emissions, 802.11g, 2412 MHz, 30 – 1000 MHz, Horizontal

Figure 41. Radiated Emissions, 802.11g, 2437 MHz, 30 – 1000 MHz, Vertical




Figure 42. Radiated Emissions, 802.11g, 2437 MHz, 30 – 1000 MHz, Horizontal




Figure 43. Radiated Emissions, 802.11g, 2462 MHz, 30 – 1000 MHz, Vertical




Figure 44. Radiated Emissions, 802.11g, 2462 MHz, 30 – 1000 MHz, Horizontal




Figure 45. Radiated Emissions, 802.11g, 2412 MHz, 1 – 7 GHz, Average, Vertical




Figure 46. Radiated Emissions, 802.11g, 2412 MHz, 1 – 7 GHz, Average, Horizontal




Figure 47. Radiated Emissions, 802.11g, 2412 MHz, 1 – 7 GHz, Peak, Vertical




Figure 48. Radiated Emissions, 802.11g, 2412 MHz, 1 – 7 GHz, Peak, Horizontal




Figure 49. Radiated Emissions, 802.11g, 2437 MHz, 1 – 7 GHz, Average, Vertical




Figure 50. Radiated Emissions, 802.11g, 2437 MHz, 1 – 7 GHz, Average, Horizontal




Figure 51. Radiated Emissions, 802.11g, 2437 MHz, 1 – 7 GHz, Peak, Vertical




Figure 52. Radiated Emissions, 802.11g, 2437 MHz, 1 – 7 GHz, Peak, Horizontal




Figure 53. Radiated Emissions, 802.11g, 2462 MHz, 1 – 7 GHz, Average, Vertical




Figure 54. Radiated Emissions, 802.11g, 2462 MHz, 1 – 7 GHz, Average, Horizontal




Figure 55. Radiated Emissions, 802.11g, 2462 MHz, 1 – 7 GHz, Peak, Vertical




Figure 56. Radiated Emissions, 802.11g, 2462 MHz, 1 – 7 GHz, Peak, Horizontal




Figure 57. Radiated Emissions, 802.11g, 2412 MHz, 7-18 GHz, Average, Vertical




Figure 58. Radiated Emissions, 802.11g, 2412 MHz, 7-18 GHz, Average, Horizontal




Figure 59. Radiated Emissions, 802.11g, 2412 MHz, 7-18 GHz, Peak, Vertical




Figure 60. Radiated Emissions, 802.11g, 2412 MHz, 7-18 GHz, Peak, Horizontal




Figure 61. Radiated Emissions, 802.11g, 2437 MHz, 7 - 18 GHz, Average, Vertical




Figure 62. Radiated Emissions, 802.11g, 2437 MHz, 7 - 18 GHz, Average, Horizontal




Figure 63. Radiated Emissions, 802.11g, 2437 MHz, 7 - 18 GHz, Peak, Vertical




Figure 64. Radiated Emissions, 802.11g, 2437 MHz, 7 – 18 GHz, Peak, Horizontal




Figure 65. Radiated Emissions, 802.11g, 2462 MHz, 7 – 18 GHz, Average, Vertical




Figure 66. Radiated Emissions, 802.11g, 2462 MHz, 7 – 18 GHz, Average, Horizontal




Figure 67. Radiated Emissions, 802.11g, 2462 MHz, 7 – 18 GHz, Peak, Vertical




Figure 68. Radiated Emissions, 802.11g, 2462 MHz, 7 – 18 GHz, Peak, Horizontal




Figure 70: Radiated Band Edge, 802.11b - 2402 MHz - Average - Horizontal.




Figure 71: Radiated Band Edge, 802.11b - 2402 MHz - Average - Vertical.




Figure 72: Radiated Band Edge, 802.11b - 2402 MHz - Peak - Horizontal.




Figure 73: Radiated Band Edge, 802.11b - 2402 MHz - Peak - Vertical.




Figure 74: Radiated Band Edge, 802.11b - 2462 MHz - Average - Horizontal.




Figure 75: Radiated Band Edge, 802.11b - 2462 MHz - Average - Vertical.




Figure 76: Radiated Band Edge, 802.11b - 2462 MHz - Peak - Horizontal.




Figure 77: Radiated Band Edge, 802.11b - 2462 MHz - Peak - Vertical.




Figure 78: Radiated Band Edge, 802.11g - 2402 MHz - Average - Horizontal.




Figure 79: Radiated Band Edge, 802.11g - 2402 MHz - Average - Vertical.




Figure 80: Radiated Band Edge, 802.11g - 2402 MHz - Peak - Horizontal.




Figure 81: Radiated Band Edge, 802.11g - 2402 MHz - Peak - Vertical.




Figure 82: Radiated Band Edge, 802.11g - 2462 MHz - Average - Horizontal.




Figure 83: Radiated Band Edge, 802.11g - 2462 MHz - Average - Vertical.




Figure 84: Radiated Band Edge, 802.11g - 2462 MHz - Peak - Horizontal.




Figure 85: Radiated Band Edge, 802.11g - 2462 MHz - Peak - Vertical.







Electromagnetic Compatibility Criteria for Intentional Radiators

§ 15.247(d) Spurious Emissions in Non-restricted Bands

Test Requirement: **15.247(d)** In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.

Test Procedure: For intentional radiators with a digital device portion which operates below 10 GHz, the spectrum was investigated as per §15.33(a)(1) and §15.33(a)(4); i.e., the lowest RF signal generated or used in the device up to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower.


The EUT was connected to a spectrum analyzer through a cable and an attenuator. Measurements were taken with the EUT set to transmit continuously on its low, mid, and high channels for all its bandwidths at maximum power. Conducted spurious emissions were measured according to sections 11.11.2 and 11.11.3 of ANSI C63.10-2013.

Test Results: The EUT was compliant with the Spurious Emission limits of **§15.247(d)**. Emissions were within applicable limits.






Plot 9. Conducted Spurious Emissions, 802.11b, 2412 MHz, 30-1000 MHz




Plot 10. Conducted Spurious Emissions, 802.11b, 2412 MHz, 1-26.5 GHz




Plot 11. Conducted Spurious Emissions, 802.11b, 2437 MHz, 30-1000 MHz




Plot 12. Conducted Spurious Emissions, 802.11b, 2437 MHz, 1-26.5 GHz




Plot 13. Conducted Spurious Emissions, 802.11b, 2462 MHz, 30-1000 MHz




Plot 14. Conducted Spurious Emissions, 802.11b, 2462 MHz, 1-26.5 GHz




Plot 15. Conducted Spurious Emissions, 802.11g, 2412 MHz, 30-1000 MHz




Plot 16. Conducted Spurious Emissions, 802.11g, 2412 MHz, 1-26.5 GHz




Plot 17. Conducted Spurious Emissions, 802.11g, 2437 MHz, 30-1000 MHz




Plot 18. Conducted Spurious Emissions, 802.11g, 2437 MHz, 1-26.5 GHz




Plot 19. Conducted Spurious Emissions, 802.11g, 2462 MHz, 30-1000 MHz




Plot 20. Conducted Spurious Emissions, 802.11g, 2462 MHz, 1-26.5 GHz




Plot 21. Conducted Spurious Emissions, Bandedge, 802.11b, 2412 MHz

Electromagnetic Compatibility Criteria for Intentional Radiators

§ 15.247(e) Power Spectral Density

Test Requirements: **§15.247(e):** For digitally modulated systems, the peak power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8dBm in any 3 kHz band during any time interval of continuous transmission.

Test Procedure: The EUT was connected to a spectrum analyzer through a cable and an attenuator. Measurements were taken with the EUT set to transmit continuously on its low, mid, and high channels for all its bandwidths at maximum power. Power spectral density was measured according to measurement method AVGPSD-1A as described in ANSI C63.10-2013, section 11.10.4. Attenuator and cable loss were programmed into the spectrum analyzer.

Test Results: The EUT was compliant with the power spectral density limits of **§ 15.247 (e)**.




Figure 86. Block Diagram, Power Spectral Density Test Setup




Figure 87. Power Density, 802.11b, 2412 MHz, -0.93 dBm




Figure 88. Power Density, 802.11b, 2437 MHz, -1.382 dBm




Figure 89. Power Density, 802.11b, 2462 MHz, -1.255 dBm




Figure 90. Power Density, 802.11g, 2412 MHz, -3.627 dBm




Figure 91. Power Density, 802.11g, 2437 MHz, -3.889 dBm




Figure 92. Power Density, 802.11g, 2462 MHz, -3.767 dBm

§ 15.247(i) RF Human Exposure

RF Exposure Requirements: **§1.1307(b)(1) and §1.1307(b)(2):** Systems operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy levels in excess of the Commission's guidelines.

RF Radiation Exposure Limit: **2.1093:** As specified in this section, a portable device is defined as a transmitting device designed to be used so that the radiated structure(s) of the device is within 20 centimeters of the body of the user. Calculations below are in accordance with KDB 447498 D01 General RF Exposure Guidance v06, Section 4.3 General SAR test exclusion guidance. Certification & User's Manual Information

A. Certification Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart I — Marketing of Radio frequency devices:

§ 2.801 Radio-frequency device defined.

As used in this part, a radio-frequency device is any device which in its operation is capable of Emitting radio-frequency energy by radiation, conduction, or other means. Radio- frequency devices include, but are not limited to:

- (a) The various types of radio communication transmitting devices described throughout this chapter.
- (b) *The incidental, unintentional and intentional radiators defined in Part 15 of this chapter.*
- (c) The industrial, scientific, and medical equipment described in Part 18 of this chapter.
- (d) Any part or component thereof which in use emits radio-frequency energy by radiation, conduction, or other means.

§ 2.803 Marketing of radio frequency devices prior to equipment authorization.

- (a) Except as provided elsewhere in this chapter, no person shall sell or lease, or offer for sale or lease (including advertising for sale or lease), or import, ship or distribute for the purpose of selling or leasing or offering for sale or lease, any radio frequency device unless:
 - (1) In the case of a device subject to certification, such device has been authorized by the Commission in accordance with the rules in this chapter and is properly identified and labeled as required by §2.925 and other relevant sections in this chapter; or
 - (2) In the case of a device that is not required to have a grant of equipment authorization issued by the Commission, but which must comply with the specified technical standards prior to use, such device also complies with all applicable administrative (including verification of the equipment or authorization under a Declaration of Conformity, where required), technical, labeling and identification requirements specified in this chapter.
- (d) Notwithstanding the provisions of paragraph (a) of this section, the offer for sale solely to business, commercial, industrial, scientific or medical users (but not an offer for sale to other parties or to end users located in a residential environment) of a radio frequency device that is in the conceptual, developmental, design or pre-production stage is permitted prior to equipment authorization or, for devices not subject to the equipment authorization requirements, prior to a determination of compliance with the applicable technical requirements *provided* that the prospective buyer is advised in writing at the time of the offer for sale that the equipment is subject to the FCC rules and that the equipment will comply with the appropriate rules before delivery to the buyer or to centers of distribution.

(e)(1) Notwithstanding the provisions of paragraph (a) of this section, prior to equipment authorization or determination of compliance with the applicable technical requirements any radio frequency device may be operated, but not marketed, for the following purposes and under the following conditions:

- (i) *Compliance testing;*
- (ii) Demonstrations at a trade show provided the notice contained in paragraph (c) of this section is displayed in a conspicuous location on, or immediately adjacent to, the device;
- (iii) Demonstrations at an exhibition conducted at a business, commercial, industrial, scientific or medical location, but excluding locations in a residential environment, provided the notice contained in paragraphs (c) or (d) of this section, as appropriate, is displayed in a conspicuous location on, or immediately adjacent to, the device;
- (iv) Evaluation of product performance and determination of customer acceptability, provided such operation takes place at the manufacturer's facilities during developmental, design or pre-production states; or
- (v) Evaluation of product performance and determination of customer acceptability where customer acceptability of a radio frequency device cannot be determined at the manufacturer's facilities because of size or unique capability of the device, provided the device is operated at a business, commercial, industrial, scientific or medical user's site, but not at a residential site, during the development, design or pre-production stages.

(e)(2) For the purpose of paragraphs (e)(1)(iv) and (e)(1)(v) of this section, the term *manufacturer's facilities* includes the facilities of the party responsible for compliance with the regulations and the manufacturer's premises, as well as the facilities of other entities working under the authorization of the responsible party in connection with the development and manufacture, but not the marketing, of the equipment.

(f) For radio frequency devices subject to verification and sold solely to business, commercial, industrial, scientific and medical users (excluding products sold to other parties or for operation in a residential environment), parties responsible for verification of the devices shall have the option of ensuring compliance with the applicable technical specifications of this chapter at each end user's location after installation, provided that the purchase or lease agreement includes a proviso that such a determination of compliance be made and is the responsibility of the party responsible for verification of the equipment.

Certification & User's Manual Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart J — Equipment Authorization Procedures:

§ 2.901 Basis and Purpose

- (a) In order to carry out its responsibilities under the Communications Act and the various treaties and international regulations, and in order to promote efficient use of the radio spectrum, the Commission has developed technical standards for radio frequency equipment and parts or components thereof. The technical standards applicable to individual types of equipment are found in that part of the rules governing the service wherein the equipment is to be operated.¹ *In addition to the technical standards provided, the rules governing the service may require that such equipment be verified by the manufacturer or importer*, be authorized under a Declaration of Conformity, or receive an equipment authorization from the Commission by one of the following procedures: certification or registration.
- (b) The following sections describe the verification procedure, the procedure for a Declaration of Conformity, and the procedures to be followed in obtaining certification from the Commission and the conditions attendant to such a grant.

§ 2.907 Certification.

- (a) Certification is an equipment authorization issued by the Commission, based on representation and test data submitted by the applicant.
- (b) Certification attaches to all units subsequently marketed by the grantee which are identical (see Section 2.908) to the sample tested except for permissive changes or other variations authorized by the Commission pursuant to Section 2.1043.

¹ In this case, the equipment is subject to the rules of Part 15. More specifically, the equipment falls under Subpart B (of Part 15), which deals with unintentional radiators.

Certification & User's Manual Information

§ 2.948 Description of measurement facilities.

(a) Each party making measurements of equipment that is subject to an equipment authorization under Part 15 or Part 18 of this chapter, regardless of whether the measurements are filed with the Commission or kept on file by the party responsible for compliance of equipment marketed within the U.S. or its possessions, shall compile a description of the measurement facilities employed.

(1) If the measured equipment is subject to the verification procedure, the description of the measurement facilities shall be retained by the party responsible for verification of the equipment.

(i) *If the equipment is verified through measurements performed by an independent laboratory, it is acceptable for the party responsible for verification of the equipment to rely upon the description of the measurement facilities retained by or placed on file with the Commission by that laboratory. In this situation, the party responsible for the verification of the equipment is not required to retain a duplicate copy of the description of the measurement facilities.*

(ii) If the equipment is verified based on measurements performed at the installation site of the equipment, no specific site calibration data is required. It is acceptable to retain the description of the measurement facilities at the site at which the measurements were performed.

(2) If the equipment is to be authorized by the Commission under the certification procedure, the description of the measurement facilities shall be filed with the Commission's Laboratory in Columbia, Maryland. The data describing the measurement facilities need only be filed once but must be updated as changes are made to the measurement facilities or as otherwise described in this section. At least every three years, the organization responsible for filing the data with the Commission shall certify that the data on file is current.

Certification & User's Manual Information

1. Label and User's Manual Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart A — General:

§ 15.19 Labeling requirements.

(a) *In addition to the requirements in Part 2 of this chapter, a device subject to certification or verification shall be labeled as follows:*

(1) Receivers associated with the operation of a licensed radio service, e.g., FM broadcast under Part 73 of this chapter, land mobile operation under Part 90, etc., shall bear the following statement in a conspicuous location on the device:

This device complies with Part 15 of the FCC Rules. Operation is subject to the condition that this device does not cause harmful interference.

(2) A stand-alone cable input selector switch, shall bear the following statement in a conspicuous location on the device:

This device is verified to comply with Part 15 of the FCC Rules for use with cable television service.

(3) All other devices shall bear the following statement in a conspicuous location on the device:

This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

(4) Where a device is constructed in two or more sections connected by wires and marketed together, the statement specified under paragraph (a) of this section is required to be affixed only to the main control unit.

(5) When the device is so small or for such use that it is not practicable to place the statement specified under paragraph (a) of this section on it, the information required by this paragraph shall be placed in a prominent location in the instruction manual or pamphlet supplied to the user or, alternatively, shall be placed on the container in which the device is marketed. However, the FCC identifier or the unique identifier, as appropriate, must be displayed on the device.

§ 15.21 Information to user.

The user's manual or instruction manual for an intentional or unintentional radiator shall caution the user that changes or modifications not expressly approved by the party responsible for compliance could void the user's authority to operate the equipment.

Verification & User's Manual Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart B — Unintentional Radiators:

§ 15.105 Information to the user.

(a) For a Class A digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class A digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a commercial environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. Operation of this equipment in a residential area is likely to cause harmful interference in which case the user will be required to correct the interference at own expense.

(b) For a Class B digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a residential environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. However, there is no guarantee that interference will not occur in a particular installation. If this equipment does cause harmful interference to radio or television reception, which can be determined by turning the equipment off and on, the user is encouraged to try to correct the interference by one or more of the following measures:

- Reorient or relocate the receiving antenna.
- Increase the separation between the equipment and receiver.
- Connect the equipment into an outlet on a circuit different from that to which the receiver is connected.
- Consult the dealer or an experienced radio/TV technician for help.
