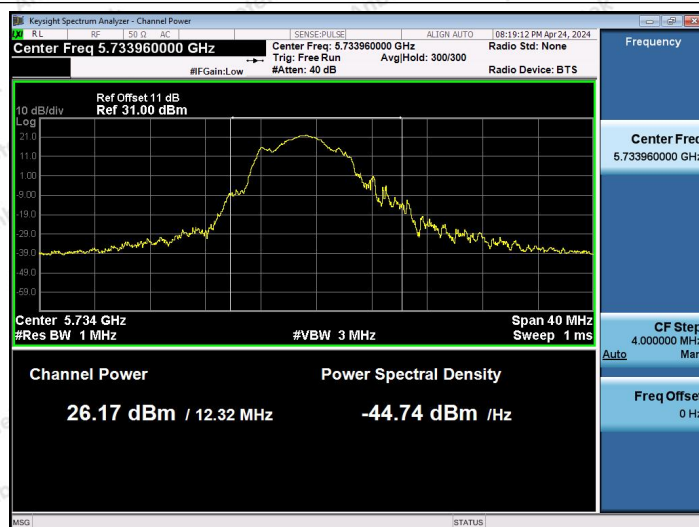

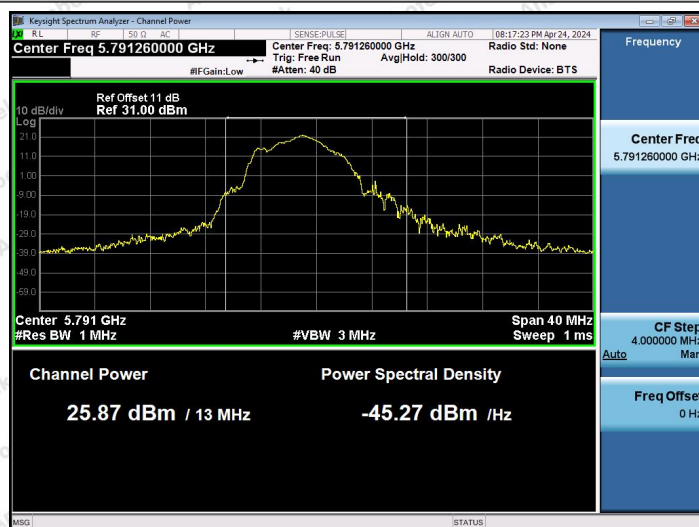

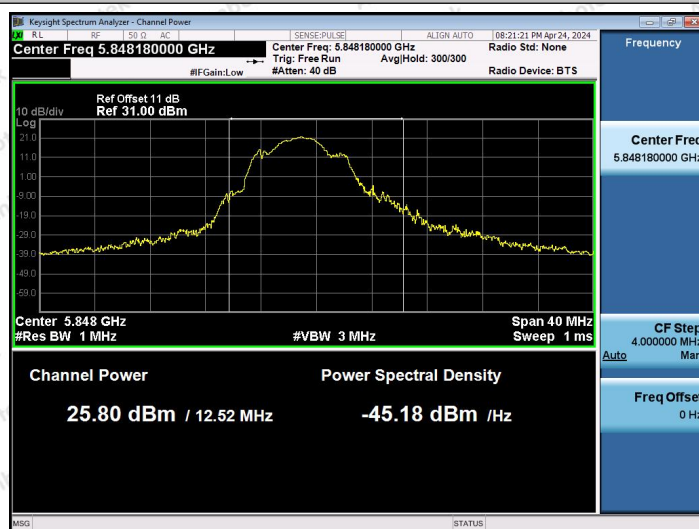
Test Graphs Channel Power

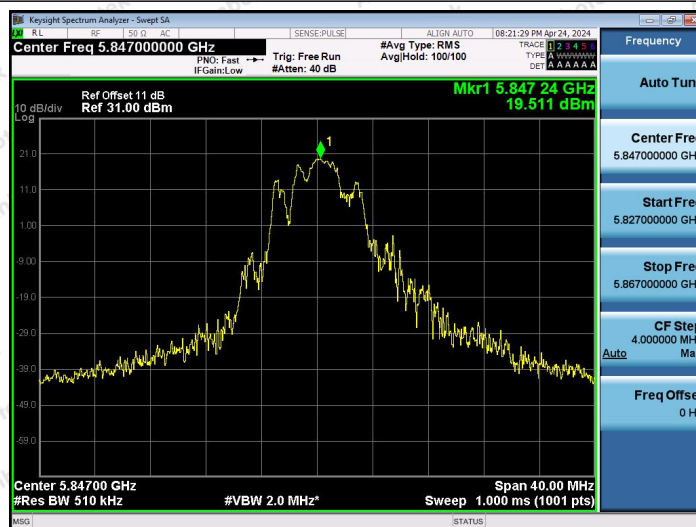
