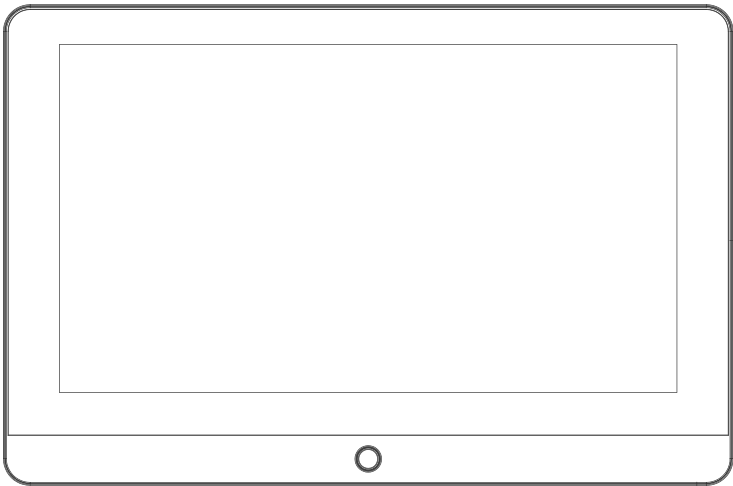

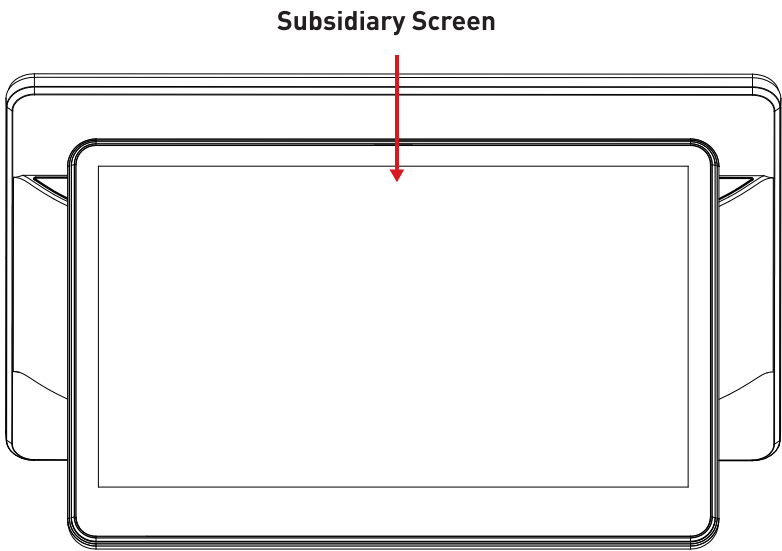

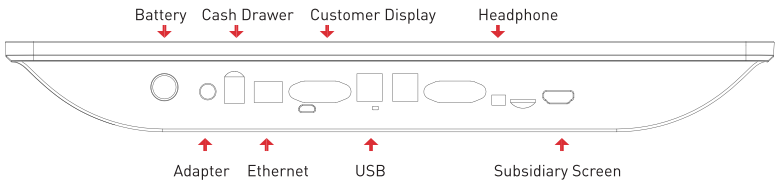
POS Device - Front



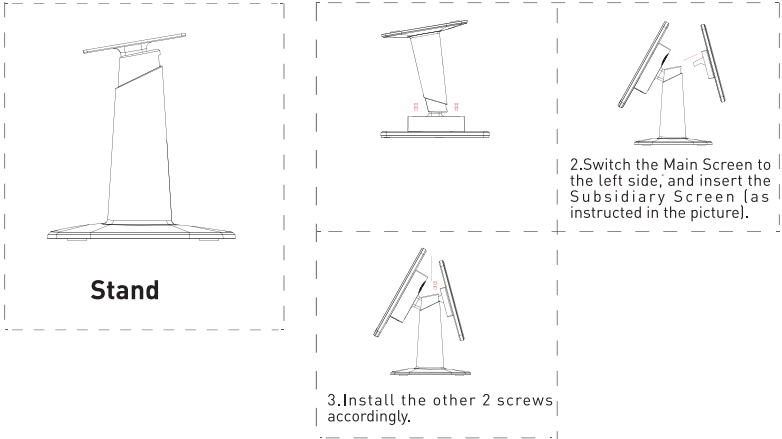
POS Device - Back



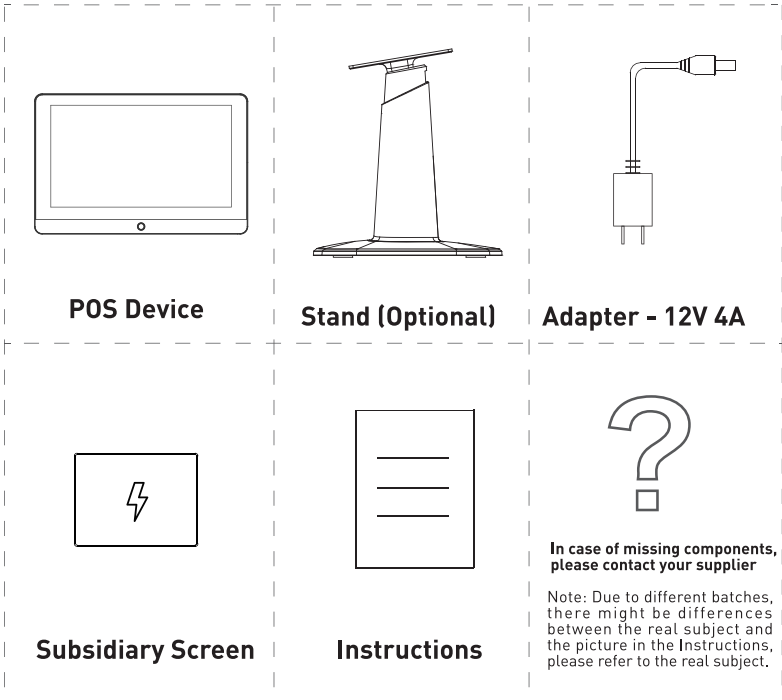
