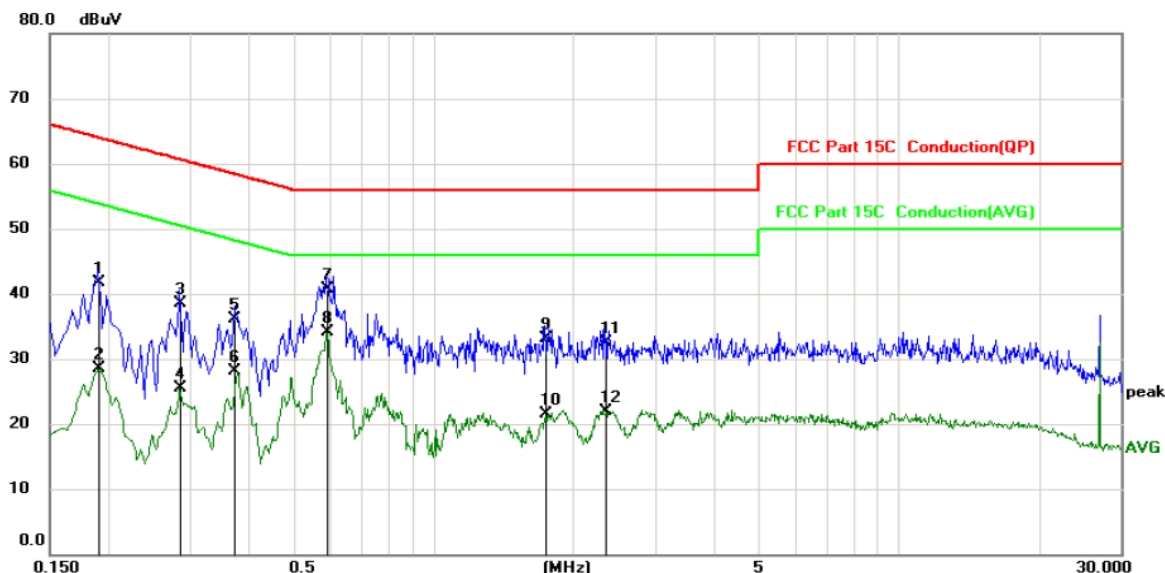

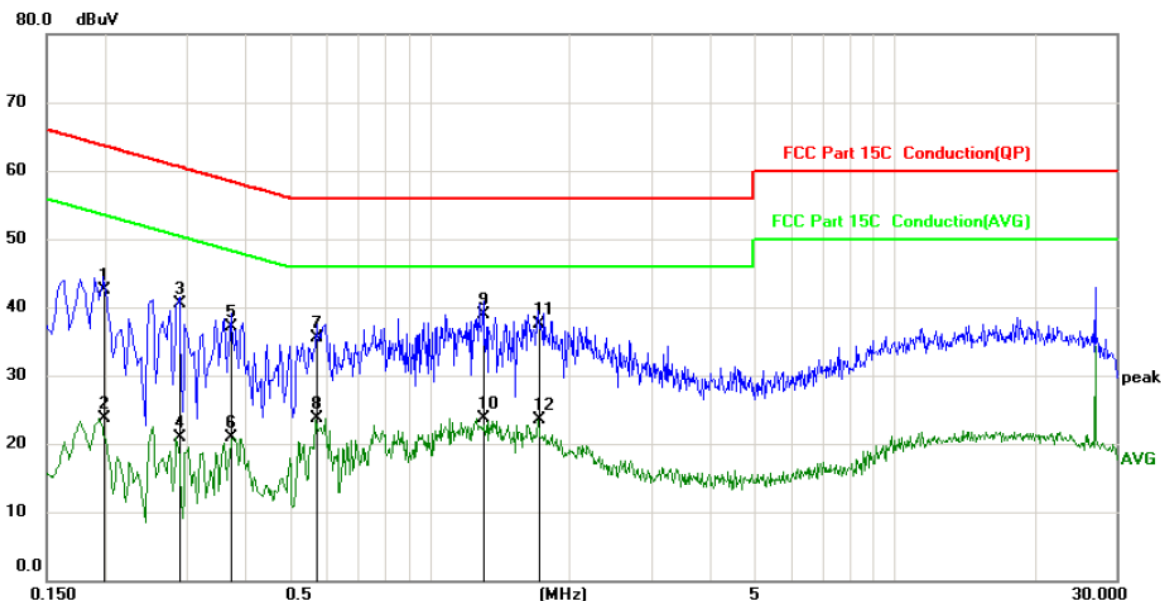

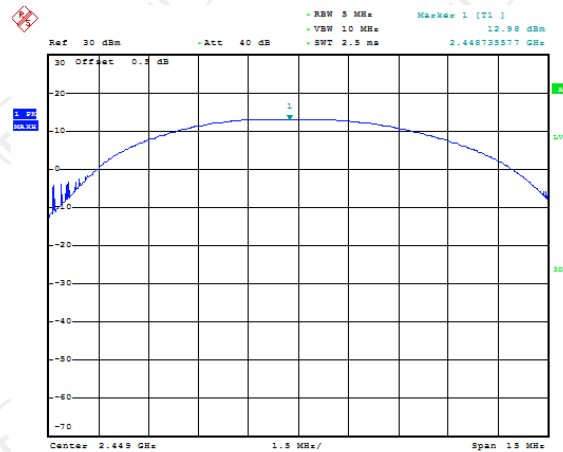

Lowest channel



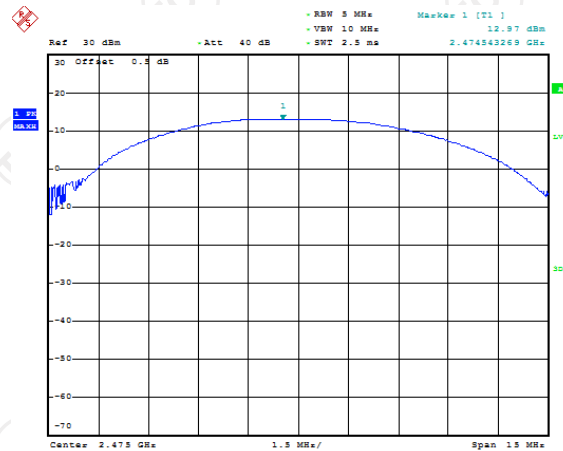

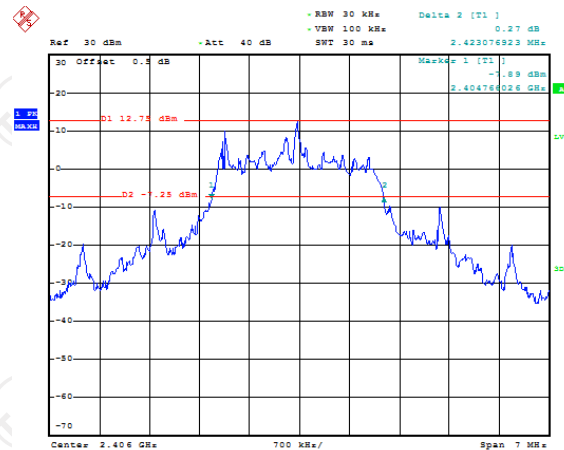

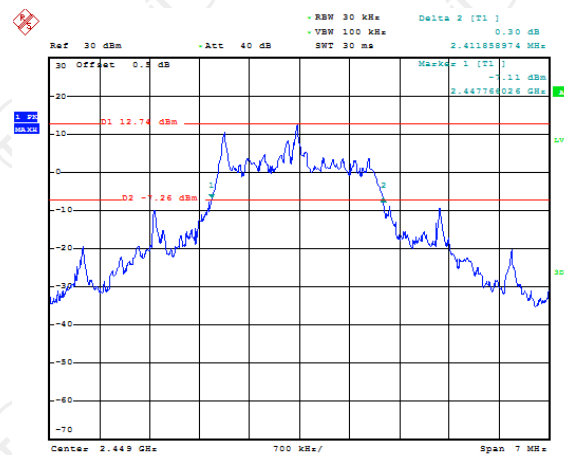

Lowest channel



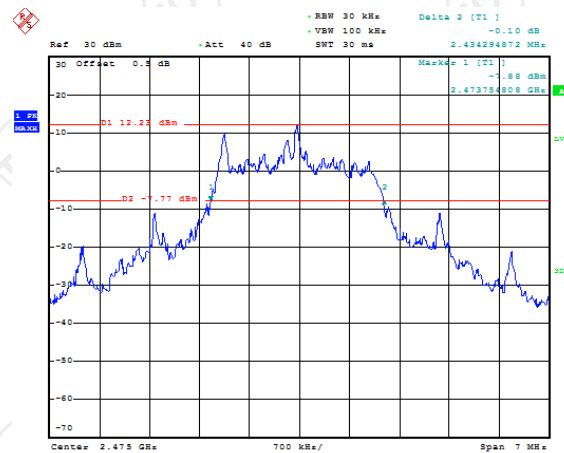

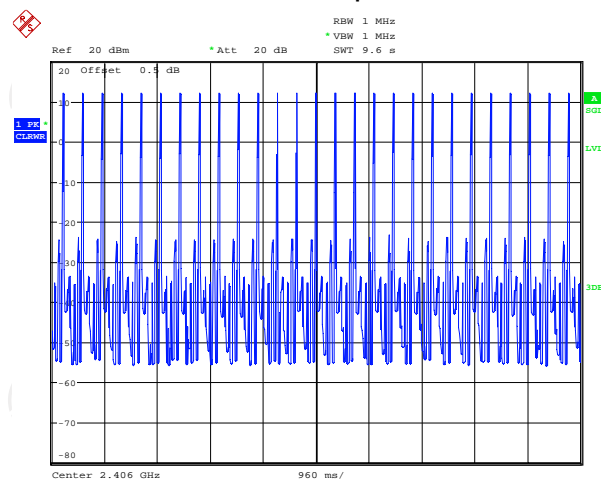

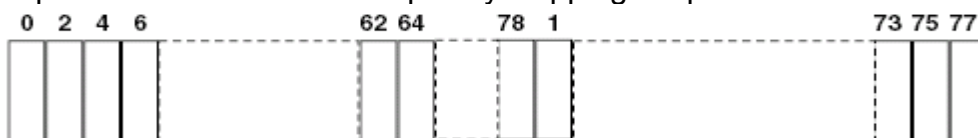

Linear Feedback Shift Register for Generation of the PRBS sequence



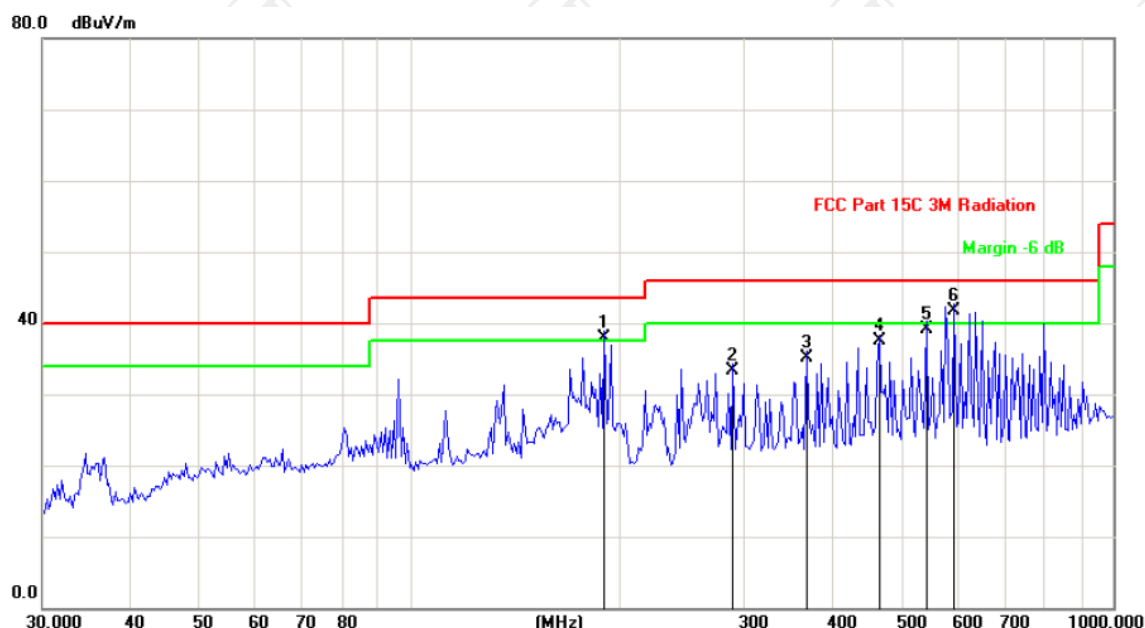

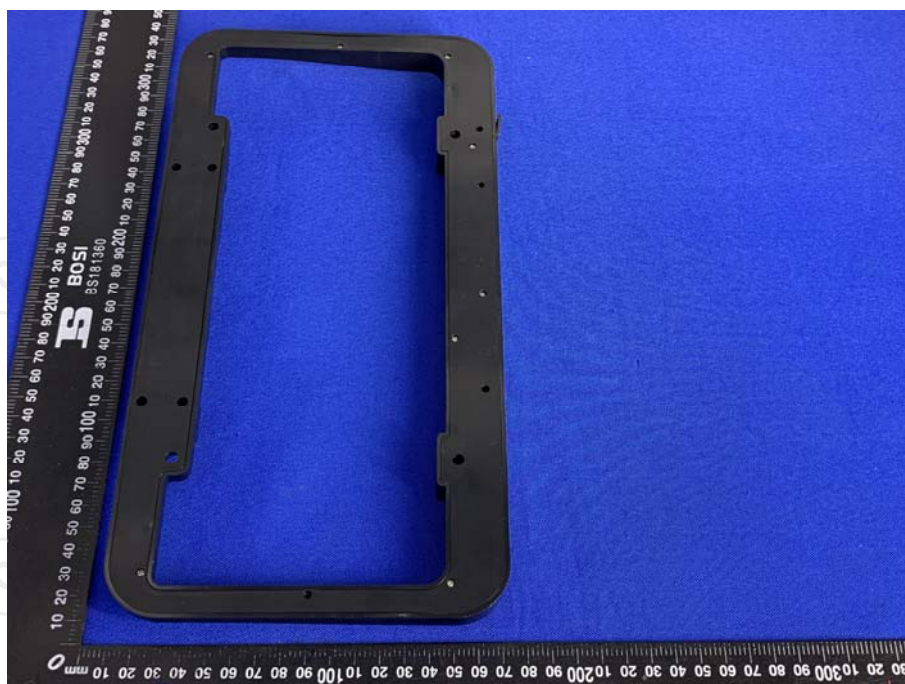


Conducted Emission
