Requirement of Public Notice 15.212	Reference to NDB1793S02.
1. The modular transmitter must have its own RF shielding.	The module doesn't have its own RF shielding. Please see external photo.pdf
2. The modular transmitter must have buffered modulation/data inputs.	The modular has buffered data inputs, it is integrated in chip MS1793. Please see schematic.pdf
3. The modular transmitter must have its own power supply regulation.	All power lines derived from the host device are regulated before energizing other circuits internal to the MS1793. Please see schematic.pdf
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The NDB1793S02 meets the FCC antenna requirements.
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing.	The NDB1793S02 was tested in a stand-alone configuration via a PCMCIA extender. Please see conducted set-up photo.pdf and spurious set-up.
