The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

The antenna is a FPC Antenna which permanently attached, and the best case gain of the antenna is 1.97dBi for Left Earphone and 1.93dBi for Right Earphone. It complies with the standard requirement.



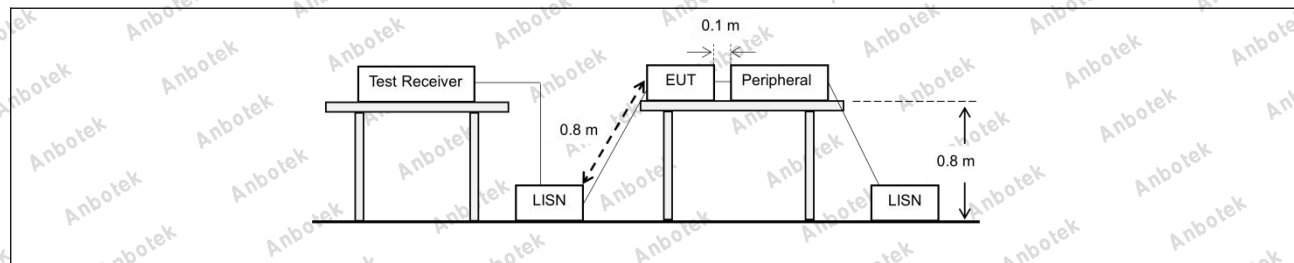
