EST PLOTS FOR CONDUCTED SPURIOUS EMISSION LTE BAND 41



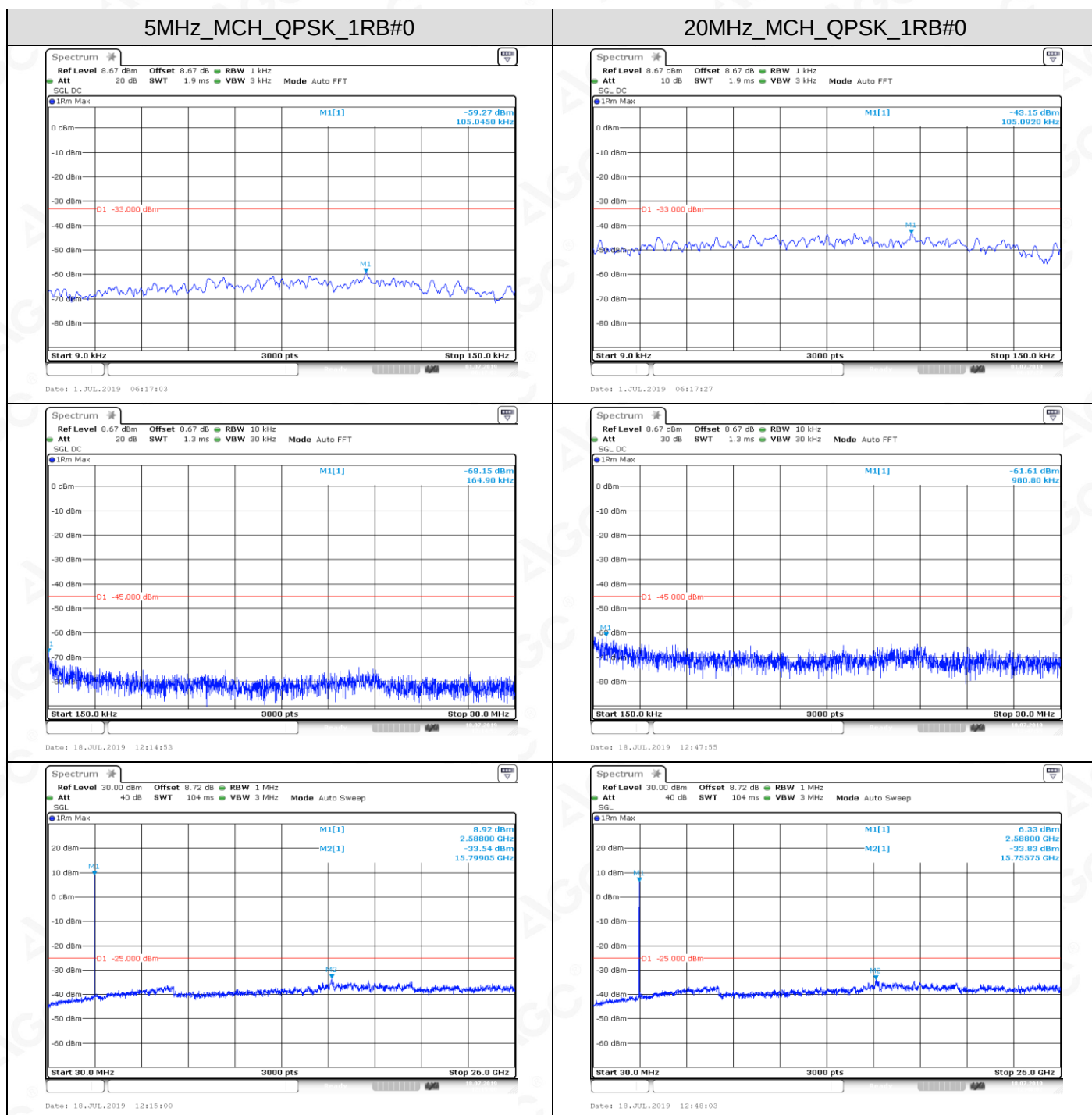

LTE Band 2 Channel Bandwidth: 1.4 MHz



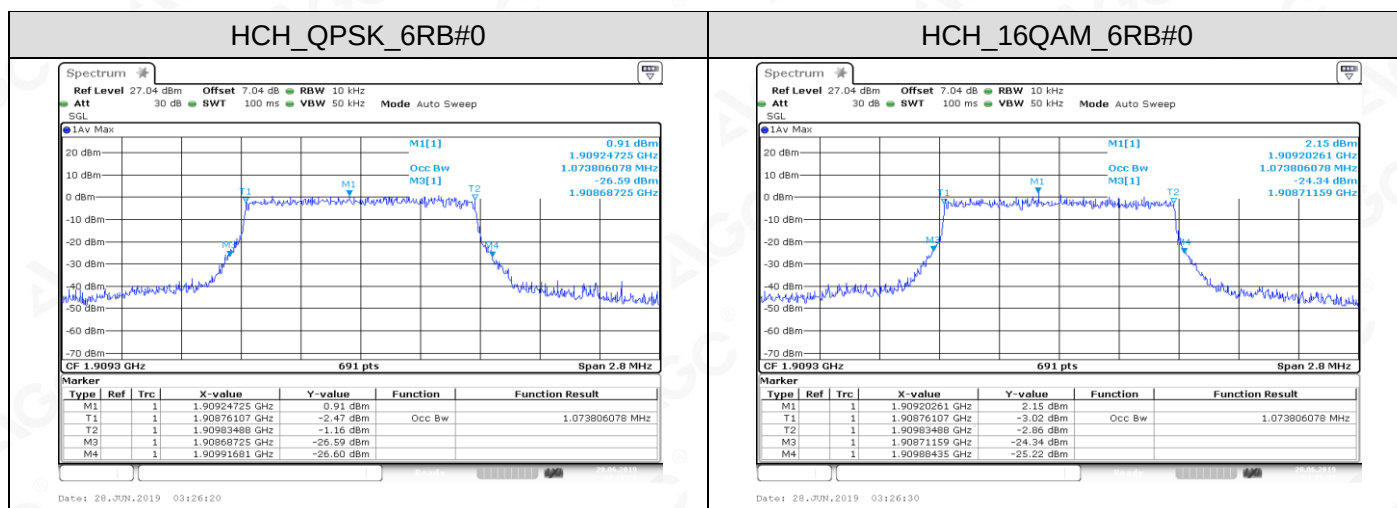
