



1 Download and Installation of the APP



3 Appearance description



4 Bluetooth connection

Switch on Bluetooth, while keeping the watch on. Open the APP to connect your watch. Bluetooth pairing successful: the red light is on for 1 second.

5 Functions

Exercise	When the watch is activated, it will automatically record the number of walking steps, which is displayed in the APP when connected.
Intelligent Photo-taking	The watch enters the photo mode by turning on the camera and tapping the photo button in the APP, and then you can press the button once or flip the wrist to control the photo-taking.
Reminder	After the watch is connected to the APP, you can turn on or off the reminder for sedentariness, phone calls, and messages through the reminder function. You will be alerted by vibration when it is turned on. When alerted by an incoming call, you can hang up the phone by pressing the buttons on the watch.
Alarm clock	You can set the alarm clock by tapping the alarm clock button, and you will be alerted by vibration. The reminder can be stopped by briefly pressing the buttons on the watch.
Time Calibration	After the watch is connected to the APP, you can synchronize the watch by tapping the Time Calibration.
Power Saving Mode	You can set power saving mode for the watch by tapping the power saving mode button. In power saving mode, the watch will turn off all reminders, retaining only the functions of timing and steps recording.
