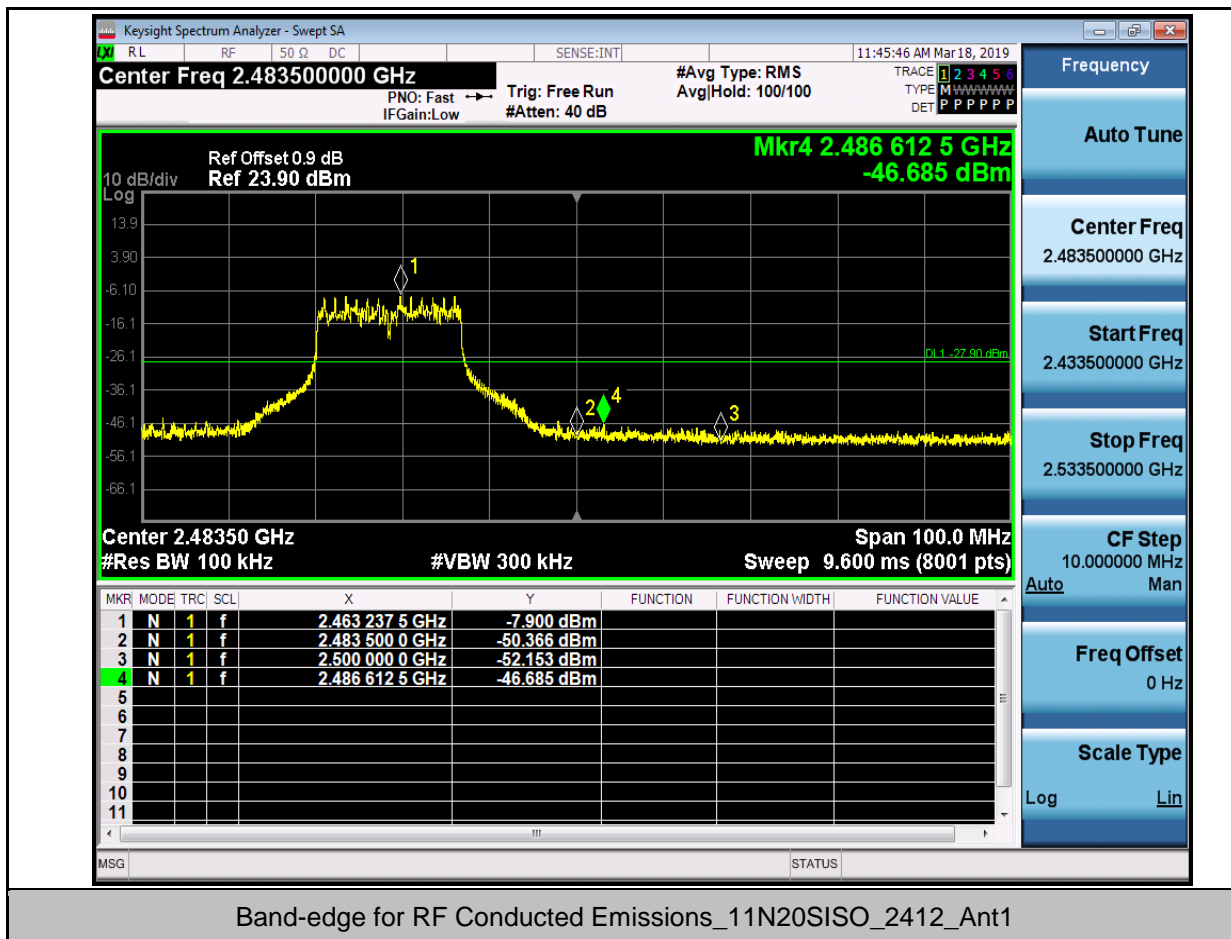
Band-edge for RF Conducted Emissions_11B_2412_Ant1

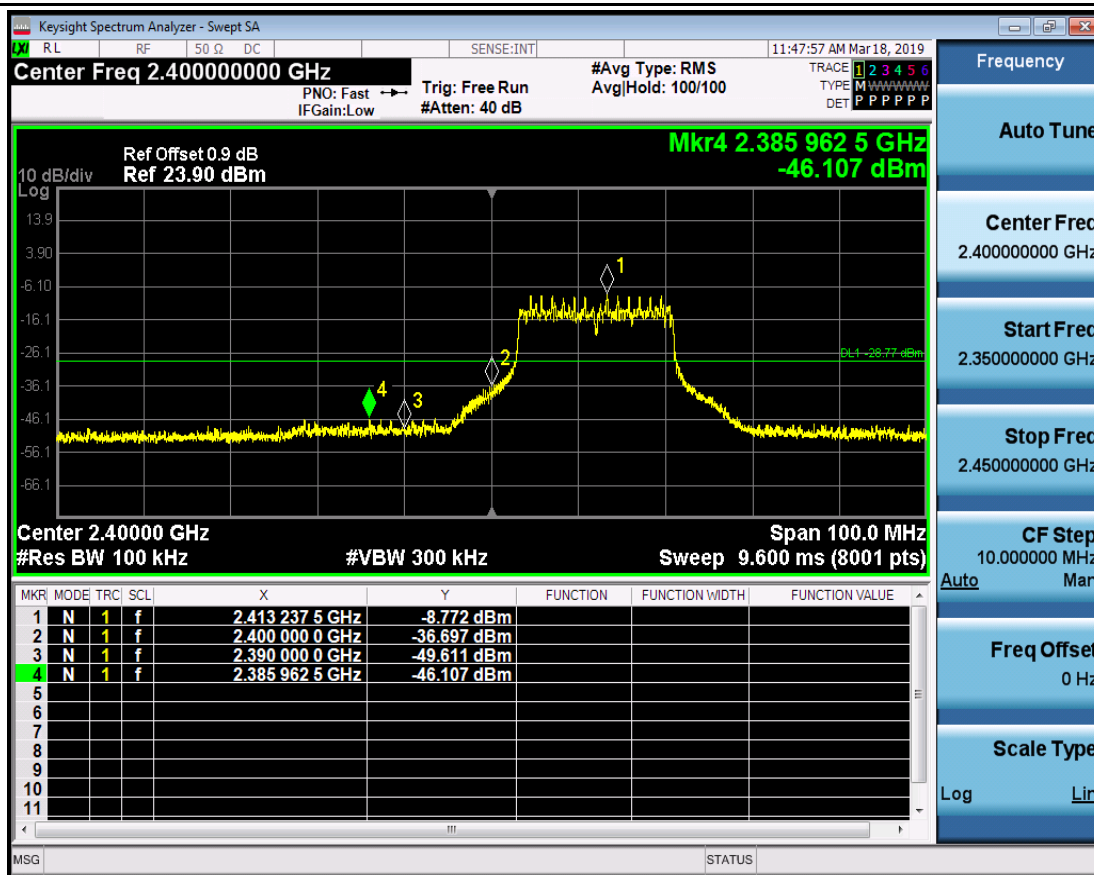

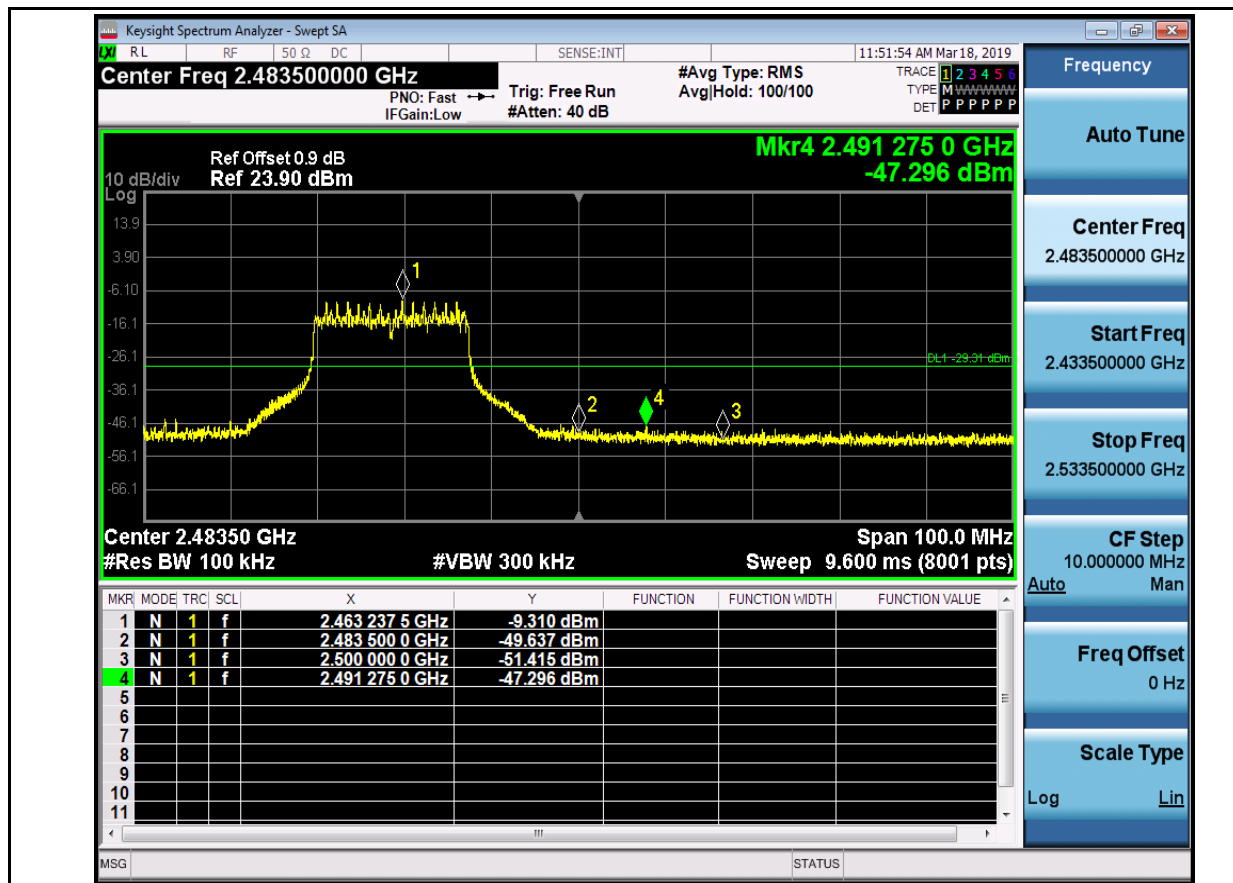


Band-edge for RF Conducted Emissions 11N20SISO 2462 Ant1
