3.3 MPE CALCULATION METHOD

$$S = PG/4\pi R^2 = EIRP/4\pi R^2$$

S = power density (in appropriate units, e.g., mW/cm²)

P = power input to the antenna (in appropriate units, e.g., mW)

G = power gain of the antenna in the direction of interest relative to an isotropic radiator, the power gain factor is normally numeric gain.

R = 20cm, distance to the center of radiation of the antenna (in appropriate units, e.g., cm)
