MPE Calculation Method

$$E \text{ (V/m)} = \frac{\sqrt{30 * P * G}}{d} \quad \text{Power Density: } Pd \text{ (W/m}^2\text{)} = \frac{E^2}{377}$$

E = Electric field (V/m)

P = Average RF output power (W)

G = EUT Antenna numeric gain (numeric)

d = Separation distance between radiator and human body (m)

The formula can be changed to

$$Pd = \frac{30 * P * G}{377 * D^2}$$

From the EUT RF output power, the minimum mobile separation distance, d=0.2m, as well as the gain of the used antenna, the RF power density can be obtained.

Measurement Result

Operation Frequency: EDR: 2402MHz~2480MHz;

Power density limited: $1\text{mW}/\text{cm}^2$

Antenna Type: PCB Antenna

Antenna gain: 0.07dBi,

R=20cm


